Introduction

The purpose of this report is to identify specific foreign direct investment transactions in the United States during 1982, analyze recent trends in such investment, and provide data and related information on significant transactions. The report incorporates information obtained as a result of responsibilities assigned to the Secretary of Commerce by Executive Order 11858, dated May 7, 1975. Specifically, the Secretary of Commerce is responsible for "the obtainment, consolidation, and analysis of information on foreign investment in the United States."

Foreign direct investment, as used in this report, means the direct or indirect ownership of 10 percent or more of the voting securities of an incorporated business enterprise, or an equivalent interest in an unincorporated business enterprise, and a 10 percent or more interest in real property transactions.

Transactions values, as used in this report, refer to the reported total cost of the investment -- or the estimated proportion of the investment if a joint venture -- regardless of the source or timing of funds. These values are intended to identify the relative size of various investments and, in the aggregate, indicate trends in investment activity.

The data and other information contained in this report represent a compilation and distillation of material available from generally available public sources, transaction participants, and miscellaneous contacts. A major portion of the data and information was derived from public secondary sources such as newspapers, magazines, and business and trade journals, as well as from the public files of Federal regulatory agencies.

The primary Federal agency sources for publicly available data are the Securities and Exchange Commission (SEC), the Federal Trade Commission (FTC), and the Federal Reserve Board (FRB). Much of the data obtained from Federal regulatory agencies originated from report series that differ widely in frequency and content. These reports are, in most cases, filed in response to the various agencies general regulatory responsibilities, rather than for the specific purpose of providing data on foreign investment. Other investment transaction and related data collected by the federal government are not available for this report. Much of this information is business confidential and is collected strictly to facilitate federal regulatory responsibilities or to provide aggregate data for macro-economic analysis purposes.

It should be noted that the aggregate data in this report are not strictly comparable to the other major statistical series on foreign direct investment in the United States, published by the Commerce Department's Bureau of Economic Analysis (BEA). The BEA aggregate dollar value data on new investments, published annually since 1979, are based on individual firm responses to mandatory reporting requirements (including strict confidentiality provisions protecting the identity of individual reporters). These data are thus likely to provide more comprehensive coverage for the types of transactions included in BEA's reporting requirements. On the other hand, this report not only identifies individual transactions, but includes a broader range of investment transactions than the BEA data -- particularly with regard to plant expansions, equity increases, and certain types of real estate investments. Consequently, the two data series should not be directly compared, although there has been significant correlation in the movement of the overall series over the last several years.

While every effort was made to verify the information obtained from public sources, the U.S. Department of Commerce is not responsible for any inaccuracies or gaps in information presented in this report. Transaction values for many investments are not publicly available. Nevertheless, experience has shown that value and other data for the large majority of major investments is identified in the monitoring process.

Overview of Foreign Direct Investment in the United States, 1982


The Office of Trade and Investment Analysis (OTIA) identified from public sources 913 completed foreign investment transactions. Values were reported for 370 of these individual transactions, for a total of \$13.9 billion. Appendix A contains a listing of all the transactions identified during 1982.

The 1982 number of completed transactions identified is 24 percent lower than the 1203 identified in 1981, and is the lowest total since 1978. The value of identified transactions was also lower -- about half the 1981 total. As in earlier years, a few large transactions accounted for a substantial part of the total value, although there were no \$1 billion or larger transactions as in some earlier years. In 1982, thirty-six transactions over 100 million each had a combined value of \$8.0 billion, 64 percent of the total reported value. In 1981, just nine transactions with values over \$500 million each combined for \$11.6 billion, 43 percent of total reported value.

Related data published by the Department of Commerce's Bureau of Economic Analysis (BEA) confirm this falloff in investment activity. (See Introduction for discussion of differences between BEA data and that presented in this publication.) The BEA data show a decline in investment transactions from 1,332 in 1981 to 788 in 1982. The value of these BEA recorded transactions fell to \$8.6 billion in 1982 from \$23.2 billion in the previous years (see the June 1983 issue of the Survey of Current Business).


The decline in 1982 foreign direct investment in the United States was consistent with domestic and international economic trends during the year. Sluggish economic activity, coupled with significant idle industrial capacity, were major disincentives to new investment -- both by domestic and foreign investors. Relatively high interest rates increased the attractiveness of investment in financial instruments versus direct investment, and substantially increased the costs of borrowing to finance new investment. Additionally, the strengthening of the dollar vis-a-vis other major currencies increased the foreign currency costs of foreign investments in the United States. These factors apparently lowered investments in the United States despite the depressed prices of equity shares and assets in U.S. firms resulting from the recession.

Investment by Source Country

The major industrialized countries, traditionally the source of most direct investment activity in the United States, retained that role in 1982. Seven nations -- Canada, France, Germany, Japan, the Netherlands, Switzerland, and the United Kingdom -- accounted for 669 transactions, or 73 percent of the total identified, slightly more than the comparable percentage for 1981. The aggregate value of these transactions is (\$11.0 billion), while only about a half of the previous year's value (\$21.2 billion), represented almost four-fifths of total 1982 identified values.

Both in terms of numbers of investments and overall value, the United Kingdom was the primary source country in 1982 (see Table 1). Twenty percent of all transactions (180) originated in the United Kingdom, with 86 identified values totalling \$4.2 billion. Canada, the largest investor in earlier years, was a very close second, with 161 transactions (17.6 percent of all transactions), and values identified for 59 totalling \$3.9 billion. Japan was the third most active source in 1982, with 143 transactions, followed by West Germany (66), France (52), and the Netherlands (46).

Investment by Industry

Until 1981, the largest number of new transactions completed each year was in the manufacturing sector. In 1981 and 1982, however, real property transactions pushed manufacturing into second place. The real property sector -- commercial land, office buildings, shopping centers, residential developments, etc., and the development and construction thereof -- accounted for 298 transactions in 1982 compared to 218 for the manufacturing sector (see Table 3).

Of the 298 real property transactions in 1982, values were identified for 124 totalling \$6.1 billion; of the 218 in manufacturing, 92 values totalled \$2.7 billion. Together these two sectors accounted for more than half of the total transactions and almost two-thirds of identified values.

Mode of Investment Transaction

Foreign direct investments in the United States occur in several major forms, referred to as "modes" in this report. These modes are acquisitions/mergers, equity increases, joint ventures, new plants, plant expansions, real estate, and miscellaneous types (such as branches, sales & distribution outlets, warehouses). Appendix B defines these and other terms used in this report.

Real property (real estate) transactions were the most frequent (298) mode of investment transaction identified in 1982, followed by acquisitions/mergers (231). These two modes were also the leading forms of activity in terms of aggregate value, with identified real estate values totalling \$6.1 billion and acquisitions/mergers at \$4.6 billion. Together these two modes accounted for 57 percent of the total number and 76 percent of the total value of all foreign investment transactions during the year.

Location of Investment by State

As in past years, most states managed to attract at least one identified foreign direct investment during 1982 (see Table VI). As might be expected, however, investment transactions were concentrated in the larger states. New York, California, Florida, and Texas together accounted for almost half of the 1982 transactions identified. By dollar value, much the same picture emerged. A major exception was the appearance of Alaska with the fourth largest value total, resulting from foreign acquisition of some high-value oil leases.

Major Sectoral Developments

The following section focuses on major investment transaction trends in the more active industrial sectors during 1982. Investment activity by section and major source country appears in table VII.

Metal mining (SIC 10)- High operating costs and increased competition from developing countries have caused severe losses in the U.S. metal mining industry in recent years. In 1982, faced with high inventories and relatively low prices, many U.S. metal mining firms were forced to curtail production even further. Yet this industry slowdown did not deter foreign investors. The metal mining industry had 12 completed investment transactions in 1982, an increase of 7 over the 1981 figure. However, the \$168.4 million total of the 5 available transactions figures was only a fraction of the \$4 billion total for the 5 completed transactions recorded in the previous year.

Most of the investment activity took place in the uranium mining (SIC 1094), copper mining (SIC 1021) and gold mining (SIC 1041) subsectors, and most of the transactions were located in the traditional western mining states. These transactions took place via three major modes of investment: acquisitions (5), equity increases (3) and joint ventures (3).

There were no 1982 metal mining transactions as large as those of the previous year. The largest 1982 investment recorded was a \$90 million equity increase in Hanna Mining Co. from 8.8 percent to 20 percent by Norcen Energy Resources Ltd., a Toronto-based natural resources concern controlled by Conrad M. Black. Norcen Energy purchased 1.24 million shares of the Cleveland, Ohio iron ore producer after a three-month takeover battle was resolved. Norcen and its affiliates agreed to an eight-year standstill arrangement under which they would cease acquiring additional shares of Hanna common, subject to certain exceptions.

Another noteworthy case in this industry was a \$37.1 million equity increase in Gulf Resources & Chemical Corp. from 8.4 percent to 25.1 percent by Alan E. Clore, a British financier who resides in Switzerland. Mr. Clore took control of the Houston mining and minerals firm in June 1982 after a three-month proxy fight.

Anthracite, Bituminous Coal and Lignite Mining (SIC 11 and SIC 12)

Despite declining steel production and reduced electricity demand worldwide, foreign investment activity in the U.S. coal industry increased slightly. Ten completed transactions were identified in the two coal mining subsectors - one in the anthracite mining subsector (SIC 11) and 9 in the bituminous coal and lignite mining subsector (SIC 12). The largest dollar value recorded was \$72 million for the 50 percent acquisition of Pyro Mining Corp. of Indiana by the Costain Group PLC, a London-based construction, engineering, and mining firm.

Foreign investors in the U.S. coal industry came from 8 countries. Four were corporations with government ownership ranging from 40 percent to 100 percent. Veba AG, 40 percent owned by the Government of West Germany, acquired a 15 percent interest in Westmoreland Coal Company of Pennsylvania for \$32.5 million. Instituto de Industria, which is 100 percent owned by the Government of Spain, acquired 10 percent of Ashland Coal Inc. of Kentucky for \$44.3 million. This transaction increased the amount of foreign held equity in Ashland Coal to 35 percent from 25 percent. (In 1981, Saarbergwerke A.G., 98 percent owned by the Government of West Germany, acquired 25 percent of Ashland Coal for \$102.5 million.)

Holland Carbon Fuels B.V. of the Netherlands acquired a 59 percent share of Scott's Branch Coal Mine in Pikeville, Kentucky. Holland Carbon Fuels is a joint venture in which equal shares are held by three partners: Dutch State Mines (owned by the Government of the Netherlands), Estel/Hoogovens Delfstoffen, and SEP (The Association of Dutch Electricity Producers). The final completed transaction by a company with foreign government ownership was the purchase of Kitt Energy Corp. of West Virginia by Standard Oil Co. (Ohio), 53 percent owned by British Petroleum, Co. PLC, 39 percent of which is held by the Government of the United Kingdom. The transaction was valued at \$55.7 million.

The most frequently utilized mode of investment in the coal industry last year was the acquisition/merger. There were 8 acquisitions recorded. An equity increase and a joint venture accounted for the remaining completed transactions. Geographically, coal investments were concentrated in three of the leading coal-producing states; Kentucky (4 transactions), Pennsylvania, (2 transactions) and West Virginia (2 transactions).

Oil and Gas Extraction (SIC 13) - In 1982, as in 1981, the oil and gas extraction subsector had the highest number of completed transactions--49--and the largest total dollar value--\$2.1 billion (37 values)--in the mining sector. There were no 1982 investments comparable in size to Kuwait Petroleum Corp.'s \$2.5 billion acquisition of Santa Fe International Corp. (which accounted for more than half of the 1981 total transaction value figure in the oil and gas industry).

Yet, in spite of reduced industrial demand and falling crude oil prices, foreign firms have continued to acquire new leases and to fund exploration projects, two of which are the largest transactions in this subsector. The first was American Petrofina Inc.'s acquisition of a 25 percent interest in Texas Oil & Gas Corp.'s undeveloped acreage in 16 states, including Texas, Montana, Oklahoma and Kansas. The two companies also agreed to begin a joint 10-year drilling and development program, 25 percent of which will be paid for by American Petrofina, the 74 percent owned affiliate of Petrofina SA of Belgium. The transaction value was \$581.6 million. The other large transaction was the acquisition of oil leases in the Diapir Field, 20 miles off Alaska's coast, by Sohio Alaska Petroleum Co. and B.P. Alaska Exploration Inc. with Mobil Corp. British Petroleum has a 45 percent interest in the group through Sohio Alaska and B.P. Alaska in a transaction valued at \$539 million.

Investors from 9 countries invested in the U.S. oil and gas industry in 1982. Almost one-third of the investments were made by companies with some foreign government ownership. The Government of the United Kingdom through British Petroleum Co.'s holdings in Standard Oil Co. (Ohio) accounted for most of these--11. The Government of Kuwait, through its ownership of Kuwait Petroleum Co., and the Government of France, through its holdings in Elf Aquitaine S.A., each had 2 oil and gas transactions.

Almost three-quarters of the investments (36) in this subsector were acquisitions. The remaining transactions were joint ventures, equity increases or other types of investments such as new wells or drilling expansions. The activity was concentrated in five states, three of which were in areas with considerable leasing activity in 1982. Texas accounted for the largest number of transactions (12), followed by Alaska, Louisiana, Colorado, and California. More than half of the completed cases in the oil and gas extraction subsector (27) were leases acquired by U.S. affiliates or subsidiaries of foreign companies. Sohio, which is 53 percent owned by British Petroleum PLC, and Shell Oil Co., which is 69 percent held by the Royal Dutch Shell Group, each had 11 leasing transactions.

Paper and Allied Products (SIC 26) - Seven investment transactions were completed during 1982, with 5 of them reporting values totalling \$609 million, about the same as in 1981. Canadian and British investors accounted for half of the completed transactions and four-fifths of the total value. Acquisitions (3) and equity increases (2) were the most frequently utilized methods of investment.

The two largest transactions in this industry were both continuations of previously reported 1981 transactions. James Goldsmith, an Anglo-French businessmen who held a 40.7 percent share of Diamond International Corp. through Cavenham Holdings Inc., made a tender offer for the remaining outstanding shares of Diamond at yearend 1981. His takeover, valued at \$455 million, was completed in December 1982.

The second largest transaction was also a 1981 holdover. In 1982, Kymi Kymmene Oy, a Finnish industrial company, and Great Northern Nekoosa Corp. formalized their joint venture to build a \$522 million pulp mill in New Augusta, Mississippi. Kymi Kymmene has 20 percent and Nekoosa 80 percent of the equity of the new joint venture company, Leaf River Corp. The Finnish firm's participation is estimated to be \$104.4 million.

Brascan Ltd.'s 1982 equity increase in Scott Paper Co. is also a continuation of this firm's 1981 interest in the Philadelphia-based paper products firm. In that year, the Toronto holding company raised its equity to 20.5 percent from less than 1 percent. In 1982, Brascan further raised its equity in Scott Paper to 23.3 percent at a cost of just over \$20 million. Brascan Ltd., with interests in natural resources, consumer products, and financial services is controlled by Edward and Peter Bronfman through their holding company Edper Equities Ltd. of Toronto.

Chemicals and Allied Products (SIC 28) - The number of identified foreign direct investments in this sector totalled 40 in 1982, down from 51 in the previous year. The number of completed transactions with known values dropped from 21 in 1981 to 12 in 1982. The aggregate value of known investments has decreased, principally due to the fact that the Seagrams Ltd. acquisition of 20 percent of duPont in 1981 totalled \$2.58 billion.

The five largest transactions totalled \$415.9 million or 87.5 percent of the total. These transactions included Badische Corp.'s plant expansion in Williamsburg, Virginia for \$120 million, Beecham Group PLC's purchase of J.B. Williams Co. for \$100 million, Montedison Sp.A.'s acquisition of Kallestad Laboratories Inc. for \$77.0 million, Seagram Ltd.'s equity increase in E.I. duPont Nemours Co. for \$65.1 million, and American Hoechst Corp.'s plant expansion in Greer, South Carolina for \$53.8 million.

Machinery, except Electrical (SIC 35) -- Nonelectrical machinery
continues to be one of the primary industries for foreign
investors. The number of identified completed transactions dropped
slightly to 42 in 1982, while those with known values (18) showed a
minimal increase. There was, however, a major increase in total
value between 1981 and 1982 -- from \$122 million to \$745 million.

Investors in the nonelectrical machinery industry came almost
exclusively from the industrialized countries. Japan and West
Germany, the largest investors with 10 transactions each, accounted
for almost half of the transactions; followed by the United Kingdom,
Canada, and France. The primary mode of investment in this industry
for 1982 was acquisitions (22 transactions) followed by ten new
plants or expansions.

Metal cutting machine tools and electronic computing equipment were
the most attractive subsectors, with five transactions each and
total values of \$318 million and \$227 million, respectively. These
two subsectors accounted for 73 percent of the total value
identified for the industry.

Four source countries accounted for 28 of the 40 transactions. Nine
investments came from the United Kingdom, seven each from Japan and
West Germany and five from Switzerland.

More than half of the investments were concentrated in four states;
nine in Texas, five in North Carolina, and four in both Delaware and
New Jersey.

1982 investment modes included twelve acquisitions or mergers,
twelve new plants, seven joint ventures and five plant expansions.

During 1982, there were 2 significant transactions in the
non-electrical machinery industry: AMCA International Corp., a New
Hampshire-based manufacturer of fabricated structural steel
products, acquired Giddings & Lewis Inc. of Fond du Lac, Wisconsin,
a producer of machine tools for \$310 million. AMCA is indirectly
controlled by Canadian Pacific Ltd., a Montreal-based transportation
and natural resources company. The other notable transaction
involves the \$222 million takeover of Applicon Inc. by Schlumberger
NV, a Netherlands Antilles investment company controlled by the
Schlumberger family of Paris, France.

Electric and Electronic Equipment (SIC #36) - The number of completed foreign direct investment transactions identified in the electric and electronic equipment totalled 34 in 1982, down 5 from the 1981 total. In aggregate value, there was a sharp decrease from \$429 million in 1981 to \$196 million in 1982.

The primary mode of investment in this industry was by acquisition (15 transactions), followed by 8 new plants or expansions. Investors from the United Kingdom accounted for nine of the fifteen acquisitions.

More than half of the foreign direct investment transactions took place in four states -- California led with eight, followed by New York, Florida and New Jersey. The remainder were scattered throughout the eastern United States.

As in 1981, Japan and the United Kingdom were the principal source countries, accounting for 21 of the 34 completed transactions. Other source countries with at least two investments were West Germany, Canada, and Sweden.

The two most significant transactions were by Siemens AG (West Germany's largest electrical company), which increased its ownership to 85 percent of Siemens-Allis Inc. (Atlanta, Georgia) by acquiring an additional 35 percent from its joint venture partner Allis-Chalmers Corp., Milwaukee, Wisconsin, for \$75 million; and the Plessey Company Ltd., (a major British telecommunications equipment manufacturer) acquisition for \$57 million of Stromberg-Carlson's telephone switching operations in Florida, New York, and Oklahoma.

Retail Trade (SICs 52-59) -- 1982 Foreign direct investment activity in the retail sector remained about the same as in 1981, with 42 cases identified during 1982. Values for 18 of the 1982 transactions amounted to \$540 million, while values for 27 in 1981 totalled \$659 million.

The most active retail subsector was apparel and accessory stores with 11 investments, followed by eating and drinking places with 9 identified transactions. Although the general merchandise stores subsector had only 3 transactions with known values, the \$408 million total represented over 75 percent of the total known value for the retail sector. One large transaction was primarily responsible. BAT Industries, a British diversified retail chain that has acquired numerous retail ventures in the United States -- including Saks Fifth Avenue, Gimbels, Brown and Williamson Tobacco Company, Kohl Food and Department Stores, and Appleton Papers Inc. -- acquired the Marshall Fields Department Store chain for \$365 million.

Canada and the United Kingdom accounted for over 45 percent of the total number of transactions with 10 each. Foreigners invested in retail trade in 13 states, with New York having the greatest concentration (15) followed by Florida (5). Investments in New York were mainly in speciality apparel stores and boutiques. As in previous years, the modes of investment most often utilized by foreign investors in this sector were to establish their own ventures (24) or to acquire existing operations (14).

Banking (SIC 60) -- During calendar 1982, 39 completed banking transactions were identified. Thirty-one of the completed cases had reported values, which totalled \$1.2 billion. The increase in banking subsector value figures from 1981 to 1982 is primarily due to a change in data recordation rather than an increase in investment activity. Calendar 1982 is the first year in which capitalization figures for foreign bank Edge Act companies, Agreement Corporations, branches, and agencies were used as proxies for investment values by the Federal Reserve Board. In terms of completed investment cases, the number actually fell significantly from 71 to 39 during the period.

Most of the completed 1982 banking investments by foreign firms were in New York, California, and Florida, with these states accounting for about 85 percent of the total. As in recent years, the large number of foreign bank establishments in New York is partly related to the tendency of foreign parent banks to choose New York as a "home state." The choice of a "home state" is required under provisions of the International Banking Act of 1978.

During 1982, investors from Brazil (6), France (5), Italy (4), and Hong Kong (3), accounted for almost half the completed transactions. Thus, the majority of completed banking investments were produced by investors from countries other than the traditional major source countries. Banking activity on the part of investors from these countries suggests a desire to establish a firm financial presence in the United States under provisions of relatively friendly regulatory legislation. In prior years, foreign parent banks, principally from the industrial countries of Europe and Japan, had acquired existing U.S. banks or established U.S. agencies or branches. During 1982, the overwhelming majority of completed foreign banking investments involved new establishments in the form of agencies, branches, Edge Act companies, and Agreement Corporations.

By the close of the period, two major transactions were identified. The first was Arab Banking Corp.'s (Bahrain) establishment of a new branch in New York City, with U.S. assets of \$454 million. The second was Istituto Bancario San Paolo di Torino's (Italy) acquisition of 85 percent of First Los Angeles Bank for \$56 million.

Services -- (SIC 72-89)

As in most of the other industries, the number of transactions identified during 1982 in the services sector declined. There were 38 transactions identified during this period with values known for 17 in the amount of \$435 million, compared to 50 transactions in 1981 with values known for 17 in the amount of \$414 million.

The subsector SIC 73 -- Business Services -- remained popular with foreign investors as in previous years. There were 29 transactions identified with values for 13 totalling \$158 million. While most of the investments in this subsector were computer and data gathering services, the largest transaction was the acquisition of New York - based Compton Communications, an advertising agency, by the British advertising agency Saatchi and Saatchi for \$57 million.

Two other noteworthy transactions took place in the services sector. In the Automotive Services sector, Deanlake Investment, (Hong Kong), controlled by Thomas Chen Tseng Tao, acquired the parking lot and real estate operations of Allright Auto Parks of Texas for \$101 million. In Health Services, Hoffmann LaRoche, the giant Swiss multinational pharmaceutical company, acquired Biomedical Reference Lab, a North Carolina clinical lab testing service for \$165 million. These three transactions accounted for \$323 million, or 74 percent of the total value known for this sector for 1982.

Investments in this service sector originated in fifteen countries. As with other industries, the traditional foreign source countries remained the most active investors, with the United Kingdom contributing 11 and Japan, 5. Other countries had less than four each.

Sixteen states were the benefactors of these investments, with no particular geographical concentration. New York lead with 7 investments. Maryland and Texas followed with five each. Other states had three or less.

Real Property -- For the year 1982, 298 commercial real estate investments were identified, which involved foreign investors in the purchase and development of U.S. real property. Of these, 124 transactions had known values, totalling \$6.1 billion. Seventeen of the 124 had values in excess of \$100 million. (Purchases of agricultural land and of individual residential units are not included in this report).

These 298 real estate transactions comprised one third of all the direct investment transactions identified in 1982, and accounted for 43 percent of the annual value of all transactions on which values were established. Real estate's share of total foreign direct investment has fluctuated annually, but in absolute dollar terms grew annually until 1981. Last year, the value declined from the 1981 level of \$7.4 billion.

Canadians maintained their dominance as the principal foreign investors in this sector, accounting for 95 transactions, one-third of the total in this sector. By value, 29 of these investments on which values were established, accounted for \$3.1 billion, over half the total identified sector value. Nevertheless, the number of 1982 Canadian real property investments was only about one half of the comparable 1981 figure.

The Canadians were followed by the British, who accounted for 50 investments, with 17 identified values totalling \$1.3 billion. Third in the real estate sector were the Japanese with 23 investments, for which 10 values were identified, aggregating \$815 million.

In terms of the size of their investments, the Canadians were again at the forefront, with the big developers and real estate holding companies -- Bramalea, Cadillac-Fairview, Campeau, Carma, Markborough Properties, the Bronfmans (through Olympia and York), and Trizec -- committing \$2.4 billion in just 9 projects of over \$100 million each. MEPC Ltd., European Ferries Ltd., and an unidentified investor group, all of the United Kingdom, committed a further \$665 million in four other large projects.

Pending Transactions

In addition to the 900 plus investments identified as completed during 1982, there were 232 cases pending at the close of the year. Estimated values were available for 91 of these pending transactions, with an aggregate total of \$3.9 billion.

One of the most interesting features of the pending transactions was the large number of potential investments accounted for by investors headquartered in Japan (see Table VIII). The 80 Japanese investments pending exceeded the number for the other major source countries, the United Kingdom (49) and Canada (27).

APPENDIX B

DESCRIPTION OF KEY TERMS

Acquisition -- a transaction in which title to stock or assets of the U.S. target is secured by another person or enterprise. The substantive result is that one party obtains ownership of another.

Agencies -- foreign financial intermediaries operating in the United States primarily financing international transactions, but prohibited from accepting domestic deposits.

Branches -- foreign financial intermediaries (integral parts of the foreign parent banks) which can accept domestic deposits.

Development -- realty investments that involve construction (as opposed to purchase.)

Equity Increase -- a rise in the percentage of equity securities held, or an equivalent increase in percentage ownership, by a foreign investor.

Foreign Direct Investment -- the direct or indirect ownership by a foreign entity of 10 percent or more of the voting securities of an incorporated business enterprise, or an equivalent interest in an unincorporated business enterprise, and a 10 percent or more interest in real property.

Joint Venture -- a transaction in which two or more parties establish a new corporation to which each contributes according to the provisions of the joint venture agreement.

Merger -- a transaction which results in the dissolution of the acquired business enterprise, into either another already existing or into a reorganized (but not always renamed) company.

New Plant -- a new operating facility, established either in conjunction with an existing foreign-owned productive enterprise or as a completely new venture.

Plant Expansion -- an addition to the capacity of an existing foreign-owned operating facility.

Purchases -- used herein to describe realty transactions, specifically the acquisition of real property.

Standard Industrial Classification (SIC) -- categorizes U.S. industries in a numerical classification series, in accordance with the composition and structure of the domestic economy.

Subsidiaries -- separate legal entities either owned or controlled by foreign investors but permitted to do business in the United States under state and/or federal authority.

Transaction Value -- the reported total cost of the investment, or the estimated proportion of the investment if a joint venture, regardless of the source or timing of funds.
