

NATIONAL ECONOMIC TRENDS

Total spending increased at a 7.7 percent annual rate from the third quarter of 1971 to the fourth quarter. Most of the gain was in real product rather than prices. Real product rose at a 6.1 percent annual rate from the third to the fourth quarter, and prices increased at a 1.4 percent rate. Year-end advances in economic activity offset some earlier sluggishness, with the result that 1971 GNP was \$1046.8 billion, a 7.5 percent increase over the recession year 1970.

Nineteen seventy-one could be characterized as a year of moderate recovery in that some progress was made in correcting the upward movement of prices and downward movement of output in recent years. Real product growth had slowed in each successive year since 1968, from a 4.7 percent rise in that year to a 0.6 percent decline in 1970. Real product rose 2.7 percent in 1971. The rate of price increase had moved up each successive year since 1962, from a 1.1 percent increase that year to a 5.5 percent increase in 1970. The inflation rate slowed to 4.6 percent in 1971.

Industrial production and employment, which changed little from 1970 to 1971, have picked up in the past few months. Industrial production rose at a 7.3 percent rate from August to December, compared with a 1 percent rate of increase from December 1970 to August. Payroll employment increased at a 2.5 percent rate from August to December, after rising at a 0.5 percent rate from December 1970 to August. Unemployment as a percentage of the civilian labor force remained near the 6 percent level throughout the year 1971.

Price advances moderated from August to November, the period of the wage-price "freeze." Many prices increased sharply at year-end with the transition from Phase I to Phase II of the Administration's Control Program. However, price rises in the last four months of the year were generally not as rapid as in the first eight months. Wholesale prices of industrial commodities increased at a 0.5 percent rate from August to December, after rising at a 4.6 percent rate in the preceding eight months. Consumer price increases slowed to a 2.5 percent rate from August to December, compared with a 3.8 percent rate from December 1970 to August.














