

# NATIONAL ECONOMIC TRENDS

The rate of price increases is slowing. The implicit price deflator for GNP rose about 9 percent in the four quarters of 1981, slightly slower than the 10 percent rise of the previous four quarters. Unit labor costs and hourly compensation growth in the private business sector also slowed from about 10 percent to about 9 percent for the same periods. Other measures of prices have shown sharper decelerations. Consumer prices increased 9 percent for the 12 months ending in December 1981, much lower than the 12-1/2 percent recorded over 1980. Similarly, producer prices of finished goods slowed from a 12 percent increase in 1980 to 7 percent in the 12 months ending December 1981.

A popular explanation for this phenomenon is that it is due to the recent recession. Since the recession began in July 1981, the Federal Reserve index of capacity utilization in manufacturing dropped from 79.8 to 71.8 percent as of February of this year; over the same period, unemployment rose from 7.2 to 8.8 percent of the civilian labor force. The slowing in prices has been especially pronounced since July 1981, with consumer prices rising at a 6-1/2 percent rate and producer prices at only a 3-1/2 percent rate.

Recent indications that the recession is ending, according to this view, have raised concern that inflation will accelerate. For example, payroll and civilian employment, capacity utilization and industrial production rose in February, although none have regained their end-of-1981 levels. Also, money stock growth jumped sharply to a 10 percent rate in the four months ending in February, following a decline over the prior six months.

This cyclical view of inflation is misleading, however. While the rates of increase of consumer and producer prices slowed in four of the seven recessions since 1950, inflation continued to decline during the year following the recession trough in all of the prior six recoveries. More importantly, the cyclical pattern of inflation, when it occurs, arises from procyclical movements in money and credit growth. Since the top of the current target range for M1 growth in 1982 (5-1/2 percent) is below the 6-1/2 percent rate of expansion over the past three years (IV/1978 to IV/1981), monetary growth within the range would make a reacceleration of inflation unlikely.

Two major factors have contributed to the slowing in the rate of price increase: a slowing in the trend growth of money and the abatement of adverse energy price developments. At the beginning of 1980, the growth rate of M1 over the prior three years (IV/1976 to IV/1979) was about 8 percent. This indicator of the underlying inflation rate fell slightly to 7-1/2 percent at the beginning of 1981 and to 6-1/2 percent at the beginning of this year. Energy price increases from 1979 to early 1981 contributed to a substantial temporary surge in the rate of increase of prices of final goods and services, especially in 1979 and 1980.







# INDUSTRIAL PRODUCTION


RATIO SCALE










