

NATIONAL ECONOMIC TRENDS

The recent recession moved utilization rates of labor and capital resources to their lowest levels since World War II. Nonetheless, the decline in output has been smaller than in the 1973-75 recession because of unusually strong productivity performance. In the 1973-75 recession, real GNP declined 5 percent from peak to trough; in the year ending in the third quarter of this year, real GNP declined 2 percent. Output per hour in the business sector rose 0.4 percent from the third quarter of last year, in contrast to its 2 percent annual rate of decline from the fourth quarter of 1973 to the first quarter of 1975. In that recession, another indicator of productivity growth, real GNP per civilian worker, fell at a 3 percent rate. Since the peak in the third quarter of 1981, this measure has fallen only 1 percent.

Productivity typically exhibits a cyclical pattern, rising in expansions and falling in recessions. In the early stages of an expansion, idle plant and equipment are reemployed, raising output faster than labor employment. As opportunities for such reemployment become more limited, continued productivity improvements through the use of relatively more capital resources require a faster pace of new plant and equipment investment. Since such investment is a more expensive and slower method of increasing the use of capital resources than reemployment of existing facilities, productivity often turns down before the peak in output. As the economy enters a recession, the utilization of existing plant and equipment slows more than that of labor, so that output declines faster than labor employment.

One factor enhancing productivity growth is a stronger demand for capital goods relative to labor. In the recent recession, the demands for the use of the existing capital stock and for new plant and equipment have not slowed as much as in the 1973-75 recession. In both the 1973-75 recession and the recent period from July 1981 to November 1982, the ratio of civilian employment to the civilian labor force, a measure of labor force utilization, fell about 4 percent from its level at the cyclical peak. In contrast, the Federal Reserve Board index of capacity utilization declined 15 percent in the recent period, compared with a 21.3 percent drop in the 1973-75 period. From the fourth quarter of 1973 to the first quarter of 1975, real nonresidential fixed investment declined at an 11.5 percent rate. Since the third quarter of 1981, such investment declined at a 6 percent rate.

The more favorable capital formation environment also is indicated by the share of such investment in real GNP. At the beginning of the 1973-75 recession, this share stood at 11.1 percent, then declined to a low of 10 percent at the recession trough. The share only declined from 11.5 percent to 11 percent during the last year, and in the third quarter, was near its peak level in 1973, despite a sharply lower capacity utilization rate.






PERCENTAGES ARE ANNUAL RATES OF CHANGE FOR PERIODS INDICATED.














