

National Economic Trends

Economic activity has surged sharply in recent months. From the third quarter of 1982 to the first quarter of this year, real final sales (GNP less inventory investment) expanded at a 3.3 percent annual rate, following a 1.2 percent rate of decline over the prior six quarters. Initially, the acceleration in sales was met largely by sales from inventory rather than by stepped-up production.

Business inventories declined at a \$20.3 billion annual rate (1972 prices) in the fourth quarter of 1982, the sharpest decline in the post-war period, and at a \$16.1 billion rate in the first quarter of this year. As a result, the ratio of inventories to final sales of business (both in 1972 prices) declined sharply to its lowest level since 1966. The decline in inventory stocks relative to sales also is apparent for the manufacturing and trade sectors (see page 20), although it is less dramatic due to the use of current dollar measures; inventory figures do not reflect the slowing in price increases of recent years as quickly as do nominal sales measures. If real final sales continue at the current pace, then production must rise to avoid further inventory depletion. Such a halt to inventory liquidation would require a significant rise in real GNP.

Monthly indicators of activity show that the recovery continued into April. Retail sales climbed at an 8.6 percent rate in the three months ending in April, about the same as the 8.2 percent rise over the previous four months. Industrial production has responded to the rapid sales growth, rising at a 14.3 percent rate from November 1982 to April. In the latest two months, production has risen at a 21.7 percent rate. Personal income growth appears to be strengthening despite the fact that the 5.1 percent rate of expansion in the first four months of this year about matched that of the previous four months. In March and April, personal income rose at an 8.2 percent rate.

Employment turned up sharply in April, so that since December, civilian employment has risen at a 1.1 percent rate and payroll employment at a 2.2 percent rate. As a result, unemployment fell from 10.8 percent of the civilian labor force in December to 10.2 percent in April.

The rate of increase of prices has continued to be depressed by declining energy prices. From December to April, the producer price index for fuels and related products and power declined at a 21.8 percent rate, much faster than the 13 percent rate of decline over the same period in 1982. Producer prices for finished goods declined at a 3.7 percent rate in the first four months of this year, and consumer prices rose at only a 2.1 percent rate over the same period.






PERCENTAGES ARE ANNUAL RATES OF CHANGE FOR PERIODS INDICATED.














