

# National Economic Trends

## June 1985


Revised estimates for the first quarter of 1985 show that the slowdown in GNP growth since the second quarter of 1984 almost brought the ongoing expansion of real output to a halt. Nominal GNP increased at only a 5.6 percent annual rate in the first quarter, and real GNP rose at only a 0.3 percent annual rate. As a result, nominal and real GNP have expanded at only 6.1 and 2 percent rates, respectively, since the second quarter of last year. Over the previous six quarters of the current expansion, nominal and real GNP expanded at 11.2 and 7.1 percent rates, respectively.

A major factor influencing the short-run growth rates of nominal and real GNP is the growth of the money stock. When the growth rate of the money stock increases, the growth of GNP increases. Indeed, after a few quarters, the acceleration in GNP growth tends to equal the acceleration in money growth. Similarly, when the growth of the money stock slows, GNP growth slows, initially not as much, but after a few quarters to the same extent as the money stock.

The 1984 slowdown in GNP growth was preceded by a sharp slowing in the growth of the money stock (M1). From the third quarter of 1982 to the third quarter of 1983, the money stock expanded a record 13.1 percent. Money stock growth slowed sharply to a 5.5 percent rate from the third quarter of 1983 to the end of 1984.

Since GNP growth does not respond immediately to a change in the growth rate of the money stock, the growth of M1 velocity, approximately the difference between GNP and money stock growth, tends to move inversely to the growth rate of the money stock in the short run. For example, in the first quarter of this year, the money stock grew at an 11 percent rate, twice as fast as its growth over the previous five quarters. Since GNP growth was little affected initially, the velocity of M1 fell substantially, declining at a 4.8 percent rate during the quarter. The "flash" estimate of GNP growth for the second quarter of this year indicates that GNP growth did accelerate, but only slightly, rising to a 6.4 percent rate. Since the first quarter, M1 has continued to grow at a rapid pace, indicating a further decline in velocity.



## EMPLOYMENT













RATIO SCALE



TRILLIONS OF DOLLARS






