

NATIONAL NEWS

CHICAGO: George R. Boyles retired Jan. 15 as vice chmn. of Central National, concluding a 58-year banking career.

CHICAGO: Directors of Continental Illinois National Bank and Trust have voted to transfer \$20 million from undivided profits to surplus. Capital and surplus now are \$380 million, with undivided profits now \$31 million.

CHICAGO: Herbert V. Prochnow, president of The First National Bank, was recipient last week of the 1966 Business Statesmanship Award presented annually by Harvard Business School Assn. of Chicago.

CHICAGO: Robert P. O'Connor was recently named western sales mgr. of George La Monte and Son. He has been with the firm since 1938.

CHICAGO: Harris Trust and Savings stockholders will vote at annual meeting March 9 on proposal to increase capital and surplus to \$90,000,000. Capital would be \$40,000,000 by transfer of \$8,000,000 from undivided profits, and surplus would be \$50, 000,000 after transfer of \$2,000,000 from undivided profits. A stock split also will be voted on.


