

IOWA NEWS

The Iowa Bankers Association is backing passage of a bill in the current Iowa legislature that would do the following three things in regard to the method for setting rates to be paid by banks on time certificates placed by the Iowa State Treasurer: (1) Increase from three to five the number of persons on the committee setting the rate. Two would be appointed by the Governor. The other three are the Treasurer, Insurance Commissioner and Superintendent of Banks. (2) Eliminate the present rate limits of 1% minimum and 4% maximum that can be paid on these CD's, thus freeing the rate from any limits. (3) Require that the committee set the maximum rate payable monthly, rather than quarterly as at present. Local treasurers may then negotiate up to the authorized maximum rate for that month. ANDREW: Capital of Andrew Savings has been increased from \$75,000 to \$150,000.

a national bank. Presently, he is barred by a recent law from appointing a state banker. The bill has been reported out favorably by the banking committee. A state banker so appointed would have his own bank's examination under the direct supervision of the Governor.

A hearing will be held February 14 at 2:00 p.m. before the Revenue Committee on LB 325, sponsored by Senator Terry Carpenter. The Nebraska Investment Bankers Association opposes the bill, which changes the method of taxation of domestic corporations, and would lead to withdrawal of many such corporations from Nebraska, if passed, the association believes.
