

Bank Advertising to Total \$287 Million

Banks are entering the last third of the 20th century with bigger than ever advertising bud-

Commercial banks in the United States will spend \$287 million in advertising in 1967, according to survey data released by The American Bankers Association. The projected total is \$25 million more than the comparable figure for 1966.

This year's total is a new high for the industry and the 17th consecutive year for increased spending on bank advertising.

Newspapers are still the top choice for bank advertising. This has been true each year since the survey was begun in 1946.

The second most popular method of advertising is "specialties," a catch-all category of small gifts, notions and novelties. Calendars ranked third, with direct mail in fourth place and radio in fifth place. Television, in eighth place, accounted for 3.6% of advertising budgets.

Auto loans, regular checking accounts, and savings are the services that will get the biggest advertising push in 1967, as they did in 1966.

Supreme Court Rules On Bank Mergers

The Supreme Court last week dealt a serious blow to bankers who thought the 1966 Bank Merger Act had freed commercial banks from some of the restrictions of the antitrust laws.

In an 8-0 decision, the Supreme Court reversed lower court decisions which had dismissed Justice Department attacks on proposed bank mergers in Houston and Philadelphia. The case represented the first major test of the 1966 Bank Merger Act, intended by its sponsors to relax antitrust standards in the merger area.

Instead, the Court voted for the Justice Department which claimed all along that the new statute did little to change current antitrust tests for banks.

The decision was written by Associate Justice William O. Douglas. Associate Justice Tom C. Clark did not participate because the Justice Department was a party in the case. Justice Clark's son, Ramsey, is Attorney General.

OMAHA: The Ames Plaza Bank has received FDIC approval to establish a detached drive-in facility at 6430 Ames Avenue.


