

NATIONAL NEWS

CHICAGO: Charles B. Weaver, 63, senior vice president of Northern Trust Company, died last week. He was in charge of the national group of the banking department and had been with the bank for 37 years.

MONTREAL: R. D. Mulholland has been elected president of the Bank of Montreal succeeding G. Arnold Hart who will continue as chairman and chief executive officer. Mr. Mulholland has been executive vice president and chief general manager.



S. District Court in Butte.

DENVER: Suit has been filed in District Court on behalf of the Cherry Creek National Bank and the South Denver National Bank challenging the right of Mid-States Bank to a charter on the grounds that operation of the bank consti-
