Question "Loan Production" Offices

The question of whether "loan production offices" are branches under state law is a key one which will have to be resolved to give real meaning to the Federal Reserve Board's new ruling permitting member banks to establish such offices at "any location in the United States."

In its recent interpretation, the Fed said that loan production offices were not branches under Federal law. However, the question still remains of whether such offices may be considered branches under the various state laws. A ruling that they are branches could ban loan production offices in non-branching states and restrict them in limited branching states.

Philip Hewes, president of the National Association of Supervisors of State Banks, addressed the annual district 2 conference of NASSB at Breezy Point in Minnesota this past week. He praised the portion of the Fed ruling that allows state member banks to set up operational subsidiaries. He did not elaborate on the portion of the ruling that allows "loan production offices." It is contemplated that the NASSB will soon develop an official position on this phase of the Fed action at next Federal Legislative Committee meeting. The meeting will be held within the next 30

NASSB considered the Fed's reversal of its stand (to allow state banks to set up operational subsidiaries) a real victory for state-chartered banks. The ruling was made by the Fed the day following a meeting of heads of a number of large state banks and state banking authorities with Fed officials. Mr. Hewes described this as a "possible coincidence!"

Plan Credit Card Hearing...

Congressional hearings on the distribution of unsolicited bank credit cards are tentatively scheduled for October, according to Senator William Proxmire (D., Wisc.) chairman of the Senate Financial Institutions Subcommittee.

Senator Proxmire is especially interested in two phases of the growth of credit cards: (1) the effect of credit card use on

consumer debt, and (2) the legal liability of the card holder in the event the card is lost or stolen. It is anticipated that the senate hearings will be exploratory in nature rather than aimed at specific legislation.

Most recent development in the credit card field in the Northwestern Banker area is the assignment of Marquette National Bank, Minneapolis, as a licensed agent for BankAmericard for the states of Minnesota, South Dakota and North Dakota. First National Bank of Omaha also is assigned South Dakota, along with Iowa and Nebraska. Commerce Trust Company, Kansas City, is the licensed agent for its trade area.

Joins Minnesota Bankers...

Wayne F. Berthiaume has joined the staff of the Minnesota Bankers Association, according to Association President J. J. Choromanski, president of the Crystal State Bank.


