

Plan One-Bank Holding Company Meeting

The key to a banking industry "consensus" on onebank holding companies - to be sought at a meeting in Washington, D.C. November 20 - may be an agreement by single bank holding companies to limit their future acquisitions to financially related businesses.

The post-election meeting has been set up by the American Bankers Association in the hope of developing a common approach to one-bank holding company legislation before Congress returns. It is almost certain that one-bank holding companies will be the subject of legislative attention - and possibly action - by the next Congress.

Around 40 persons are expected to attend the November meeting, including representatives from the newly-formed Association of Corporate Owners of One Bank; the Reserve City Bankers Association; the Association of Registered Bank Holding Companies; and the Federal banking agencies.

Meanwhile, FRB Governor George W. Mitchell has indicated he sees greater anticompetitive danger in permitting one-bank holding companies to acquire financially-related businesses than non-banking related organizations. In contrast, FDIC Chairman K. A. Randall suggested at the Iowa Bankers Convention that one-bank holding companies might be permitted to expand into financiallyrelated fields.

Armored Car Service Termed Illegal Branching ...

Following the edict of the U. S. Fifth Circuit Court of Appeals, a Federal District Court Judge Sidney O. Smith, Jr., has ruled that a bank's armored car messenger service constitutes branch banking in violation of state law.

Granting the motion for a summary judgment requested by W. M. Jackson, Georgia Superintendent of Banks, and a group of national and state-chartered banks in the state, Judge Smith said the present activities of the First National Bank of Cornelia "come squarely within the definition of branch banking" set down by the appeals court in Dickinson v. First National Bank of Plant City.

Contracts and other forms used by First National, Judge Smith ruled, do not basically alter the actual banking functions being performed by the bank at its mobile facilities. The receipt of cash, checks and other negotiable documents by the bank's employee at its armored truck constitutes doing banking business, regardless of stipulations in the accompanying transmittal slip, he said.

Further, he ruled that the exchange of cash for checks from the public at the armored truck the cashing of constitutes checks by the bank. And the dispatching and delivery of currency by the armored truck constitutes the withdrawal of funds and the cashing of checks by the bank at its armored

truck.


CHEYENNE: Cheyenne National Bank has been cited as one of the top 100 commercial banks in the nation in terms of real estate loans serviced.
