#### **NORTH DAKOTA NEWS**

BISMARCK: Governor Guy has signed H.B. 133, which carried an emergency clause and became law immediately. This bill provides that the maximum allowable interest rate be 3% above that authorized by the State Banking Board which banks may pay on deposits. On June 29, 1967, the State Banking Board authorized North Dakota banks to pay 5%, compounded, on certificates of deposits. Therefore, the present maximum allowable interest rate in the state is 8%, which is 3% over the certificate of deposit

There are several exceptions to the 8% rate, and they will be outlined in the April Northwestern Banker.

#### SOUTH DAKOTA NEWS

ONIDA: The Sully County Bank has joined the Federal Reserve System.

PIERRE: A proposed one-year freeze on branching by merger in South Dakota has been defeated by the South Dakota Legislature. The bill, calling for a moratorium on branching until July 1, 1970, and supported by the Independent Bankers of South Dakota was voted down 41-28 in the House. The action was seen as support for the South Dakota Bankers Association proposal for a committee tc study branch banking in the state.

YANKTON: James M. Lloyd, former president of the American State Bank and former state senator, has died in Sacred Heart Hospital where he had been a patient for the last two weeks following a stroke.


