### List Senate, House Banking Committees

There are seven new members of the House Banking Committee and six new members of the Senate Banking Committee in the 92nd Congress.

About the only big change in the final line-up in committee assignments was the transfer of Rep. Seymour Halpern (R., N.Y.) from the House Banking Committee, where he was the third ranking minority member, to the House Foreign Relations Committee.

The 15-member Senate Banking Committee has two new Democrats – Sen. Adlai Stevenson (Ill.) and Sen. David Gambrell (Ga.) – and three new Republican members – Sen. Robert Taft (Ohio), Sen. W. E. (Bill) Brock (Tenn.), and Sen. William Roth (Del.).

The holdover members of the committee, which now consists of eight Democrats and seven Republicans, are Chairman John Sparkman (D., Ala.), Sen. Thomas J. McIntyre (D., N.H.), Sen. William Proxmire (D., Wis.), Sen. Harrison A. Williams, Jr. (D., N.J.), Sen. Walter F. Mondale (D., Minn.), Sen. Alan Cranston (D., Calif.), Sen. John Tower (R., Utah), Sen. Edward Brooke (R., Mass.), and Sen. Robert Packwood (R., Ore.). During this Congress, Sen. Tow-

er rather than Sen. Bennett will be the ranking minority member. The reason is a new Republican rule in the Senate that no GOP Senator may be ranking member on more than one committee. Sen. Bennett is ranking minority member on the Senate Finance Committee.

The House Banking Committee, whose size has been increased from 36 to 37 members, has three new Democrats – Rep. Parren Mitchell (Md.), Rep. William Cotter (Conn.), and Rep. Edward Koch (N.Y.) – and four new Republican members – Rep. Bill Archer (Tex.), Rep. Bill Frenzel (Minn.), Rep. Norman F. Lent (N.Y.), and Rep. Stewart B. McKinney (Conn.).

The changes in the House Banking Committee, which now consists of 22 Democrats and 15

Republicans, resulted from a combination of the expansion of the committee, election results and shifts in committee assignments.

Three former members – Rep. Nick Galifianakis (D., N.C.), Rep. Michael J. Harrington (D., Mass.) and Rep. Seymour Halpern (R., N.Y.) – transferred to other committees. Former Rep. Brock moved from the House to the Senate. And former members Chester L. Mize (R., Kan.) and William O. Cowger (R., Ky.) were defeated in their bids for re-election.

Holdover majority members are Committee Chairman Wright Patman (D., Tex.), Rep. William A. Barrett (D., Pa.), Rep. Leonor K. Sullivan (D., Mo.), Rep. Henry S. Reuss (D., Wis.), Rep. Thomas L. ### Prime Rate Falls to 5-3/4

Four leading New York banks -Bankers Trust Co., Chase Manhattan, First National City Bank, and Chemical Bank-on February 16 cut their prime rates to 5-3/4% from 6%.

The cut was the ninth since a record peak of 8-1/2% reached June 9, 1969. The last cut was on January 18.

The banks, on December 31, had total deposits of \$3,260,279,266.36 compared to \$2,968,035,262.65 on June 30. Loans on December 31 were \$1,825,050,512.52 compared to \$1,-778,451,459.16. Total loans were 59.31% of total deposits on Decema ber 31, and 63.04% on June 30.

Total capital accounts on December 31 were \$262,276,771.68 and on June 30 \$249,152,491.08.

DENVER: Don E. Vestal, southeast Denver homebuilder, has been elected to the board of the University National Bank.


