BAI Convention to Host 3,000

Rep. Wright Patman, chairman of the House Banking and Currency Committee, and James J. Saxon, former Comptroller of the Currency, head the list of more than 40 banking experts who will address the 47th National Convention of Bank Administration Institute to be held at the Fontainebleau Hotel in Miami Beach, November 7 to 10, convention general chairman, Frank Smathers, Jr., announced.

Mr. Smathers, who is chairman, United Bancshares of Florida, Miami Beach, said that an estimated 3,000 bankers and their wives would attend the 3-day meeting, which will open Sunday, November 7 with registration, review of exhibits and an evening reception.

BAI president, Raymond C. Kolb, senior vice president and cashier, Mellon National Bank, Pittsburgh, will call the convention to order Monday morning, November 8. The opening general session will hear James H. Higgins, president, Mellon National Bank; Charles A. Agemian, immediate past president, BAI, and chairman of the board, Garden State National Bank, Hackensack, New Jersey; and Mr. Saxon, who will deliver the keynote address on regulatory authorities today.

Monday afternoon and Tuesday, November 9, will be devoted to concurrent sessions on audit, operations, control, computer, personnel and the bank holding company.

Representative Wright Patman, D., Texas, will address BAI's annual business meeting, which will be presided over by BAI president, Raymond C. Kolb Wednesday morning, November 10. Representative Patman, is chairman of the House Banking & Currency Committee.

the traditional Ask the Experts session at which chairmen and members of BAI's Accounting, Audit, Personnel Administration, Tax, Operations and Trust Commissions will be available to answer questions from delegates.

NATIONAL BANKS ASSETS **UP 12.9 PERCENT**

Total assets of the 4,599 National banks reached \$353.0 billion on June 30, 1971, according to Comptroller of the Currency William B. Camp. This figure represented an increase of \$40.4 billion, or 12.9 percent, since mid-1970.

Deposits of National banks totalled \$294.1 billion at mid-1971, including \$151.3 billion time and savings deposits and \$142.8 billion demand deposits. The increase in total deposits during the

preceding twelve months was \$39.7 billion, virtually matching in dollar amount the increase in total assets.

ANNOUNCE TWO KEY **ABA APPOINTMENTS**

Mr. Vucurevich also owns banks in Nebraska and Montana.
