## Senate Committee Approves Farm Bill

A comprehensive rural development bill which would establish new forms of financial assistance to rural communities has been approved by the Senate Agriculture Committee.

The committee bill provides for establishment of a borrower-owned nonfarm credit system similar to the existing Farm Credit System. The Federal Government would appropriate \$200 million a year for 10 years. It is anticipated that the system would provide a loan fund up to 20 times the size of the capital in the system.

The measure provides authority for unlimited Farmers Home Administration loans for essential community facilities; to finance business and improve the environment of rural areas. It also provides loans for small business, and expands the number of eligible applicants and loan purposes for community facility loans.

Liberalization of Farmers Home Administration lending authority for farm loans is provided for in the proposed legislation. The bill increases from \$35,000 to \$50,000 the limit on operating loan indebtedness for farmers and a total first-year grant authority of \$725 million is provided by the bill — \$500 million would be part of a revenue sharing provision to be provided to the states for rural development purposes. Unlike the Nixon Administration's original special revenue sharing plan for rural community development, the Committee bill would not "fold in" any of the 11

categorical grant programs, such as the Appalachian Regional Commission, the Rural Environmental Assistance Program, or the Cooperative Agriculture Extension service.



One hundred million dollars of the authorization would go to borrowers to be used as an incentive for business location in rural areas and for community facilities development. Fifty million would be authorized for grants to the Land Grant Universities for the establishment of rural development extension programs, research and training for rural development, and for small farmers.

The bill provides for an extension of the purposes for which cost sharing grants can be made by the Soil Conservation Service, providing for 10-year contracts for soil and water conservation practices. The bill permits grants from other agencies for land acquisition, and authorizes federal cost sharing for municipal and industrial water supplies.

The measure would give the Department of Agriculture prime responsibility for rural development. It would reorganize the Farmers Home Administration into the Farm Development Administration and the Rural Enterprises and Com-

munity Development Administration, each under its own Administrator. It provides for an Assistant Secretary for Rural Development Credit.

### Muskie Aims At Banks For \$200 Million

Presidential hopeful Senator Edmund S. Muskie (D., Maine) has proposed a tax program that would include higher taxes for financial institutions. His \$25 billion reform program proposes that commercial banks, mutual savings banks and savings and loan associations be limited to their actual loss experience in making tax-free additions to their bad debt reserves.

Muskie's plan also includes an option to allow states and municipalities to issue taxable, rather than tax exempt bonds.

Muskie estimates his program for the financial institutions would bring an additional \$200 million into the Treasury.

### Tax Ruling On Bank Insurance Income

The Supreme Court has ruled that insurance income is not allocable for tax purposes to National banks affiliated with bank holding companies. The ruling overturned an Internal Revenue Service ruling that 40 percent of certain types of insurance income was the equivalent of sales commissions earned by these banks. The High Court upheld a lower court ruling against the IRS, but on a different basis.



### Loans to Politicians Legal After April 7

Beginning April 7, it is now legal for national and state banks to make bona fide loans to political candidates and committees. A bill - the Federal Elections Campaign Act of 1972 - making this clear was signed into law by President Nixon recently. The measure took effect sixty days after enactment.

Under the measure, bank loans to political organizations and candidates "made in accordance with the applicable banking laws and regulations" are not to be considered political contributions.
