### ABA Opens in Dallas with 12,000 Registered

The 98th annual convention of the American Bankers Association gets underway today (Monday) in Dallas, Tex., with an anticipated registration of more than 12,000 persons. Allen P. Stults will be presiding at the convention in his position as president of the ABA. He is scheduled to be succeeded in that post at the election on Wednesday by Eugene H. Adams, currently president-elect of the ABA.

Mr. Stults is chairman and chief executive officer of the American National Bank and Trust Company, Chicago.

Mr. Adams is president of the First National Bank of Denver.

General sessions will be held in the \$33 million Dallas Convention Center complex, just two blocks away from downtown Dallas, on Monday and Wednesday mornings. A variety of theme sessions and guest speakers will be featured on Tuesday.

After the opening ceremony at the general session on Monday, Mr. Stults will address the convention. Also on the

program will be Willis Alexander, executive vice president of the ABA, and Richard G. Lugar, the Mayor of Indianapolis.

Participation will be a principal theme of the convention as every effort is being made to get convention attendees to take part in dialogue sessions with speakers and ABA officials in order that the association might be better aware of and respond to individual member's thinking.

The first such opportunity will be Monday morning when Newsweek magazine's Periscope Panel of experts in finance, international news, and national news will respond to questions posed by the audience. Panel moderator will be Dwight Martin, senior editor of Newsweek. Panelists will be Hugh G. Aynesworth, Houston bureau chief; Edward Klein, senior editor, international section; Edward Kosner, assistant managing editor, and Lawrence S. Martz, senior editor of the business and finance section, all with Newsweek.

The Tuesday theme sessions are titled "Speak Up Through Knowledge." Bruce MacLaury, president of the Minneapolis Fed, will speak on economic realities. Jim Hayes, president of American Management Association, will discuss changing life styles as a management challenge. Deputy Secretary of the Treasury Charles E. Walker will explain the myths and realities of taxation. Secretary of Agriculture Earl L. Butz will present an outlook for rural America.



FCB owns four banks in the Denver area Lakeside National, University National, Security National and First National of Englewood. In Loveland, about 79% of the outstanding shares of Affiliated Bankshares of Colorado, Inc., were voted in favor, while less than one per cent opposed. ABC owns 14 banks in Boulder, El Paso, Weld and Larimer counties. ABC would absorb FCB if the merger agreement is approved by the Federal Reserve Board.

Registration will start Thursday, October 19 at 8:30 a.m., and the first session will commence at 9:30 a.m. The conference will adjourn at 11:30 on Friday.

GLASGOW: Bancorporation of Montana has agreed in principle to acquire 80% or more of the outstanding stock of First Security Bank of Glasgow, N. A. The joint announcement was made by Richard D. Rubie and Charles W. Rubie, chairman and president of Bancorporation, and by Charles Brocksmith and Conrad Tvedt, chairman and president of First Security Bank. The exchange of stock is subject to regulatory and certain other provisions. The Glasgow bank will be operated as a subsidiary with no change in management or personnel, it was announced. Total assets of Bancorporation on August 31 were approximately \$100 million. First Security Bank had total assets of \$21.5 million on August 31.

SHERIDAN: Mrs. Ruth Opie of White-hall has announced the sale of the Bank of Sheridan to her brother, Paul Robert, of Prescott, Ariz. Mr. Robert, recently engaged in land development and the mobile home business, has many years of banking experience in Whitehall, Butte and Sheridan where for the years prior to 1962 he was an officer and director.
