John Sparkman, D., Alabama, chairman of the Senate Banking Committee, won re-election by obtaining twice as many votes as his opponent, Winton M. Blount. John Tower, R., Texas, ranking minority member also won in his bid for re-election.

Wright Patman, D., Texas, chairman of the House Banking Committee, had no opposition and will continue as chairman of the committee.

Sen. David Gambrell, D., Georgia, is the one member of the Senate Banking Committee who will not be back next year. He was defeated in the primaries.





The exchange will be in the ratio of seven shares of Banks of Iowa stock for each outstanding share of First National Bank. Banks of Iowa said the remaining 160,000 shares filed may be issued in connection with future acquisitions.

DES MOINES: Central National Bank & Trust Company has filed an application to establish a facility at the southeast corner of 35th Street and Ingersoll Avenue.


MARION: Emery J. Miller, 87, died November 1. He retired in 1970 after serving since 1925 as president and chairman of First National.

SCOTTSBLUFF: The Scottsbluff National Bank has received approval to change its name to Scottsbluff National Bank and Trust Company.






CHICAGO: The Michigan Avenue National Bank of Chicago has received approval to establish a branch bank at 72 East Randolph Street in Chicago.



BISMARCK: It was announced by the North Dakota Bankers Association that the NDBA proposal presented at the recent group meetings for liberalization of the state's bank office laws was defeated. •The proposal would have granted banks permission to conduct loan services at paying and receiving stations, and would have given banks permission to have one or two full service offices within three miles of the city, but not in a neighboring town. The vote was 80 no, 45 yes, and 44 absent or abstaining. The legislative committee was scheduled to meet November 16th to review the matter and then refer it to the NDBA executive council. 5


SOUTH DAKOTA NEWS


