# **High Court Approval for Greeley**

The U.S. Supreme Court has dealt the Justice Department a major defeat by turning down its bid to halt acquisition of the First National Bank of Greeley by the First National Bancorporation of Denver.

The case, closely watched by the banking community, was the nation's first test of Justice Department power to stop banking alignments through antitrust charges.

The high court split 4-4 on Wednesday's decision, but a tie vote upholds the lower court ruling. Justice Lewis F. Powell, Jr. did not participate in the decision.

The government had charged the acquisiton of small state banks by large state bank holding companies eliminated potential competition and would lead to the dominance of commercial banking by a few large holding companies.

The Justice Department pointed out that in 1960 in Colorado there was only one bank holding company and that it operated three subsidiary banks.

But by 1970, the department said, there were seven holding companies in Colorado operating 41 banks which controlled 51 per cent of the total bank deposits in the state.

However, on Aug. 27, 1971, then Denver U.S. Dist. Court Judge William Doyle ruled the government failed to show the acquisition of the Greeley bank by the First National Bancorporation would "substantially lessen competition."

Attorneys for the First National

Bancorporation argued the acquisition of the small state banks doesn't necessarily discourage new competition.

They noted that in areas where the state's two other major bank holding companies had acquired banks, 24 new banks have organized and performed well.

The bank attorneys also questioned the right of the justice department to regulate the structure of the banking industry, a duty assigned by Congress to the bank regulatory agencies.

The Justice Department had appealed Judge Doyle's ruling directly to the Supreme Court. The current decision noted only that the lower court ruling was affirmed by an equally divided court.

The court doesn't announce how each justice voted when they are equally divided.

#### ABA Supports Bank Tax Bill

A bill to regulate state taxation of national banks and federally insured financial institutions has received the full support of the American Bankers Association.

In testimony before the Senate Committee on Banking, Housing and Urban Affairs, Frank E. Bauder, chairman of the ABA's Government Relations Council, urged the enactment of S.297, which would:

- Prohibit discriminatory taxation of depositories.
- •Prohibit taxation of intangible per-

sonal property, including cash owned by banks.

 Postpone state taxation of transactions by out-of-state banks, until Congress decides the terms of such taxation.

The bill would carry out the recommendations of a Federal Reserve Board study on state taxation of banks. It was introduced by Senator Wallace F. Bennett (R-Utah) by request.

Mr. Bauder explained that the proposals would reinstitute a situation dating from 1864, when the National Bank Act was adopted. Since national banks



**National Bank of Waterloo** 

WILTON: The Wilton Savings Bank has withdrawn a controversial application to the Iowa State Banking Board for permission to open a temporary banking facility in Atalissa. The application had been challenged by the West Liberty State Bank on the grounds that the Wilton bank would be encroaching on its territory. No specific reason was given for the decision to withdraw.

#### **NEBRASKA NEWS**

The Legislature's Banking, Commerce and Insurance Committee has voted unanimously to advance a proposed one-bank holding act. LB 441. sponsored by Sen. John Murphy of South Sioux City, would allow the State Banking Department to supervise matters of banks owning other banks.

Killed by the committee was LB 305, which would have prohibited financial institutions from getting involved in the insurance business. The bill, sponsored by Sen. Glenn Goodrich of Omaha. would have banned any institutions in a town of over 5,000 population from selling insurance, either directly or indirectly, regardless of the situation.

DODGE: Funeral services were held recently for Fred J. Rabeler, 63, pres., Farmers State Bank. He had been with the bank for 23 years. Mr. Rabeler's son, Russell, is a v.p. in the bank.

HARDY: Jerry Cordis is the newly named mgr. of the Hardy State Bank, succeeding Vinton Clark, mgr. for the past six years.

were Federal instrumentalities, states could only impose those taxes specifically authorized by Congress. Over the years, five types of taxes were authorized on real estate, national bank shares, taxes on dividends as part of the taxable income of shareholders, bank income taxes, and franchise taxes measured by bank income.

In 1969, Congress approved an amendment that would end Federal regulation of state taxation of banks, and permit states to tax national banks as though they were state-chartered. The amendment took effect on January 1, 1973.
