Must Understand Pressures of Change

Bankers must understand — not just react — to the pressures that bring about changes in their industry if they are to deal with them effectively, the executive vice president of the American Bankers Association said recently in Baton Rouge, La.

Willis W. Alexander, in a speech to the Louisiana Bankers Association's Mid-Winter meeting, said, "Once we have identified the pressures that will change the system, we have a chance to forecast what those changes are likely to be. And we can make plans.

"If we have an awareness of our environment and face the certainty of change with realism, we can chart banking's course in the public interest," he continued.

Mr. Alexander said shortages of items like capital, raw material and land top the list of pressures for change in the banking industry as well as the nation.

Banking's energy supply — money — is also in short supply, Mr. Alexander pointed out — a situation, he warned, that could make the fuel shortage look mild by comparison. One cause of this problem, he said, is that the banking system is hobbled by regulations on competition for key capital resources.

The continuing shortage of funds will keep the cost of capital — interest rates — at a somewhat higher level than in the last decade, he stated. Rate fluctuations in turn have the effect of making the consumer financially more sophisticated.

This public awareness of the value of

money and the fact it is increasing constitutes a second major source of change, Mr. Alexander said. This pressure manifests itself in such ways as consumer

demand for interest on checking accounts.

"A third major force for change," he said, "is the increasing size of the economy, and, as a by-product, the increasing size of individual business units, including banks and other financial institutions."

This type pressure makes itself felt, for example, in certain proposals concerning the affiliation between banks and their trust departments, Mr. Alexander explained. The very fact that the total assets of banks and their trust departments total more than a trillion dollars creates problems for banking, given the fact that the average American is usually apprehensive about something that big.

Other forces for change outlined by Mr. Alexander include the establishment of an electronic funds transfer system, competi-

tion and the need for equal competitive ground rules between financial institutions, government pressure, escalating standards for business performance, shifting public attitudes and the whole area of social priorities.

Housing will continue to be at the top of the social priority list in 1974, Mr. Alexander said. The banking industry must continue to tell the story of the major role it plays in housing because it cannot afford to let the thrift institutions take all the credit for housing the nation.

The transaction is accomplished instantly by electronic transfer of funds between a terminal in the supermarket and the S&L's on-line computer. This eliminates check cashing by the cardholding customers, thus reducing bad check losses for the supermarket. 
