### Missouri Considers Control of Bank H.C. s

The 77th General Assembly of the State of Missouri has received House Bill No. 1798, an Act relating to the control and limitation of bank holding companies. It was read the first time on March 11 and is now awaiting further action.

Section 2 makes it "unlawful for any bank holding company to obtain control of any bank if the total deposits in the bank together with the total deposits in all banks in Missouri controlled by the bank holding company exceed thirteen percent of the total bank deposits in all banks in the state."

This restriction is similar to one in the Iowa law that became effective last year, although in Iowa the holding company may have only 8% of total time and demand deposits held by banks in the state.

Section 2 of the Missouri bill stipulates that "there shall be deducted from total deposits, certificates of deposit in the face amount of one hundred thousand dollars or more, deposits from sources outside the United States, and deposits of banks other than banks controlled by the bank holding company."

Section 5 makes it unlawful for any bank or holding company outside Missouri to operate a business within that state. The section reads as follows: "No bank, trust company or bank holding company organized or based in any other state or country shall operate any business of any kind from an office in this state, directly or indirectly, unless the office was in operation on January 1, 1973, or unless it is approved affirmatively that such operation supplies a function or service not furnished by any

company or other supplier located within this state and its application to operate in this state has been approved by the commissioner of finance."

Several sections of the bill are descriptive in nature, describe the methods for filing and the penalties for violation. The bill would be effective January 1, 1975, if approved by the legislature and signed by the governor.

Section 5 is considered to cast doubt on the ability of national bank holding companies to operate within Missouri through finance company or mortgage company affiliates, although this has not been clarified at this point by the discussion to date.

### District Court Rules Against Nebraska Independent Bankers

Omaha District Court Judge John C. Murphy dissolved on March 14 the restraining order previously granted to prevent American Community Stores Corporation (Hinky Dinky supermarkets) from operating computer terminals in its stores that are tied in to the main computer of the First Federal S&L of Lincoln. The supermarkets have been operating the Transmatic Money Service terminals directly from the store to the S&L computer to effect transfer of funds instantly for S&L customers who desire cash at the store. This effectively withdraws money from the savings accounts and by-passes the checking account system, and eliminates any bad checks so far as those customers are concerned.

The Nebraskans for Independent Bank-

ing had filed a petition for a temporary injunction and this, too, was denied.

The Nebraska Bankers Association, Inc., was not a party to the action. The association officials recently concluded a statewide series of meetings designed to get executive officer opinion on steps the NBA should take and following those meetings the NBA Executive Council on March 13 unanimously approved establishment of a Study Committee to provide for alternatives that could be available to effectively compete in the area of electronic funds transfer for Nebraska banks. A preliminary report from the Study Committee is expected to be given at the NBA convention in Lincoln May 6.
