Justice Asks Review of Sponsorship Plan

A case with important ramifications for larger banks in many states has been brought to the Supreme Court by the Justice Department. The Department has filed a jurisdictional statement with the high court seeking the overturn of a District Court approval of the acquisition by Citizens and Southern National Bank, Atlanta, of certain "correspondent associate" banks in the Atlanta area.

Justice has asked the Supreme Court to review the case with the aim of a ruling that the detailed contract by C & S of six small and legally independent banks violates both Section 1 of the Sherman Act and Section 7 of the Clayton Act. All parties concede that the small banks are being operated as de facto C & S branches.

The District Court ruled that while C & S held only five per cent of the stock of the smallest banks, the maximum permissible under Georgia law, much of the rest of the stock in the de facto branches was held by C & S officers and stockholders; there were no substantial shareholdings outside of C & S shareholders, and all concerned "recognized the virtually complete direction and control by C & S" and the relationship had been much closer than the normal correspondent banking relationship.

Evidence in the District Court indicated that C & S not only was "intimately involved in all aspects of the six banks' establishment" but has also furnished from its corporate ranks the president and other managing officials of each bank, had selected directors, had arranged for the banks "to use the C & S name and logo to increase their public identification with C & S" and had provided other services.

The District Court ruled that since there had never been any real competition among the sponsoring and sponsored banks because they were new, the de facto control by C & S could not adversely affect competition and did not violate Section 1 of the Sherman Act. Similarly, the court ruled the situation would not substantially lessen competition in the Atlanta area banking market so as to violate Section 7 of the Clayton Act.

Justice hopes to present three issues to the court:

First, Section 1 of the Sherman Act is actually violated by C & S control of these "independent business entities" since the stipulated findings of pervasive control by C & S "establish that the arrangements have eliminated all meaningful price and service competition.'

Second. Justice disputes the District Court conclusion that federal court jurisdiction of the Sherman act controversy is eliminated by provisions of the Bank Holding Company Act of 1956, 12 USC 1841 et. seq., that give "exclusive primary jurisdiction" over the underlying controversy to the Federal Reserve Board.

Third, Justice suggests that "under established market share criteria, C & S's acquisition of the 'five-percent banks' would violate Section 7 of the Clayton Act.'

Some sources see the Justice Department's current appeal of the case to the Supreme Court as being inconsistent on the issue of "sponsorship-acquisition" by large banks. Justice, in U.S. v. Marine Bancorporation, argued that this type of acquisition, in which a bank hoping to circumvent rigid state branching restrictions, helps to organize and charter "legally independent" banks which the organizor bank can ultimately acquire, is a proper and feasible means by which banks may effect geographical market extensions.

In the Marine Bancorporation case, Justice maintained a Seattle bank was "sponsoring" a new bank into Spokane, a different geographic market (300 miles away), which it says is "a far cry" from the relationship between C & S and its

'sponsored" banks.
