## **Predict Largest ABA Convention**

The 1974 Annual Convention of the American Bankers Association (ABA) will be the biggest of its kind ever held and will cover a wider variety of program content than ever presented before.

The Convention will be held in Honolulu, October 19-23. More

than 13,000 bankers and wives have already registered for the meeting. This year's final registration is expected to approach 15,000.

One innovation at this year's meeting will be the scheduling of between 30 and 40 special-interest seminars or workshops. These will begin on Saturday, October 19, and will continue through the convention.

In explaining the new approach, the ABA convention director said, "In evaluations of our prior conventions, suggestions have been made by many participants to expand the program content and to offer a much wider range of topics.

"This is particularly important this year with such an expanded registration and expected increase in bankers coming from all types and sizes of banks from all regions of the country," he added.

It was emphasized that current registrations represent nearly a 50 per cent increase in the number of institutions represented and an increasing number of chief executive officers from small and medium-sized banks.

In addition to the special-interest sessions, there will be two general sessions, held on Monday and Wednesday mornings. Tuesday will be devoted to between eight and 10 concurrent forums, both morning and afternoon. Subjects will range from current issues facing the banking industry to general management subjects and current social issues and problems to world events.

Further details on program content will be announced at a later date.

Another change from last year is the opening of the exhibits on Saturday and their continuation through the convention's close on Wednesday. Exhibits will be housed in the Honolulu International Center (HIC) and the Hilton Hawaiian Village and will be divided into six pavilions.

Another new feature this year will be the scheduling of joint banker/spouse sessions beginning Saturday through Wednesday as a supplement to the general program.

Some quick facts about the Hawaii Convention site:

- 28 hotels in the Waikiki Beach area with a total of 7,500 rooms will be used.
- The Honolulu International Center, located between Waikiki and the downtown area, includes an arena with seating for 7,500 people and will house the two general sessions and a Sunday morning Prayer Fellowship.

• A massive shuttle transportation system is planned to move people between the Waikiki Beach hotels and the HIC.

• Upon arrival, and following the traditional Hawaiian welcome, registrants will be shuttled with their baggage to their hotels.

• ABA will not be using any air charters this year because of the energy situation. All registrants will be traveling on regularly scheduled commercial airlines.

All those planning to attend this year's convention but who have not yet submitted their registration forms are urged to do so as soon as


