Time for Bankers to Make Views Known

"The 94th Congress intends to consider and approve banking

legislation with a speed and efficiency seldom seen on Capitol Hill.' making it imperative for bankers 'to make our views knownand soon." This warning was issued recently by ABA President

George Whyel in an address to the Wyoming Bankers Association's Credit Conference in Casper.

"This year, more than any other year, must be a year for banker involvement in politics," Mr. Whyel stated, adding that banker participation in politics is important because the 94th Congress "offers us an excellent opportunity to present the facts of banking more effectively—a chance to clear up once and for all age-old misunderstandings about banking and the workings of a free economy.

He added that "1975 will be a year of great change for banking and the financial industry." Mr. Whyel, who is also vice chairman of the board of Genesee Merchants Bank and Trust Co., Flint, Mich., said that a variety of forces have come together to create a climate in which it seems almost unthinkable that change will not occur. "The public wants changes to deal with our economic problems, particularly high interest rates and a shortage of money for housing.

"The financial institutions themselves, through their own innovations, have added impetus to the forces pushing them toward change," the ABA president stated.

Last November's elections were only the preliminaries, Mr. Whyel said. "The main event is beginning right now. The men and women we voted for-or against-are about to consider, or are considering at this moment, federal legislation that could bring about a revolution in the future of the banking industry.'

He listed as examples legislation now pending in the House of Representatives which would establish a fixed formula for a minimum national money supply growth, allocate credit and enforce credit allocations through adjustments in Federal Reserve member

banks' reserve requirements.

"The 94th Congress intends to consider and approve banking legislation with a speed and efficiency seldom seen on Capitol Hill," Mr. Whyel predicted.

"The implication for bankers is obvious. We must make our views known-and soon. More important, we must explain clearly and logically why our views make good economic sense, for our customers and communities as well as for our industry.

"We must do a better job this year of explaining the facts about our industry's operations than we have ever done before. The alternative is legislation which, however well intentioned, could hinder our ability to serve the financial needs of this nation.'

The over-riding challenge to bankers, Mr. Whyel continued, is one of information-information about the facts of banking life. "We need to communicate the facts about banking operations in a rational, unemotional way. We need to marshall the facts about how banks work-and about how they might be affected by proposed legislation. We need to suggest alternative solutions to problems which we all agree are doing serious

Amends Regulation on Reporting Requirements

The Comptroller of the Currency is amending the regulation governing statements of business interests of directors and principal officers of national banks. The amendment (a) eliminates collection of information relating to deposits, and (b) makes clear that extensions of credit to reporting individuals, as well as to their business enterprises, must be reported.



The ABA spokesman urged bankers to contact their senators and congressmen directly and personally. "It's our responsibility-yours and mine-to make sure that all the members of the 94th Congress learn as much as possible about our nation's financial system. And they must learn soon-before they are called on to vote on final passage of bills that could irrevocably alter the course of banking in the U.S."
