## Seek Increased Farm Loan Limits

Sharp increases in the size of government guaranteed loans to farmers and livestock producers and the creation of a national secondary market for these loans to insure an adequate flow of funds to rural areas was urged recently by a leading agricultural banker.

"The loan limits of the Farmers Home Administration's (FmHA) farm ownership and operating programs and the Emergency Livestock Act must be increased if these programs are to help the producers the Congress intended them to," Oliver Hansen, vice chairman of the American Bankers Association's Agricultural Bankers Division, told a Senate subcommittee in Washington.

Mr. Hansen, who is president of the Liberty Trust & Savings Bank, Durant, Ia., asked that maximum allowable amount of FmHA guaranteed farm operating loans be raised from \$50,000 to \$100,000 and the amount of farm ownership loans be increased from \$100,000 to \$200,000. He also asked for an overall real estate indebtedness ceiling of \$350,000.

The restrictions in these programs, he said, are much too limiting to provide real help to the young farmer, the farmer adversely effected by weather or current economic conditions and qualified

people trying to get into the farming business.

The continued deterioration of the livestock situation since the

enactment of the emergency program warrants doubling of the maximum loan limit to individuals, Mr. Hansen said. He requested that the committee raise the ceiling on these types of loans from \$250,000 to \$500,000 and increase the present 80 per cent guarantee to 90 per cent, in line with the other FmHA programs.

Mr. Hansen also called for the creation of a national secondary market to insure banks that may exhaust local supplies of capital for rural lending purposes can still provide needed funds to their communities. A secondary market allows the government or other

investors to buy packages of loans or shares in a pool of loans freeing money for additional lending.

Nearly one-half of the nation's 14,000 banks are located in communities of less than 5,000 people.


## File Bill to Require Audit of Fed

Rep. Wright Patman, D., Tex., introduced legislation Wednesday which would require a comprehensive audit of the Federal Reserve System by the General Accounting Office. He was joined in sponsoring the legislation by 86 of the 435 members of the House or Representatives.

Mr. Patman, who is chairman of the subcommittee on domestic monetary policy of the House Banking, Currency and Housing Committee, said he would call for early subcommittee hearings on the bill.

He pointed out that the number of congressmen who had agreed to co-sponsor the bill showed that the 94th Congress expects the Fed to be accountable to the people.

"There is a strong sentiment for an end to secrecy at all levels of government and this audit legislation will make it clear that the Federal Reserve is to be subject to audits and public scrutiny the same as any other major Federal entity," Mr. Patman said.

## To Head Independents



## **Questions Colorado Branching Decision**

Thomas J. Gleason, chairman and president of the \$2.7 milliondeposit First National Bank of Fort Collins, Colo., said that his bank has no intention of closing a 24-hour Docutel customer-bank communication terminal in spite of a ruling by the Colorado Banking Board that the terminal violates a state law which prohibits branch banking and sets a limit on detached facilities.

Mr. Gleason insisted, that the CBCT is not a branch but "simply an unmanned remote terminal.'

The seven-member banking

board, in a unanimous decision Thursday, found the terminal to be "an office," which violated the "state and national banking laws. It ordered the state attorney general to take the "necessary action to preserve the dual banking system in Colorado.'
