Form Multi-State EFTS Network


With various banking organizations continuing to disagree on the future for EFTS, one group of midwest banks has agreed to form a new corporation which will begin immediate development of a unique multi-state electronic funds transfer network.

The sponsoring banks of the new system, which will go into operation next year, include: Davenport Bank and Trust Co., Davenport, Ia.; Boatmen's National Bank of St. Louis; Central Missouri Trust Co., Jefferson City; City Bank, St. Louis; Commercial National Bank, Kansas City, Ks.; First National Bank of Belleville, Ill.; First National Bank in St. Louis; Mercantile Trust Co., St. Louis; Traders National Bank of Kansas City; and United Missouri Bank of Kansas City.

Offered To All Banks

In addition to these originating banks, the service will be offered to all banks -- both state and national -- in the five-state area. It will consist of an electronic communications network that will enable participating bank members to provide remote access to a wide range of consumer banking services to their customers.

An initial development study was conducted by Credit Systems Incorporated of St. Louis. CSI is the operating center for Master Charge in the central mid-western states of Missouri, Kansas, Iowa, Illinois and western Kentucky.



Booz-Allen & Hamilton, Inc., a management firm specializing in the field of electronic funds transfer, conducted the extensive study among area consumers, merchants, and banks.

Through the new communications network, consumers will be able to transact most of their normal banking business from thousands of convenient locations throughout the area. There will be two types of bank-service locations: compact equipment will be placed at point-of-sale locations of participating merchants, and free-standing "Financial Convenience Centers" will be installed in busy areas like shopping and industrial centers, airports, etc. These Centers will contain automated banking equipment and will be open 24-hours a day, seven days a week.

The facilities will be shared by all banks participating in the system.

The new service will provide customers of participating banks with direct access to their various bank accounts. They may withdraw funds from -- or make deposits to -- checking and savings accounts; transfer money from one account to another; make payments on various types of bank loans; obtain a credit card cash advance; cash a check at any of the participating merchant locations.

Merchants could find the service desirable because it will reduce "bad" checks, speed transactions, reduce the necessary amount of cash on hand, and increase customer traffic. The system could also permit rapid authorization of bank credit card transactions.

Initial planning calls for the system to provide approximately 6,000 merchant installations, and over 130 of the "Financial Convenience Centers." The system will have the potential to ultimately interface with a national or international network, providing account access for the customer from anywhere in the world.

It is estimated that the participating banks' investment in the network will be in the millions of dollars, but the result will be a unique and convenient consumer service that has never been attempted on this scale anywhere else in the world.


Iowa News

A series of 15 bankers meetings will be held throughout Iowa the week of April 21 to discuss the Iowa Automated Clearing House Association which is scheduled to begin operations October 1, with automated deposits of payrolls.

The meetings will be conducted by Merland J. Wackerbarth, Sioux City National Bank, and Gerald Waters, Davenport Bank & Trust Co., co-chairmen of IACHA's Marketing and Education Committee, along with Larry R. Retherford, Central National Bank, and Herman C. Kilpper, Iowa-Des Moines National Bank, chairman and vice-chairman of the IACHA

steering committee.

Nearly all of Iowa's banks have supported the organization of the IACHA, but it will be necessary for all banks to sign up as "receiving banks," "originating banks" or "originating correspondent banks." Banks are urged to send top officials to the meetings to get complete information on how the Automatic Payments Exchange (APEX) system will operate and affect their banks individually and to sign up.


