AIB Plans Diamond Jubilee

This will be the fourth time that the AIB, the world's largest educational organization, has held its annual convention in Minneapolis, the place of its birth in 1889. AIB was formed that year when Joseph Chapman, a note teller at Northwestern National Bank, got a group of 30 bank clerks together to review a course in commercial law. It was formally organized at the ABA convention in 1900 and has held annual conventions in Minneapolis in 1905, 1921 and 1950.

Dickinson, president, Gateway Bank, said last week that attorneys for the bank are reviewing the service and license contracts submitted by First Federal Savings & Loan Association, Lincoln, under which Gateway Bank would operate if it goes on 1st Federal's TMS program. Mr. Dickinson said Gateway directors reviewed the matter at their May 13 meeting, but it was tabled until further cost studies could be completed, with agreement to hold a special meeting when figures are available.

First Federal President John Dean reported to a Comptroller of the Currency hearing recently that five remote terminals in Lincoln during a recent three month period generated average of 83 daily transactions.

Mr. Dickinson said, "The costs are substantial and we're taking a further look at it. We're also looking at how much new business could be attracted to help pay the costs, and whether we would just be serving and preserving present customers.'


