# Fed May Drop IRA Rate Differential

The Federal Reserve Board has postponed until next year a decision on whether to permit commercial banks to pay the same rates as thrift institutions for Individual Retirement Accounts, but it has also indicated that its decision at that time will be affirmative.

"The Board believes that in enacting the IRA provisions it was the intent of Congress that individuals whose employers do not have private retirement plans should be encouraged to provide for their retirement needs through the establishment of IRAs," the Board said in a statement.

"In order to accomplish Congress's intent, as a matter of public policy the Board believes that IRA participants should be permitted to obtain the highest rates of interest permissible on their retirement savings regardless of where the deposits are maintained.

"In the Board's estimation, a differential on IRA deposits may be viewed as inconsistent with the objective of providing IRA depositors with a means of obtaining the highest earnings possible on funds saved for retirement purposes."

The Board also noted there "is some evidence, as yet inconclusive, which indicates member banks may be at a disadvantage vis-a-vis thrift

institutions in competing for IRA deposits because of the existence of the differential in present interest ceilings." It said it would continue monitoring the situation for several months before drawing a final conclusion.

This statement was based on a survey conducted this year by the Board, the FDIC, and the Federal Home Loan Bank Board of IRA accounts at banks, savings associations and mutual savings banks which showed generally that thrifts hold more IRA deposits than do commercial banks.

"If the present trend in the competitive structure for IRA deposits continues, the Board will then consider taking appropriate steps to restore competitive balance between commercial banks and thrift institutions in the offering of IRAs."

However, the Board said it felt a final decision would be more appropriate in early 1977 when Congress is considering an extension of interest rates ceilings for financial institutions.

In this regard, it noted that Public Law 94-200, enacted last December, makes any action by it to eliminate or reduce an interest rate differential for any category of deposit in effect on December 10, 1975, subject to approval by Congress before it becomes effective.

Commercial banks may pay up to 71/4 % on IRAs if they are made as four-year time deposits or up to 71/2 % if they are made as time deposits of six years or more. Thrift institutions can pay one quarter of one percent more.

# MAPEX Clearing Center Operational in St. Louis

Mid-America Payment Exchange (MAPEX), which became operational July 1, is expected to handle 90,000 transactions in August, all of them direct deposit of payroll checks. Debit functions are expected to be added at a later date.

The MAPEX region is the same as the Eighth Federal Reserve District's St. Louis zone, which includes eastern Missouri, southern Illinois and a tip of southwestern Indiana. MAPEX currently has 195 member banks in the three states, most of them in the St. Louis Regional Check Processing Center, which serves all commercial banks in about a 50-mile radius of St. Louis. MAPEX member banks hold about 85% of total bank assets in the RCPC and represent 99.7% of assets of all commercial banks in St. Louis.


### First of St. Louis Asks Review of Court Decision

First National Bank in St. Louis has announced that it will request the United States Supreme Court to review the decision of the United States Court of Appeals for the Eighth Circuit, holding that First National's use of customer communication terminals at two locations in St. Louis County constitutes branch banking under federal and Missouri law.

First National Bank of Chicago and Continental Bank of Chicago have filed similar petitions with the United States Supreme Court seeking a review of an adverse decision of the United States Court of Appeals for the Seventh Circuit. Other related cases are pending in several district courts.

Prairie du Chien is located in southwestern Wisconsin, 100 miles west of Madison and 240 miles northwest of Chicago. Prairie du Chien is the county seat of Crawford County and is situated on the Mississippi River just north of the point where the Mississippi and the Wisconsin Rivers flow together. Prairie du Chien is the second oldest city in Wisconsin and the area, often referred to as the "Land of the Voyageurs", abounds with historic lore and scenic beauty. 
