Says SBA Farm Disaster Plan a 'Disaster'

A flood of farmer applications for disaster aid loans from the Small

Business Administration prompted that agency's administrator, A. Vernon Weaver, to ask Congress January 30 to transfer the farm disaster loan program to the Farmers Home Adminis-

tration in the Department of Agriculture. Stating that "it is clear to us that SBA expertise is not readily transferable to the farm segment of the economy," Mr. Weaver said SBA has had to rely heavily on the Agriculture Department for advice on "how to repair, rehabilitate or replace a crop," or how to deal with a farmer's claim concerning smaller calf production due to drought.

Citing SBA statistics, Mr. Weaver said that during 1975, the year before Congress placed farm programs within SBA, the SBA processed 10,429 loans totaling \$236.5 million. By comparison, in the last three months of 1977, the SBA approved 10,861 drought-disaster loans for farms totaling \$531.7 million and 7,427 disaster

loans for other homes and business totaling \$107.8 million.

SBA, he said, normally has 300 to 500 temporary employes processing disaster-aid applications at this time of year; however, that figure now is 1,200, he said and those people are working 10 hours a day, seven days a week.

SBA is involved in drought disaster aid in approximately 32 states. One of them with the highest activity is Iowa, where 9,000 applications had been filed as of January 31 for physical disaster aid loans. Of that number, 5,800 had been approved by that date by the SBA state loan committee, with money for 1,156 loans disbursed and the balance being processed. That left 3,200 loans yet to go through the loan committee. With extension of the filing deadline from December 31, 1977 to February 23, applications continue to pour into the emergency office in Des Moines at the rate of 70 per working day, making it likely that the state SBA office will have in excess of 11,000 applications by the February 23 deadline. The physical disaster aid applications are in addition to those that may be filed with SBA for economic injury due to drought, and that filing deadline is September 25, 1978.

The Des Moines SBA office has a regular staff of 50 people. Its disaster emergency aid office has a staff of 112, including some retired bank loan officers who help process loan applications.

Iowa Congressman Neal Smith sponsored legislation in Congress that authorized SBA to make the farm loans. Last week he immediately defended the practice and said he opposes transfer of the service to the USDA's Farmers Home Administration which currently has Congressional limitations on such things as partnership loans that SBA can handle.


