## Nebraska Court Voids H. C. Bill

OLDING company legislation (LB 376) enacted by the 1981 Nebraska legislature was given a double reversal by the Nebraska Supreme Court in a decision announced December 17.


LB 376 was a bill authorizing formation of multi-bank holding companies in Nebraska and expanded numbers of banking facilities. Of the 49 Senators in the legislature, the final vote was 24-24 with one abstention, so the Lieutenant Governor took an unprecedented step by voting in favor of the bill. Governor Charles Thone returned it to the legislature's chief clerk with objections to its final passage. While the Governor was absent from the state the following day, the Lt. Gov. retrieved the bill and signed it into law. After considerable legal discussion over the matter at the legislative level and within the banking industry, the Supreme Court agreed to hear the case last September and return a verdict prior to the end of the year.

In that decision of December 17, the seven justices voted unanimously that the bill did not become law because Governor Thone effectively vetoed it by returning it to the legislature with his objections.

On a split 4-3 decision, they also ruled LB 376 did not become law because the Lt. Gov. was not em-

powered under the state constitution to vote on the bill. The three dissenting judges said he is entitled to vote and that the majority opinion, in essence, has eliminated the office of Lt. Gov. as the presiding officer in the legislature.

When Gov. Thone returned the bill to the legislature, Sen. Chambers of Omaha, who had abstained from voting, moved that the veto be over-ridden. That action would require 30 votes. Sen. John



DeCamp, a proponent of the bill, called for a ruling from the chair that the motion to over-ride was out of order. The presiding officer, the Lt. Gov., then ruled in favor of Sen. DeCamp, which blocked the over-ride motion; thus, the Lt. Gov. upheld his own position.

Since the bill also included the authority for banks to have added drive-in or office facilities within

their communities, that authority was lost. Consequently, Nebraska banks still are limited to two facilities city-wide, one of which must be within three miles of the main bank, while the other may be any place within the corporate limits, so long as it is not closer than 300 feet to an existing bank facility.
