### **Iowa News**

BOONE: Douglas E. Rieken has been elected vice president at Boone State Bank & Trust Company. Prior to joining the bank in 1983 as an assistant vice president, Mr. Rieken was with Griswold State Bank.

BURLINGTON: Farmers and Merchants Bank and Trust has set aside \$5 million for farm operating loans this spring at a rate of 10% - 3½% less than the current price at most ag banks. William Kuehn, vice president and farm rep at F&M Bank said officers at the bank became "tired of all the meetings and all the talk" about the sagging farm economy and decided on "putting our money where our mouth is." The move will cut deeply into F&M's potential profit, Mr. Kuehn said, but said the bank is determined to help the people who have helped the bank.

DUBUQUE: Bill Schrup and Jeffrey P. Mozena have been appointed vice presidents, commercial loan officers, at American Trust and Savings Bank. A graduate of the University of Santa Clara, Mr. Schrup joined the bank in 1982. Mr. Mozena is a 1975 graduate of Loras College in Dubuque and joined the bank in 1975.

FARLEY: It recently was announced that James K. Burdick has been named executive vice president of Farley State Bank. Most recently

The new bank owners - Dick Wikert of Fremont, Nebr., A.C. Benton and Wm. A. Krause of Hampton, and R. Wilson Pursinger of Sioux City paid the FDIC a premium of \$367,700. The new bank retained \$647,000 in installment loans and \$440,000 in real estate loans. FDIC paid \$16 million into the new bank and retained all other loans of First



### **Illinois Bank President**

### Hires Two Senior V.P.s With One Call to AGRIcareers

Bank President L.W. "Link" Phillips intended to hire one senior vice president but wound up hiring two, both through AGRIcareers.
