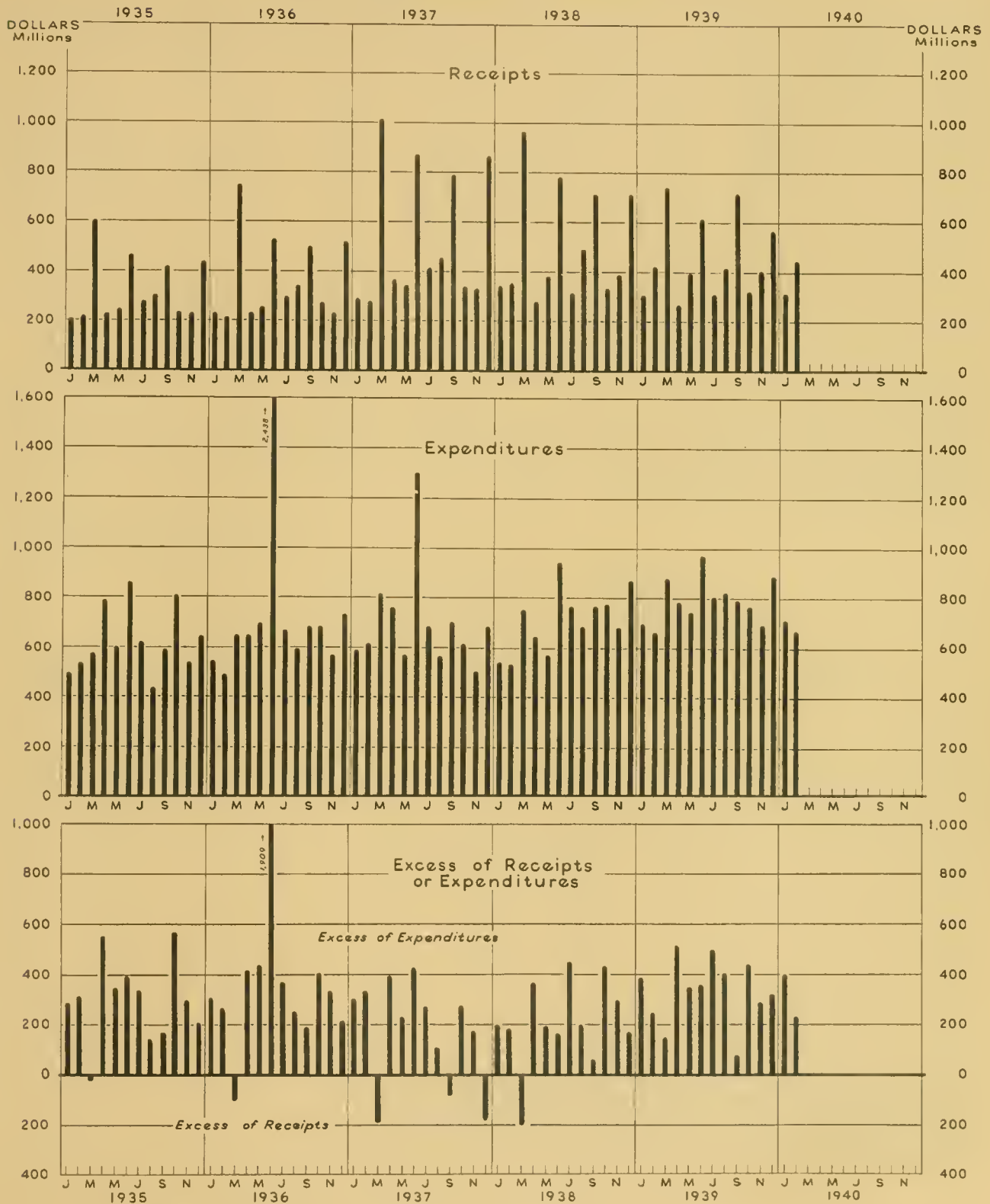

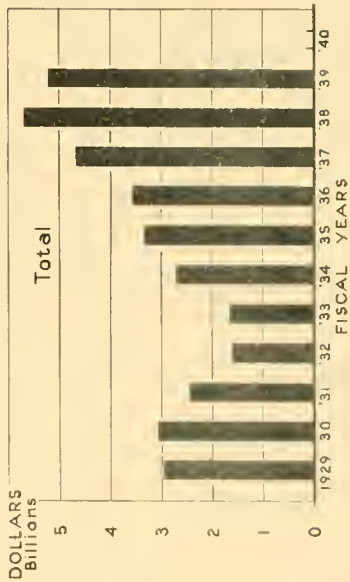

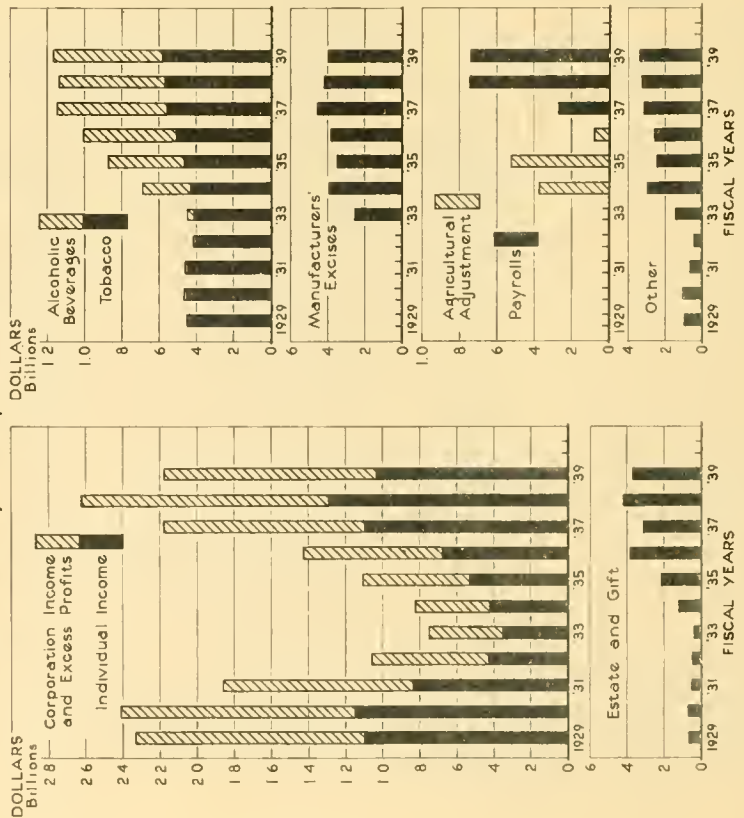
COLLECTIONS OF INTERNAL REVENUE

By Principal Sources

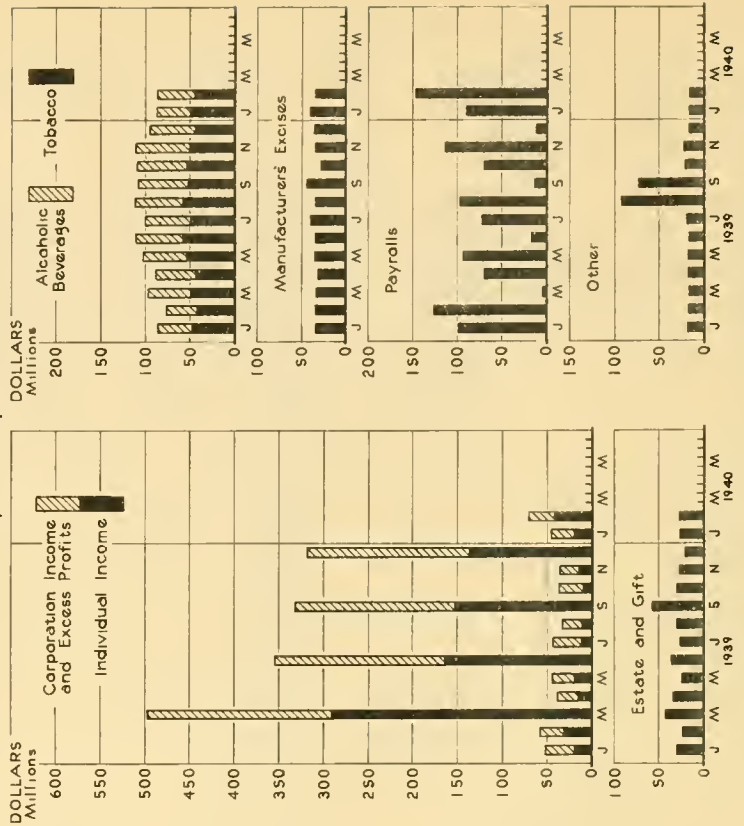


MONTHLY

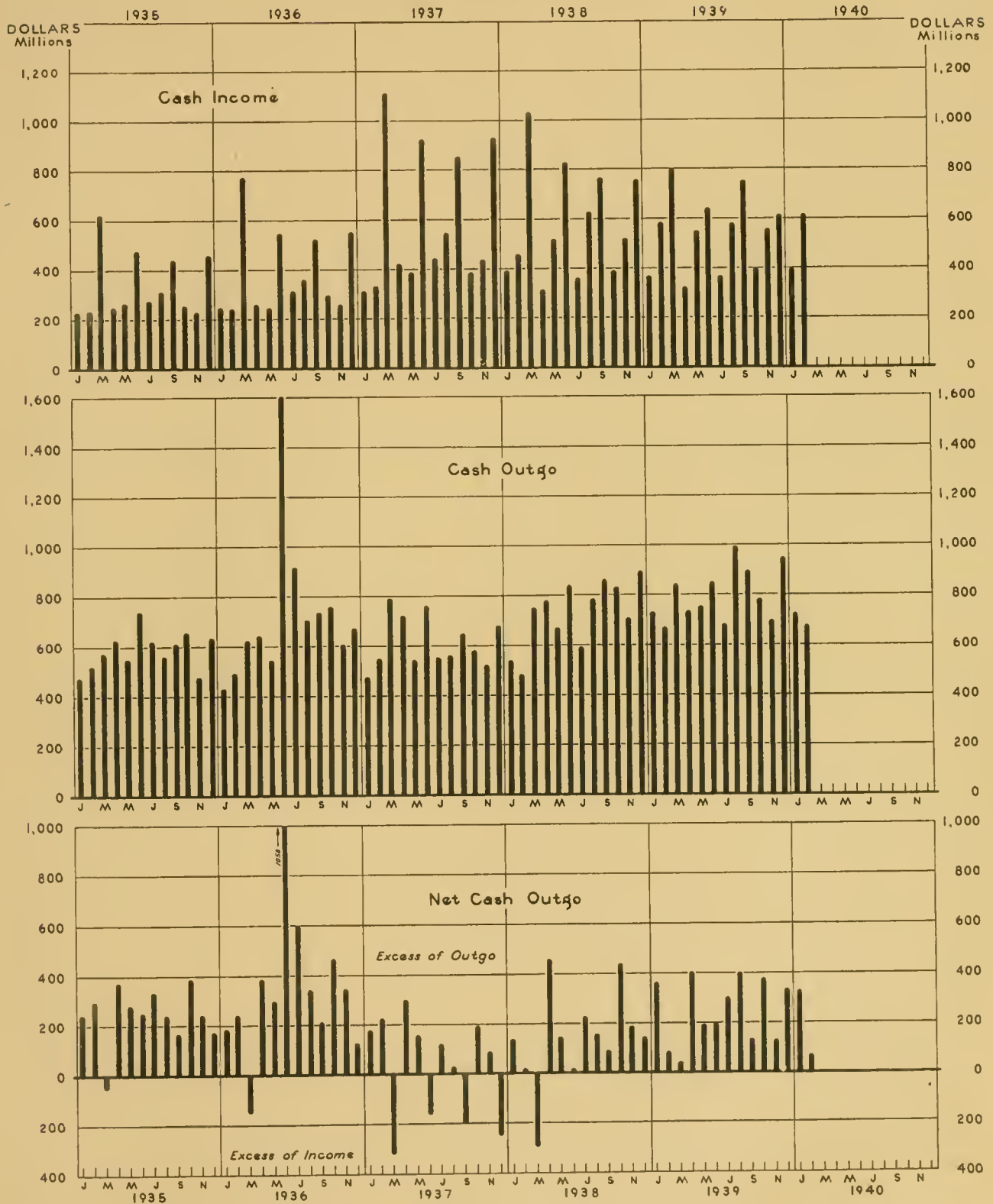

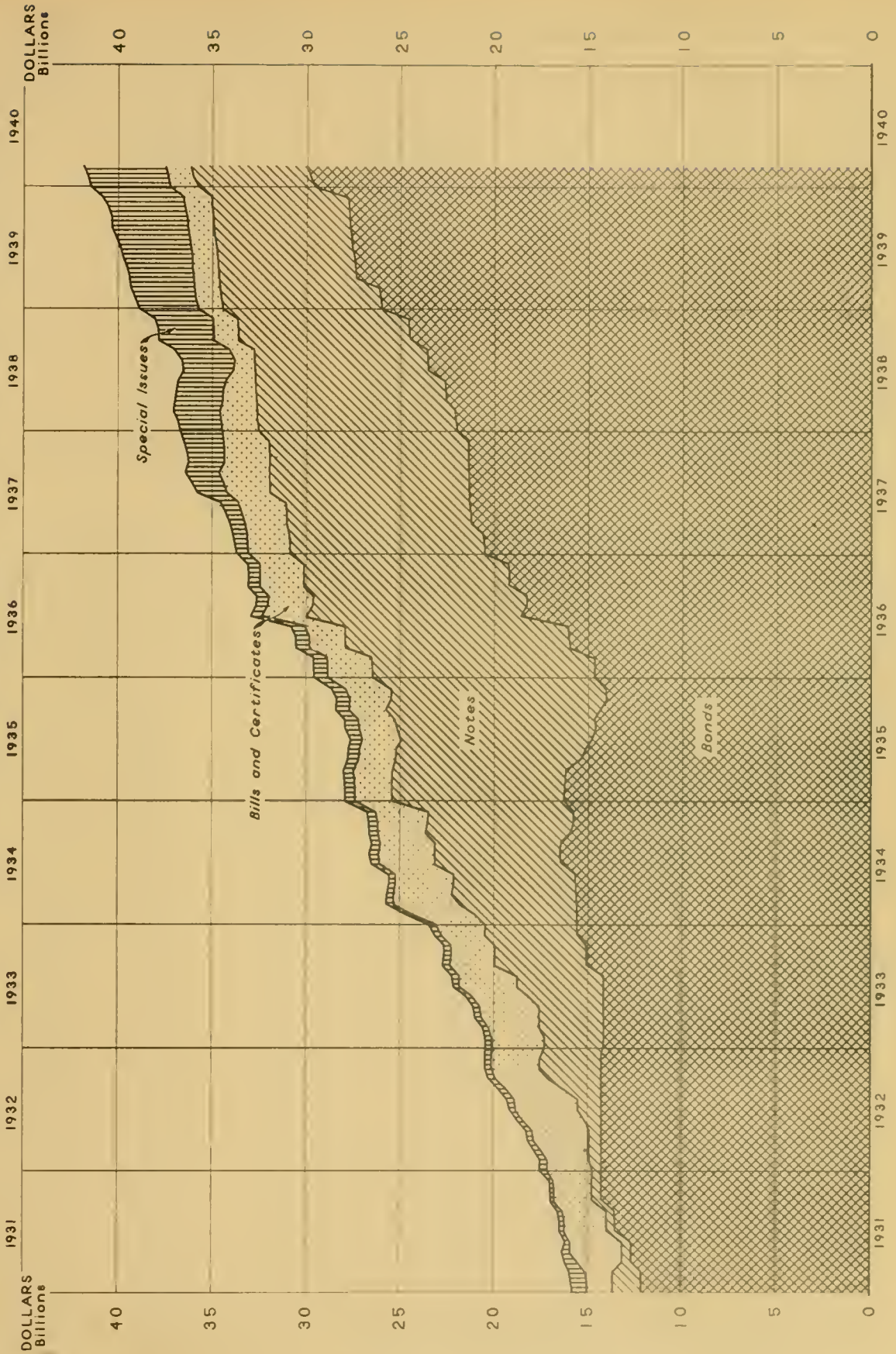

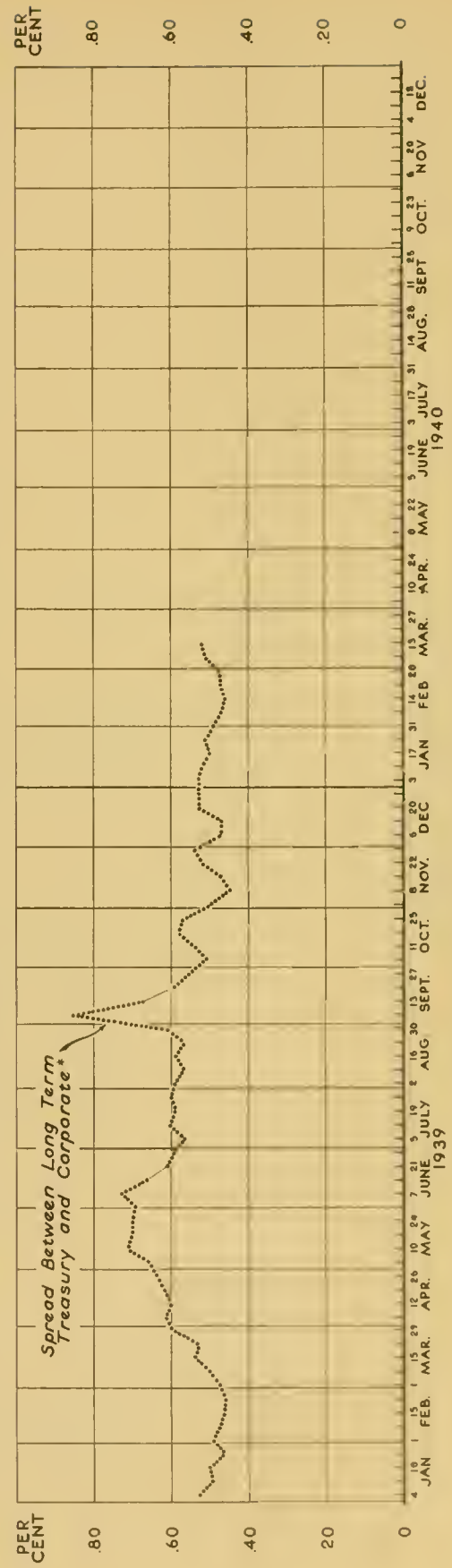
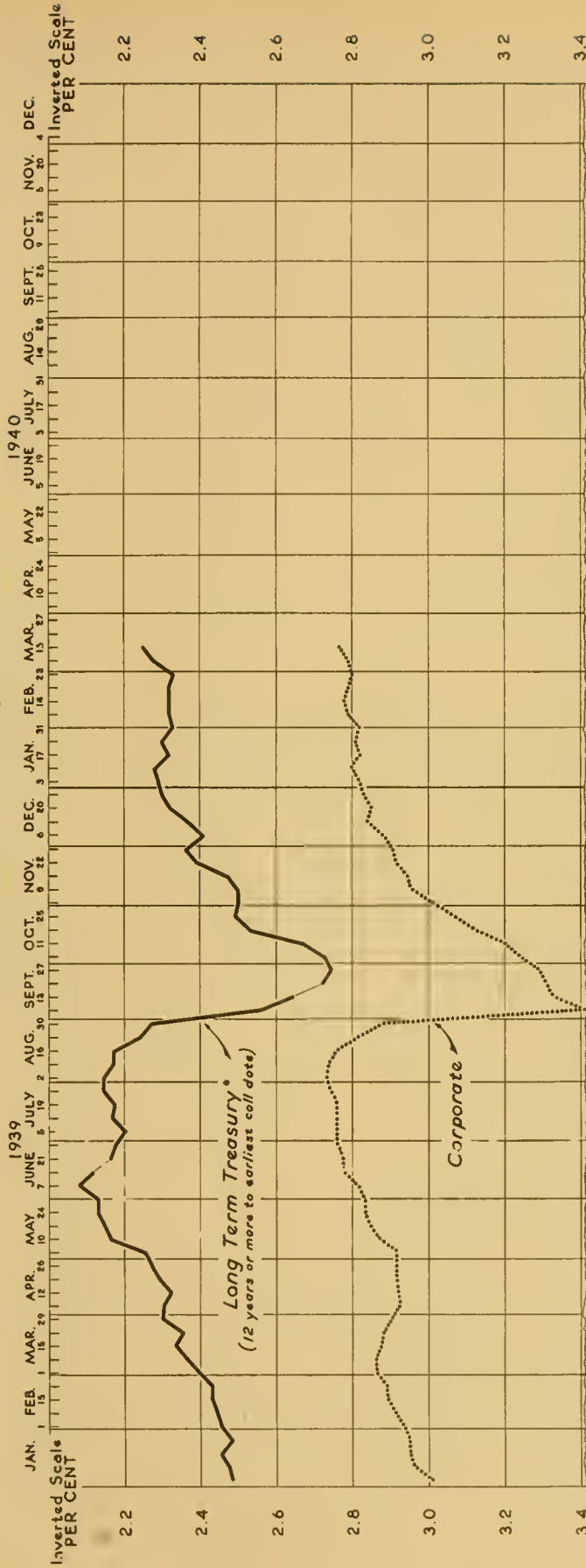

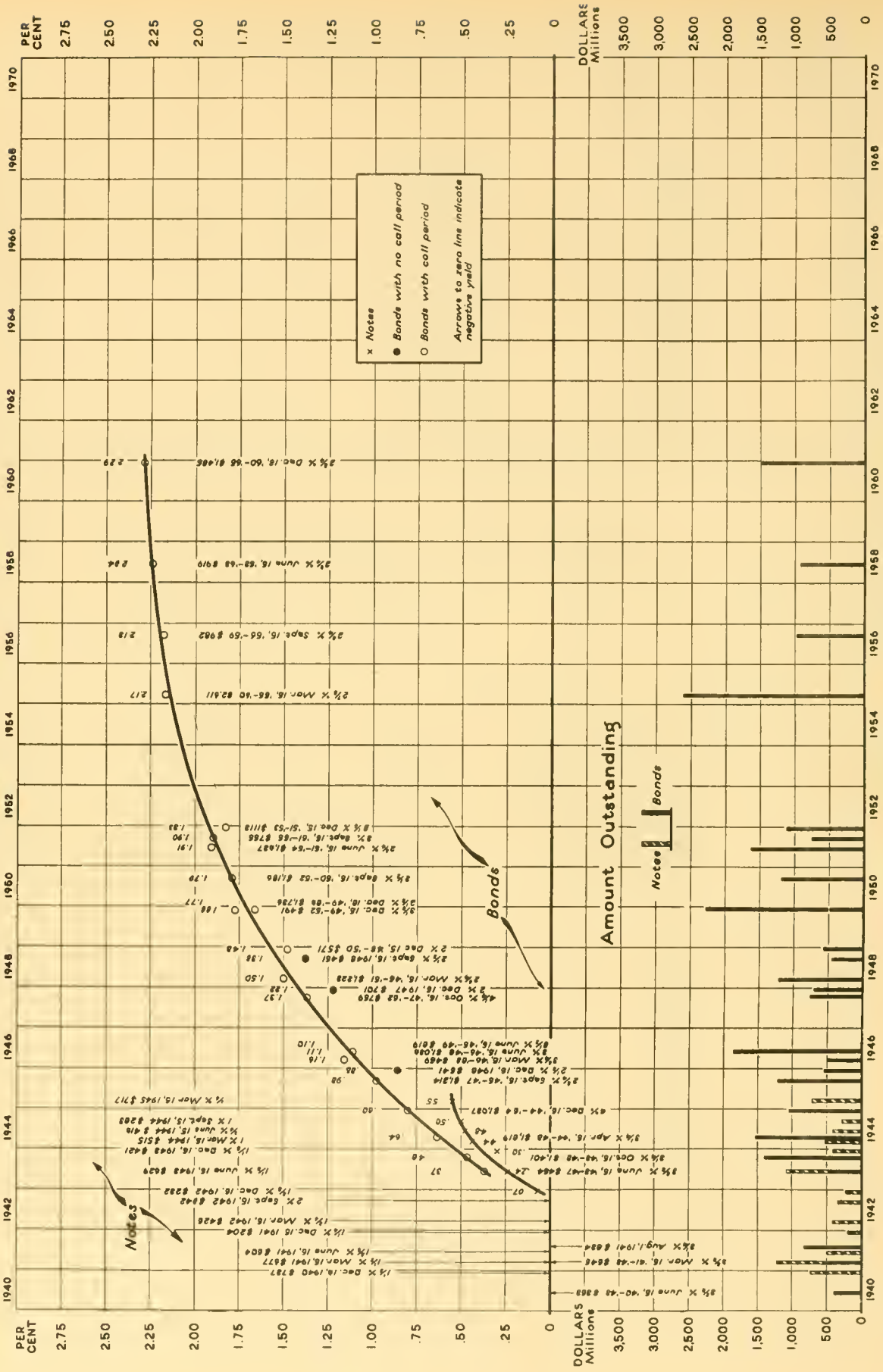
Yields Based on Wednesday Quotations

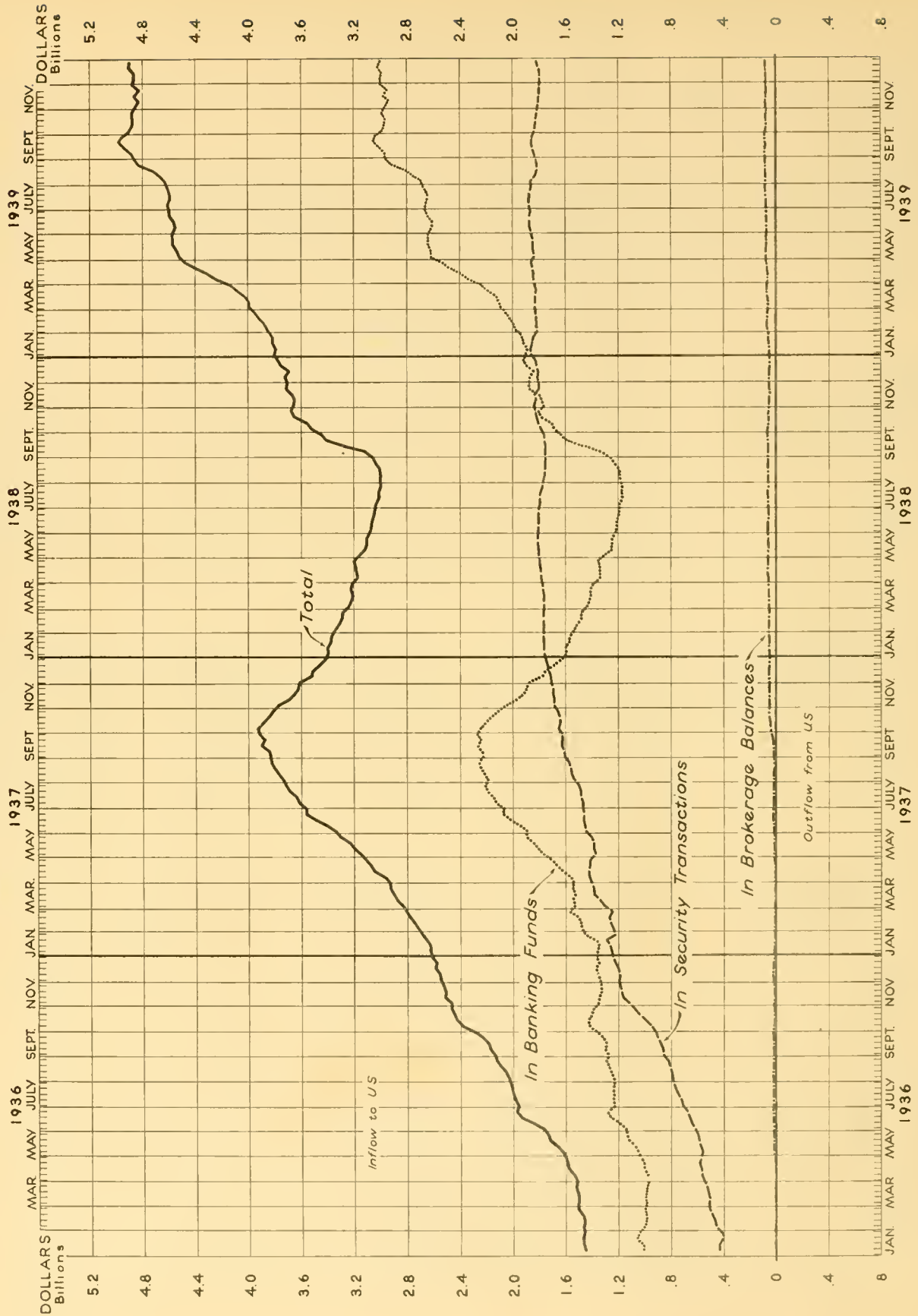

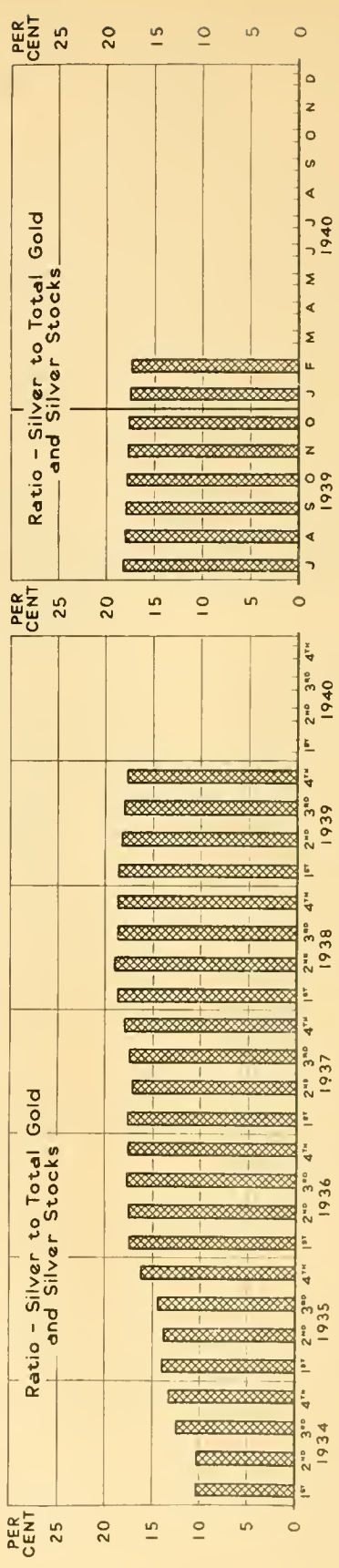
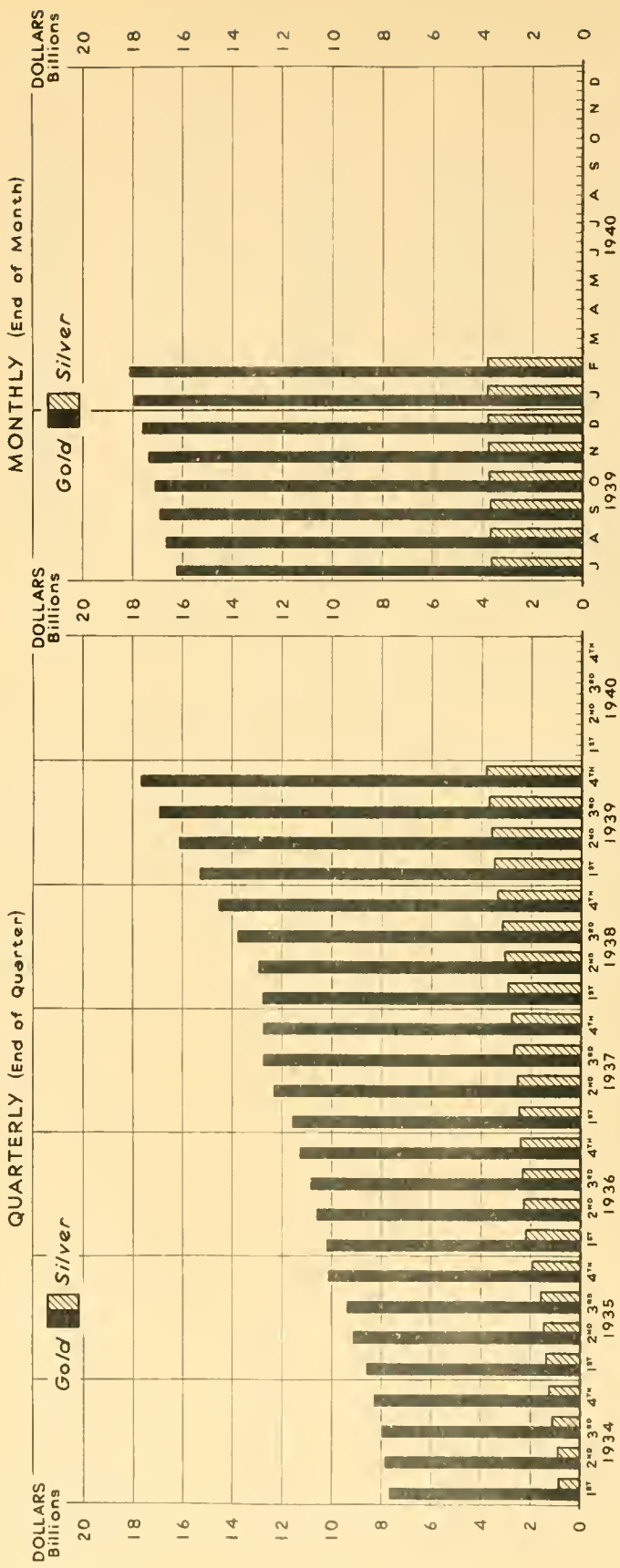
