^{1/} The "Total amount outstanding" of tax-exempt securities of the several borrowers differs from the gross indebtedness of these borrowers in that the former excludes non-interest-bearing debt and taxable interest-bearing debt, both of which are included in the gross indebtedness of the borrowers. The "Total privately-held securities" differs from the net indebtedness of the borrowers in several additional respects. The former is derived by deducting from the total amount of tax-exempt securities outstanding, the amount of all tax-exempt securities held by the United States Government, Federal agencies, Federal Reserve Banks, and by public sinking, trust, and investment funds. Net indebtedness, on the other hand, is derived by deducting from the gross indebtedness an amount equivalent to the total volume of sinking fund assets of the respective borrowers, but makes no allowance for any other public assets.

^{2/} Securities the income from which is exempt from both the normal rates and surtax rates of the Federal income tax.

^{3/} Securities the income from which is exempt only from the normal rates of the Federal income tax. United States savings bonds and Treasury bonds are classified as partially tax-exempt securities although, by statutory provision, interest derived from \$5,000 of principal amount of these securities owned by any single holder is exempt from the surtax rates as well as the normal rates of the Federal income tax.






COLLECTIONS OF INTERNAL REVENUE

MONTHLY July 1939 to Date


YEARLY Fiscal Years 1929 to Date







THE UNITED STATES AND FOREIGN COUNTRIES

Revisions in Statistics on Capital Movements between the United States and Foreign Countries

More complete information on capital movements between the United States and Asia has made it necessary to revise figures covering the "Movements in short-term banking funds" and "Movements in transactions in foreign securities" between this country and Asia. These revisions apply to the period July 27, 1938 through September 4, 1940 and are incorporated in the table showing "Net Capital Movement between the United States and Foreign Countries, 1935 through September 1940" which appears on page 36. Data subsequent to September 4, 1940 reflect the improvement in the statistics.

The additional information affects also the items "Deposits for foreign account" shown in the table on "Short-Term Foreign Liabilities as Reported by Banks and Bankers in the United States for September 1940," pages 38 and 39, and "Loans to foreign banks" shown in the table on "Short-Term Foreign Assets as Reported by Banks and Bankers in the United States for September 1940," pages 40 and 41. Consequently, data for these particular items which have appeared in previous issues of the Bulletin of the Treasury Department are not comparable with the figures shown herein for September. Revisions of these earlier weekly figures will appear in a forthcoming issue of the Bulletin.




