FP 7 1983 Total commercial bank credit (loans plus investments) rose at a 10.6 percent annual rate from May to July, little changed from its growth rate in the first five months of the year. The composition of the growth of bank credit, however, changed markedly over the same period. Total loans accelerated substantially, rising at about a 10 percent rate from May to July, after its 4.8 percent pace earlier in the year. On the other hand, the growth of bank investments slowed, from the rapid 28.6 percent rate in the December-May period to about a 12 percent pace over the last two months. The high rate of banks' acquisition of securities earlier in the year was partly the result of an influx of funds into the new money market deposit accounts, which boosted banks' deposits faster than loan demand.

> From May to July, business, real estate and consumer loans at all commercial banks have risen at a faster pace than earlier in the year (see table). Commercial paper outstanding, an alternative source of short-term business credit, also rose at a faster rate from May to July than earlier in the year.


> Business loans at weekly reporting, large commercial banks, however, changed little from last December to May, then increased from May to July at a 4.3 percent pace. Thus, the greater lending to businesses occurred primarily at small and medium-sized banks.

ADJUSTED MONETARY BASE AVERAGES OF DAILY FIGURES SEASONALLY ADJUSTED BY THIS BANK









MONEY STOCK (M1) AVERAGES OF DAILY FIGURES SEASONALLY ADJUSTED




