The money stock (M1) rose at an annual rate of 8.1 percent during the first six months of 1984. In comparison, it grew at a slower 5.7 percent pace during the last six months of 1983. Thus, on a monthly average basis, M1 growth has been more rapid during the first half of 1984.

A comparison of quarterly growth rates, however, reveals essentially no change in the growth of M1. M1 increased at an annual rate of 7.3 percent from the second quarter of 1983 to the fourth quarter of 1983, then rose at a 6.8 percent from the fourth quarter of 1983 to the second quarter of 1984. This recent growth is well within the 4-8 percent target range adopted by the Federal Open Market Committee from the fourth quarter of 1983 to the fourth quarter of 1984. Also, the recent quarterly growth in M1 has resulted in little change in its trend rate of growth (12-quarter moving average), as shown in the table below.












TOTAL CHECKABLE DEPOSITS V AVERAGES OF DAILY FIGURES SEASONALLY ADJUSTED






