

Interest rates on Treasury securities of all maturities declined by about 300 basis points from mid-1984 to mid-1985. Since June 1985, the rate on threemonth bills has been virtually unchanged while yields on other Treasury securities have declined further, resulting in a substantial flattening of the yield curve. As the table below shows, the narrowing of the interest rate spreads has occurred primarily since the end of September and has been most prominent in the yields on longer-term Treasury securities. In particular, the 5-year and long-term Treasury securities have each narrowed their spreads with the three-month rate by more than 150 basis points.

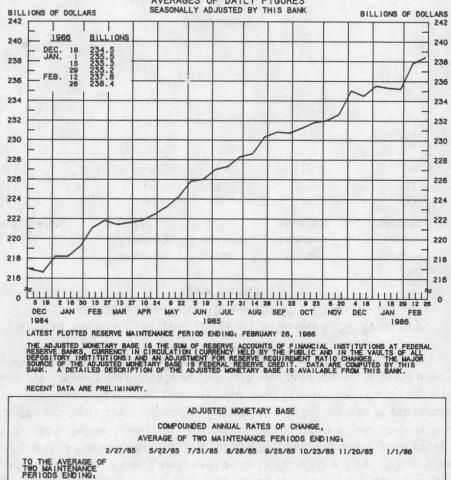
