THE WEEK'S HIGHLIGHTS:

- The most recent monthly average numbers show that the growth rates of each of the three monetary aggregates—M1, M2 and M3—have slowed sharply in the two months ending in March of this year.
- ✓ M1 grew at a 1.3 percent annual rate over this period, after rising 17.3 percent in the prior 12 months.
- M2 rose at a 0.8 percent annual rate in the past two months, after rising 9.6 percent in the previous 12 months. M3 growth slowed to a 1.6 percent rate in the two months ending in March, after rising at a 9 percent rate in the previous 12 months.
- Real GNP rose at a 4.3 percent annual rate in the first quarter of 1987, up from a 2 percent growth rate in the prior four quarters. The GNP deflator rose in a similar fashion, growing at a 3.5 percent rate in the first quarter of 1987, compared with 2.1 percent growth in the prior four quarters.












COMMERCIAL BANK TOTAL TIME DEPOSITS AVERAGES OF DAILY FIGURES SEASONALLY ADJUSTED


