


THE WEEK'S HIGHLIGHTS:

- Business loans at weekly reporting large commercial banks rose slightly over the two weeks ending August 19, after declining for most of this year. In the latest four-week period, business loans were 4 percent higher than a year earlier.
- ✓ New single-family home sales rose at a 9.7 percent annual rate from May to July. In the first seven months of this year, sales were 10.8 percent lower than in the same period of 1986.
- ✓ The composite index of leading indicators rose 0.5 percent in July. The index has risen at a 9.6 percent annual rate since May, up from a 5.6 percent rate of advance in the first five months of this year.
- ✓ New factory orders fell 0.2 percent in July, the first decline since January of this year.
- Manufacturing productivity rose at a revised 4.9 percent rate in the second quarter of this year, which was 3.4 percent higher than a year earlier.


