## THE WEEK'S HIGHLIGHTS:

- The nation's real gross national product rose at a 2.2 percent annual rate in the third quarter, following a 3.2 percent rate of increase in the first half of 1988.
- Prices, as measured by the GNP deflator, rose at a 4.4 percent rate in the third quarter, after rising at a 3.6 percent rate during the first half of the year.
- New factory orders for durable goods fell 0.3 percent in the third quarter, but were up 5.7 percent from the fourth quarter of 1987.
- Consumer prices (CPI) rose at a seasonally adjusted rate of 4.1 percent in September compared with a 5.2 percent rate in July and August. The CPI has risen at a 4.5 percent rate thus far in 1988.
- The trade-weighted value of the dollar has declined 4.6 percent since mid-August, following a 9.6 percent increase during the previous three months.





















