THE WEEK'S HIGHLIGHTS:

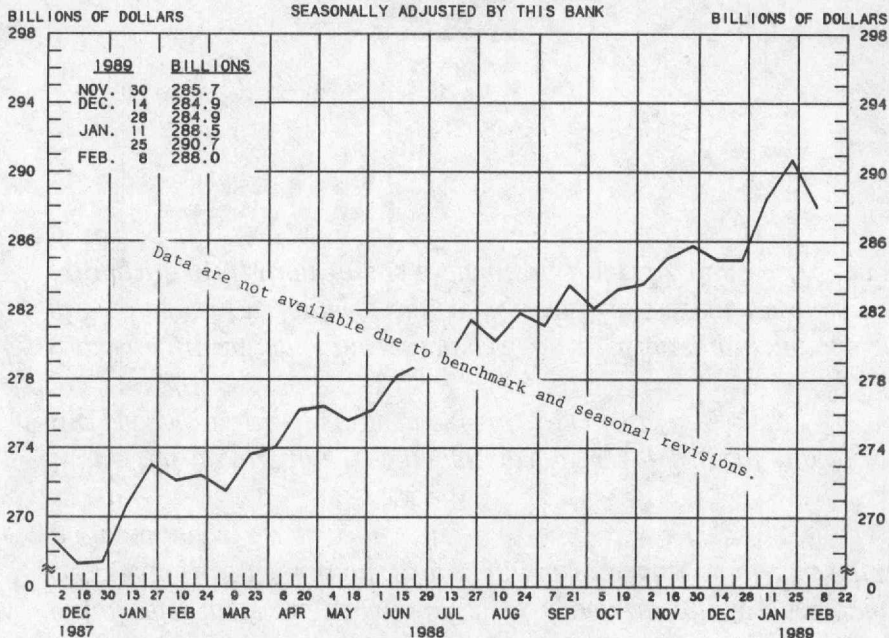
- ✓ *Producer prices, seasonally adjusted, increased at a 12.7 percent annual rate in January, reflecting sharp increases in the prices of energy goods and consumer foods. Producer prices are up 4.3 percent from a year earlier. Excluding energy and food, producer prices rose at a 5.1 percent annual rate in January.*
- ✓ *Retail sales increased in January at a 6.8 percent rate to a seasonally adjusted \$138.91 billion. Since January 1988, retail sales have increased at a 7.7 percent rate.*
- ✓ *Industrial production rose in January at a 4.4 percent rate. Over the past year, production increased 5 percent.*
- ✓ *Capacity utilization of the nation's factories, utilities and mines stood at 84.4 percent in January, compared with 82.5 percent a year earlier. January's utilization rate is unchanged from the revised December figure.*

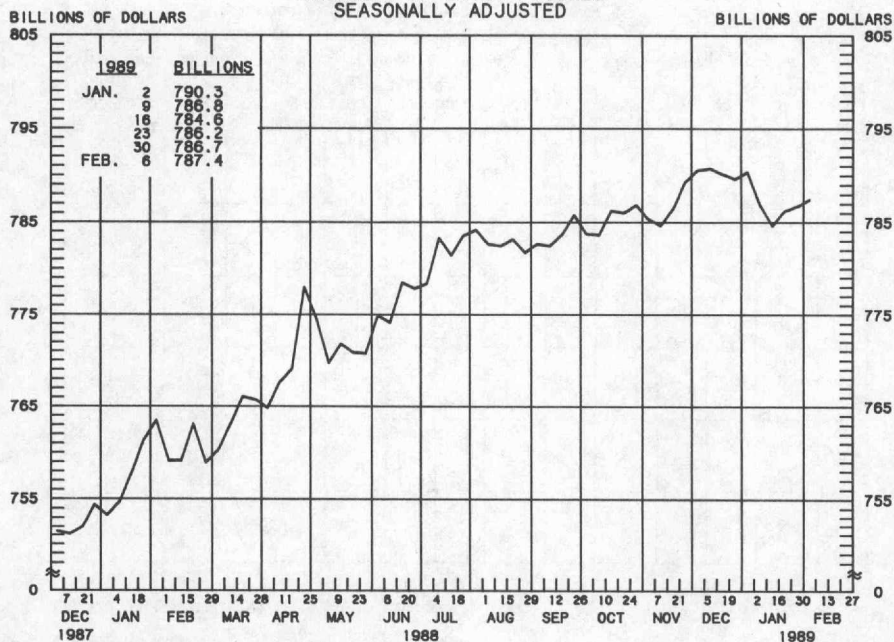

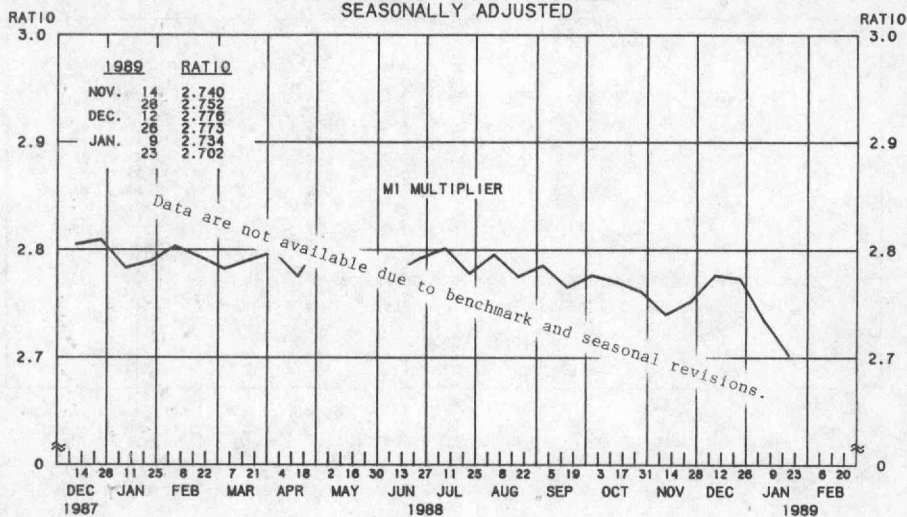

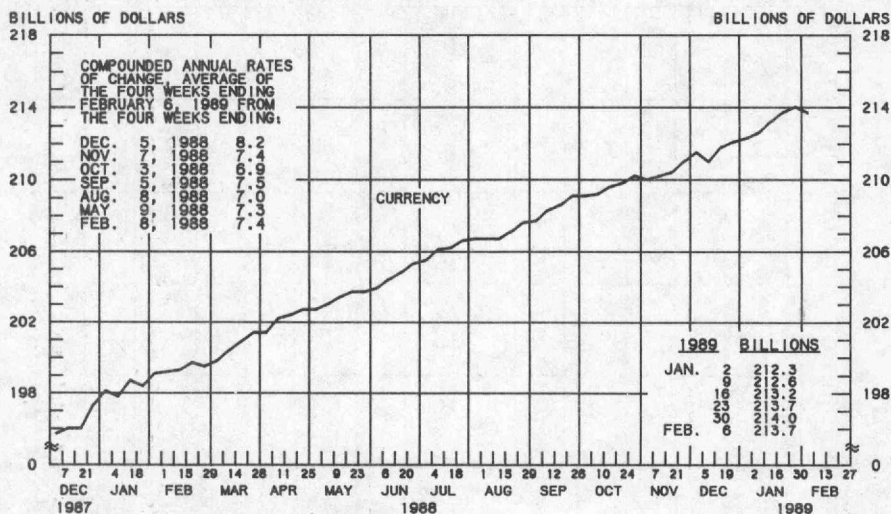

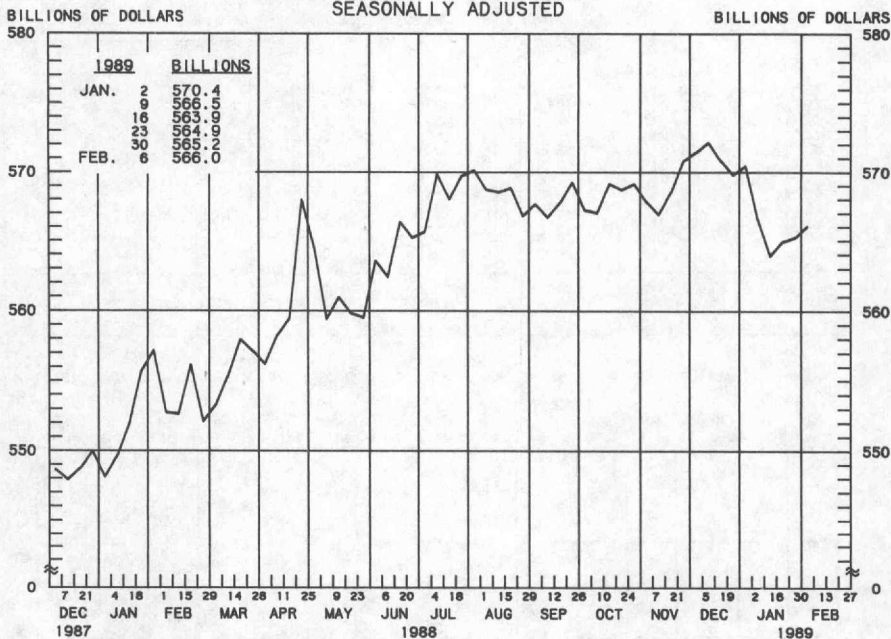

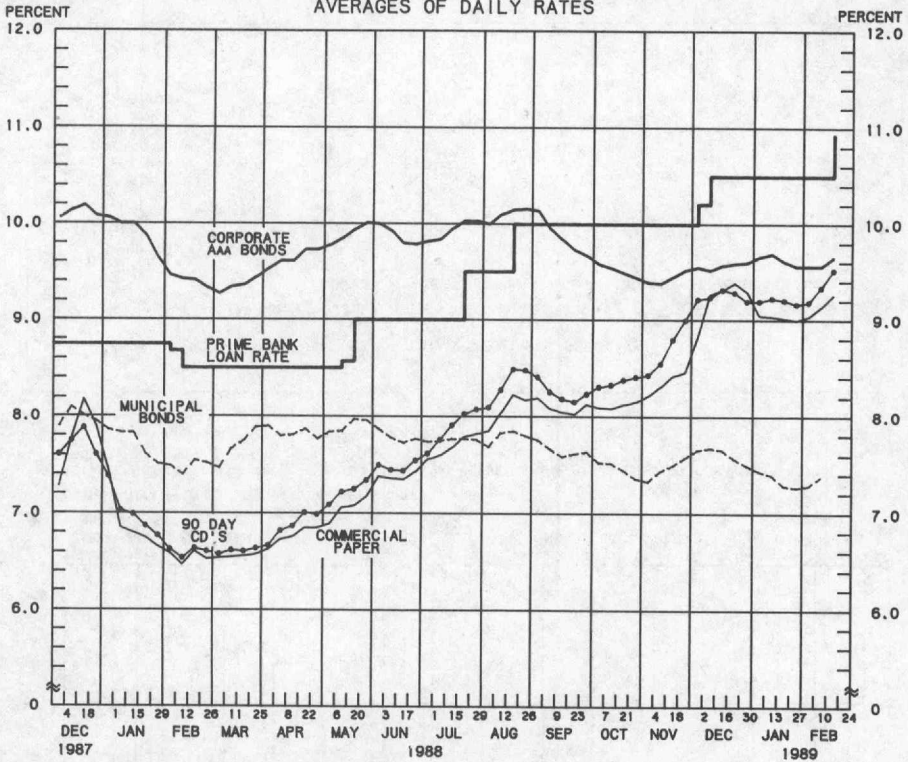

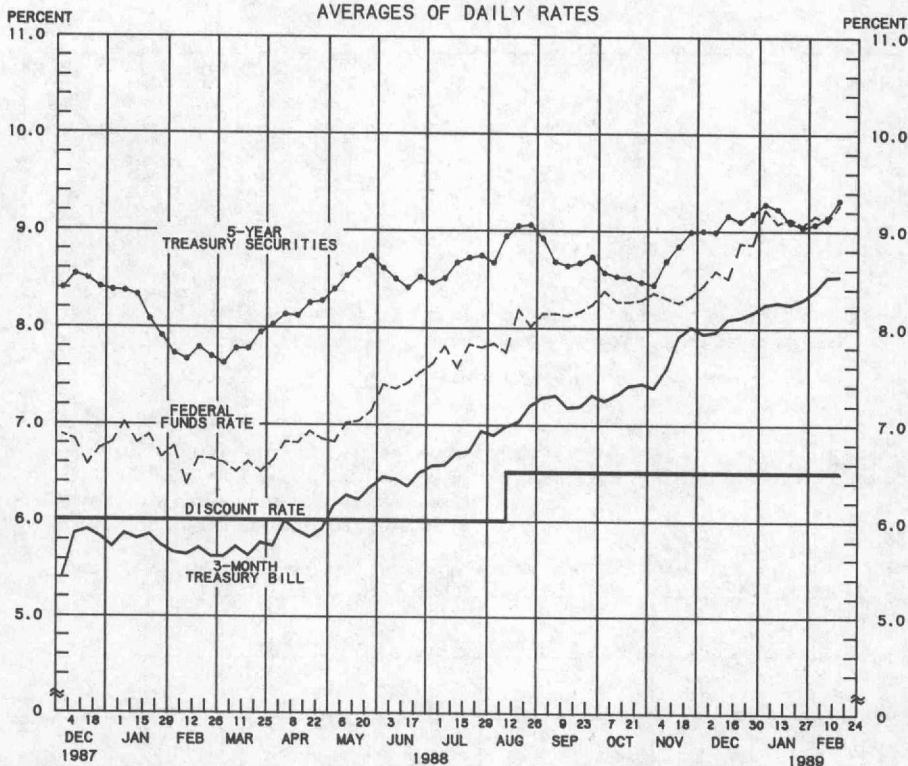

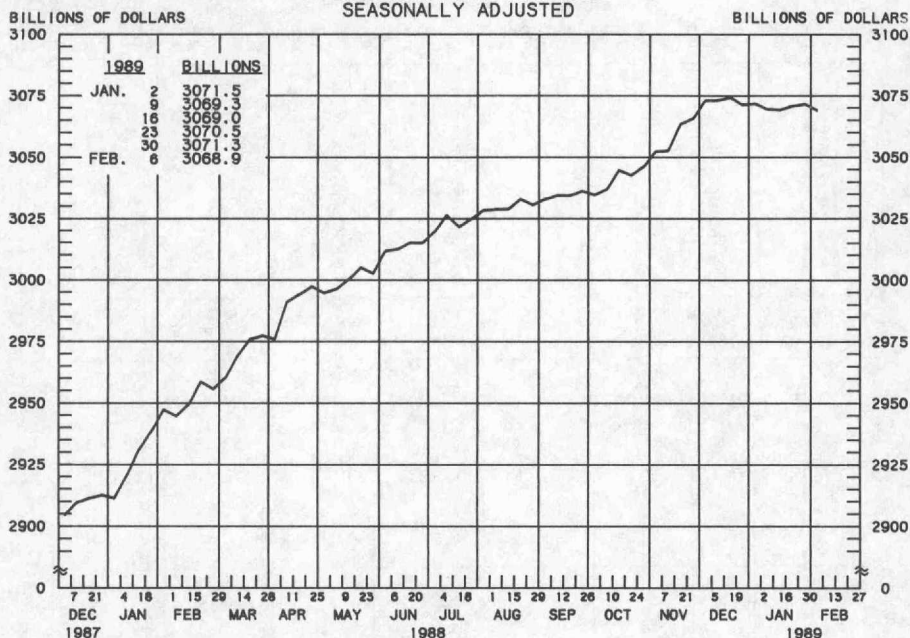

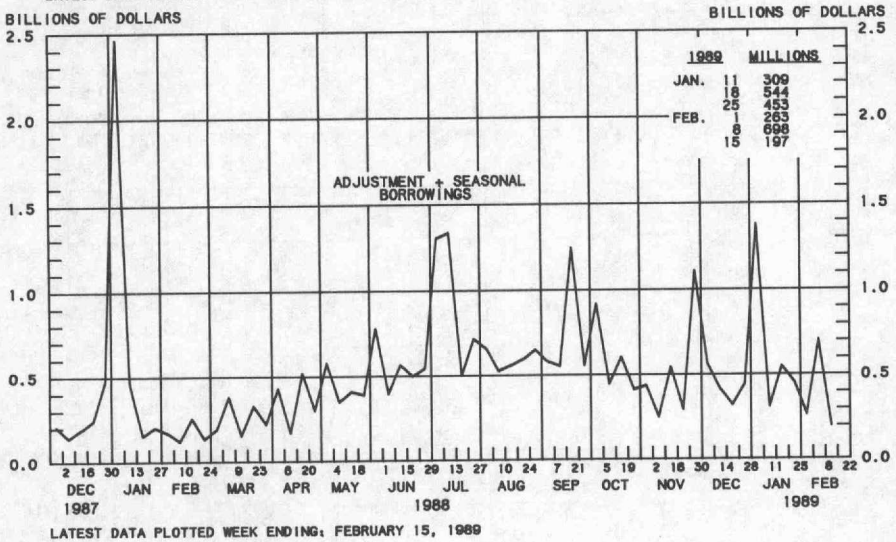
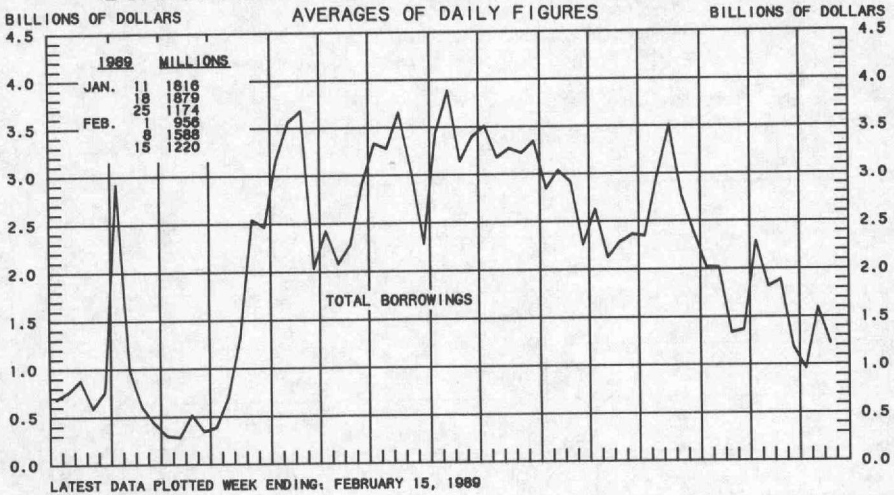

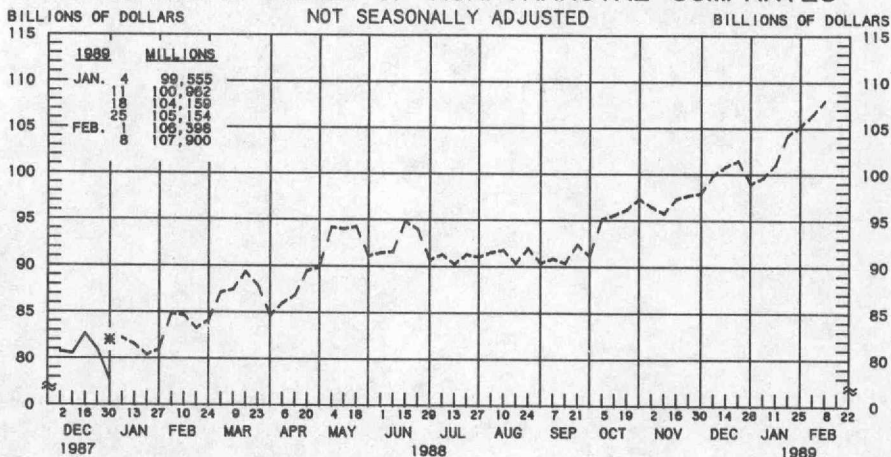

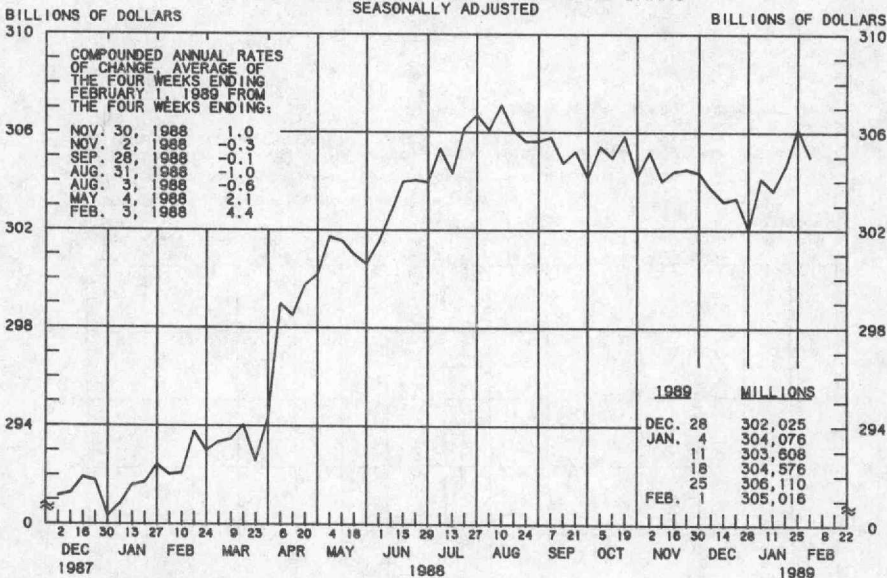
COMMERCIAL PAPER OF NONFINANCIAL COMPANIES

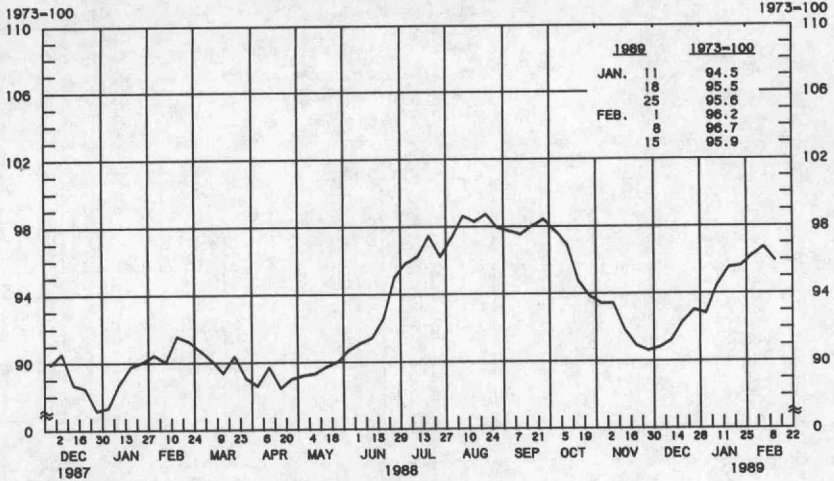
