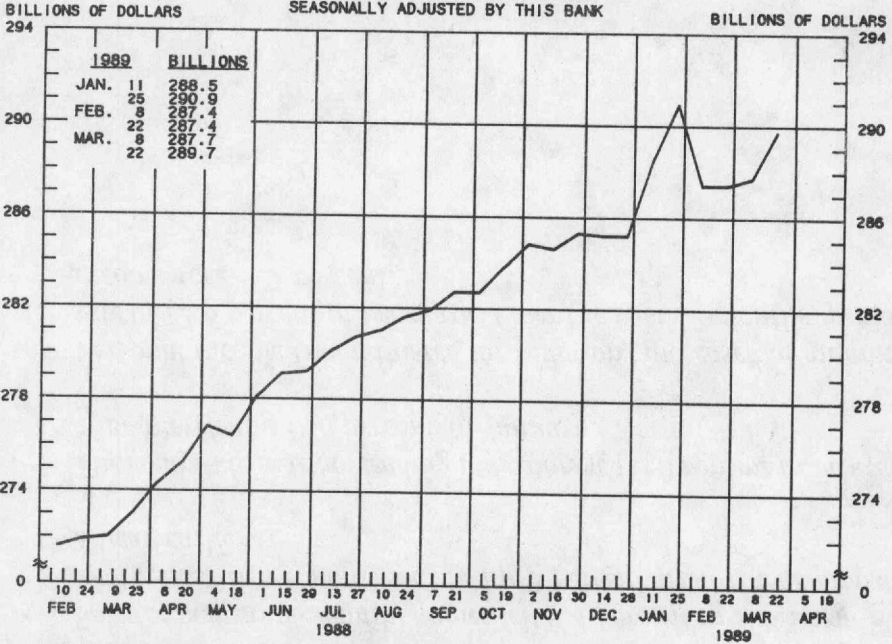

THE WEEK'S HIGHLIGHTS:

- ✓ *The M1 money stock grew at a 1.3 percent annual rate from the four weeks ending September 19, 1988, to the four weeks ending March 20. From the four weeks ending March 21, 1988, to September 19, 1988, M1 grew at an annual rate of 5.5 percent.*
- ✓ *Sales of new single-family homes fell 9.4 percent in February. Sales for the last three months were up 9 percent from the same period a year earlier.*
- ✓ *The composite index of leading indicators fell 0.3 percent in February, after increasing 0.7 percent in January.*
- ✓ *Personal income (not adjusted for inflation) increased at an annual rate of 12.6 percent in February. Over the past 12 months, personal income rose 9.3 percent.*

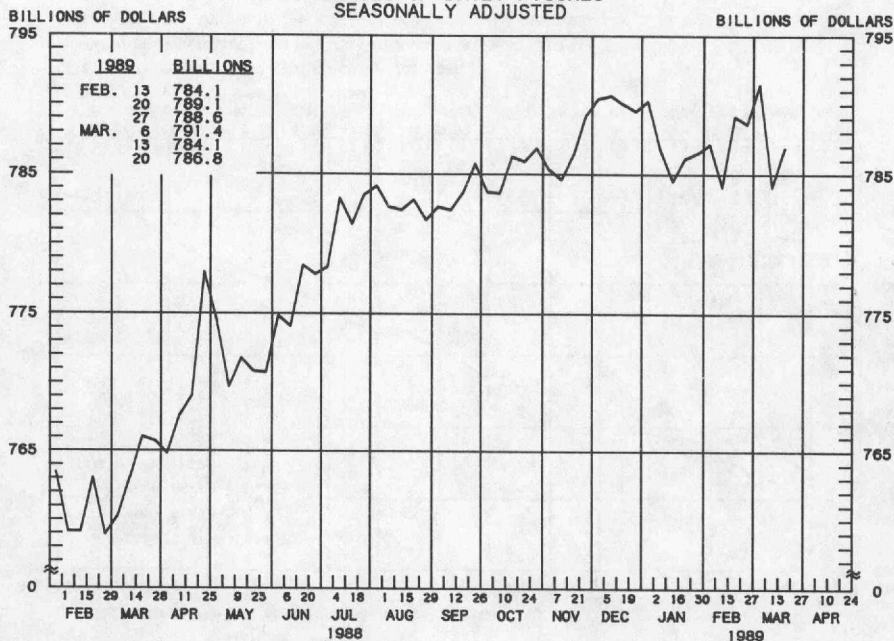

THE MAJOR SOURCE OF THE ADJUSTED MONETARY BASE IS FEDERAL RESERVE CREDIT. DATA ARE COMPUTED BY THIS BANK. A DETAILED DESCRIPTION OF THE ADJUSTED MONETARY BASE IS AVAILABLE FROM THIS BANK.

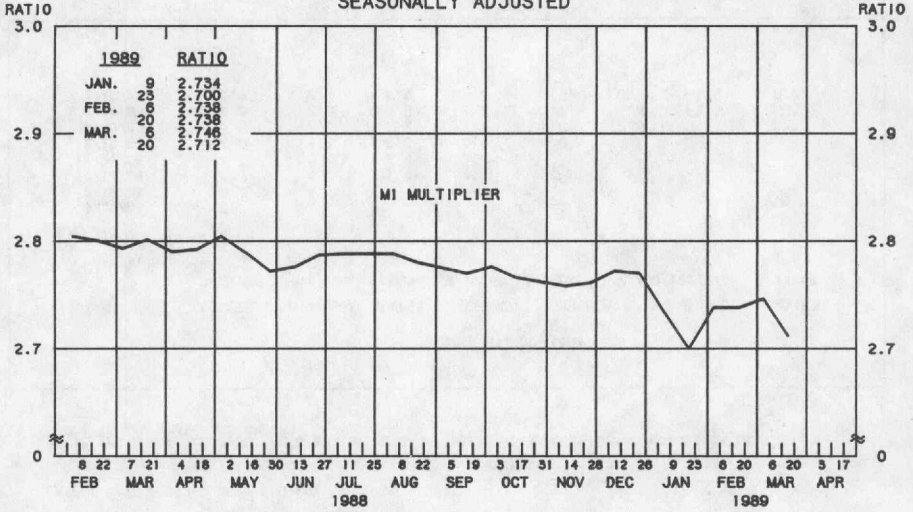

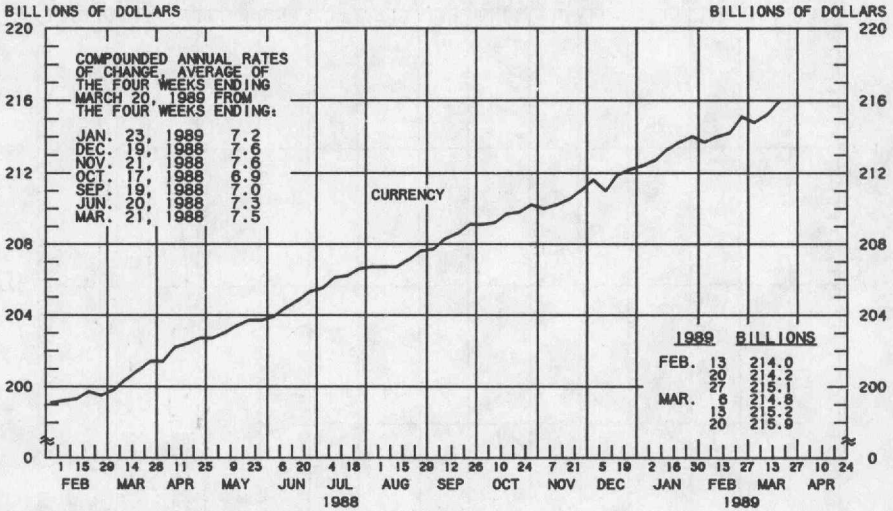

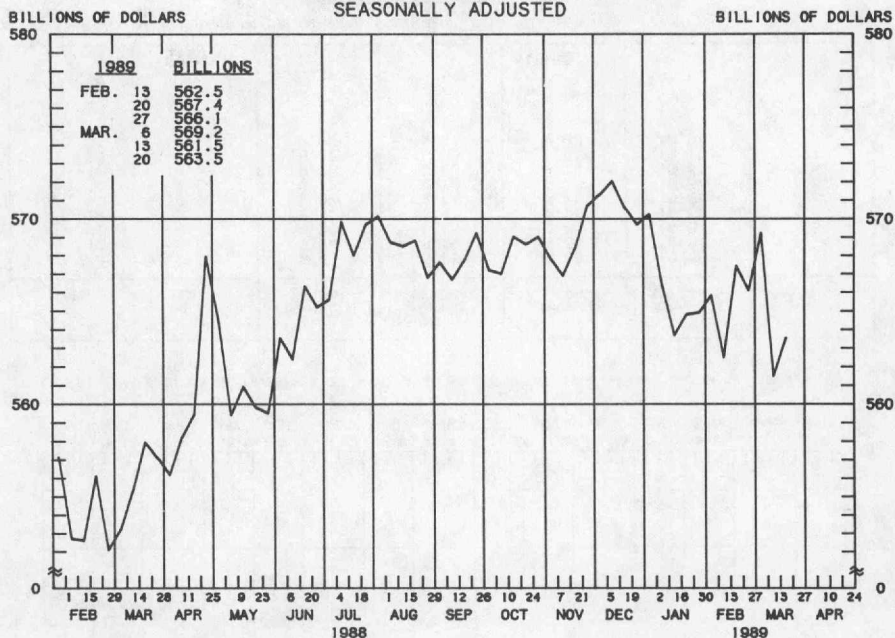

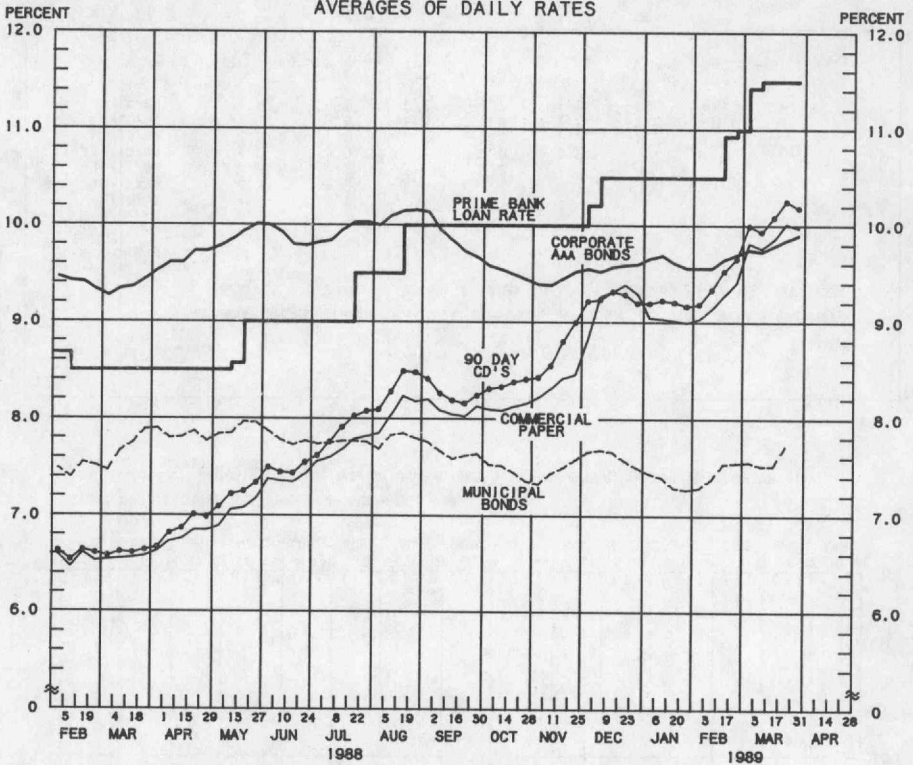

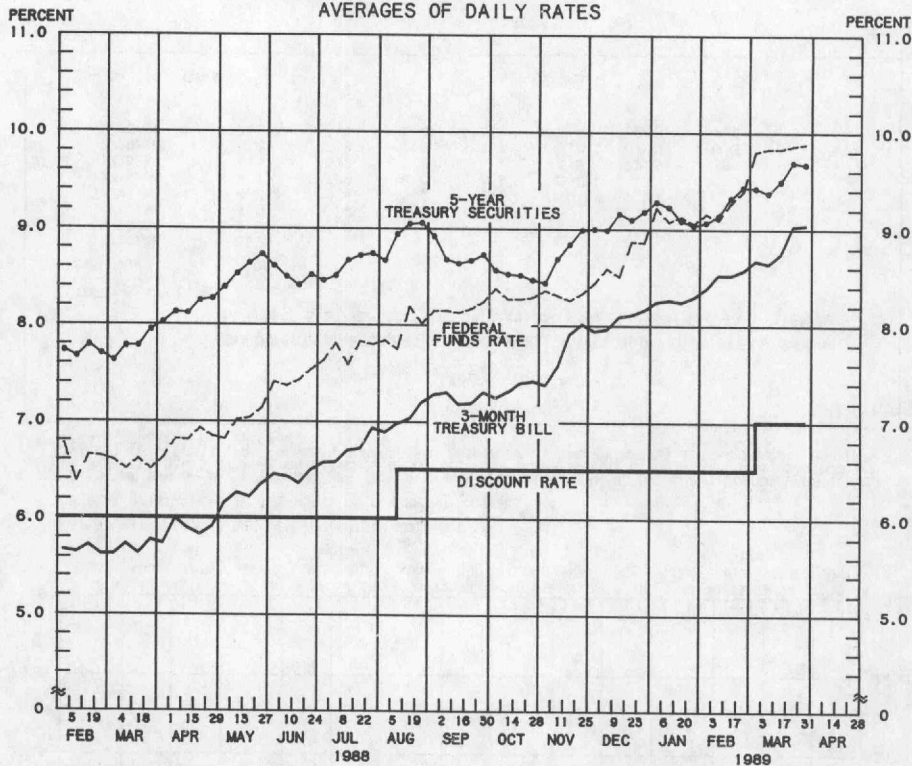

SELECTED INTEREST RATES AVERAGES OF DAILY RATES



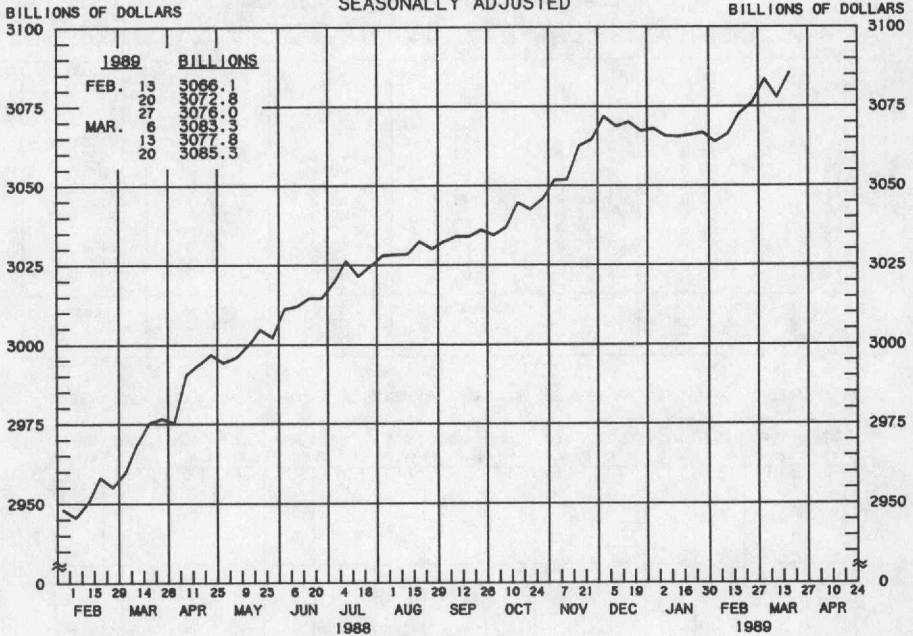

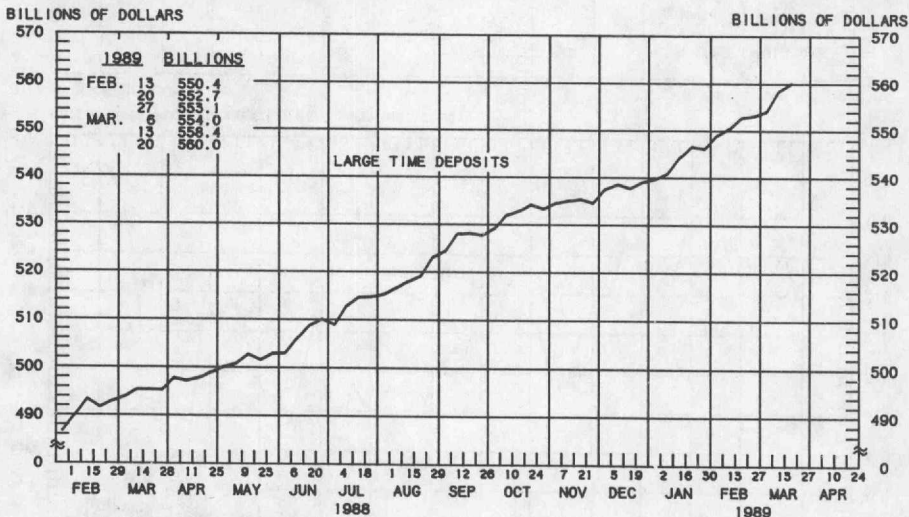

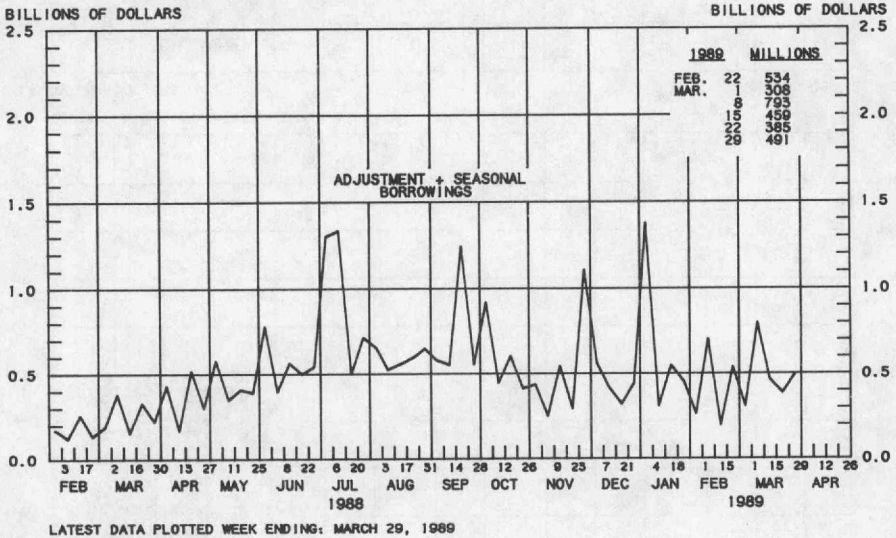
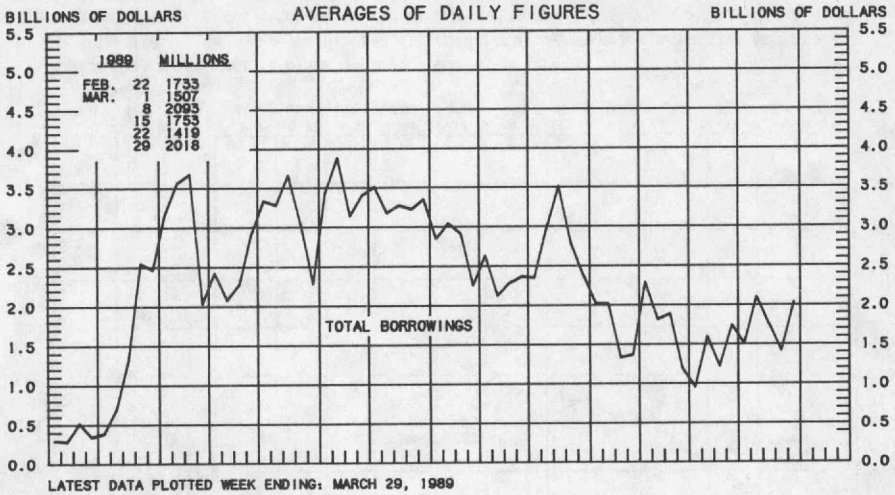

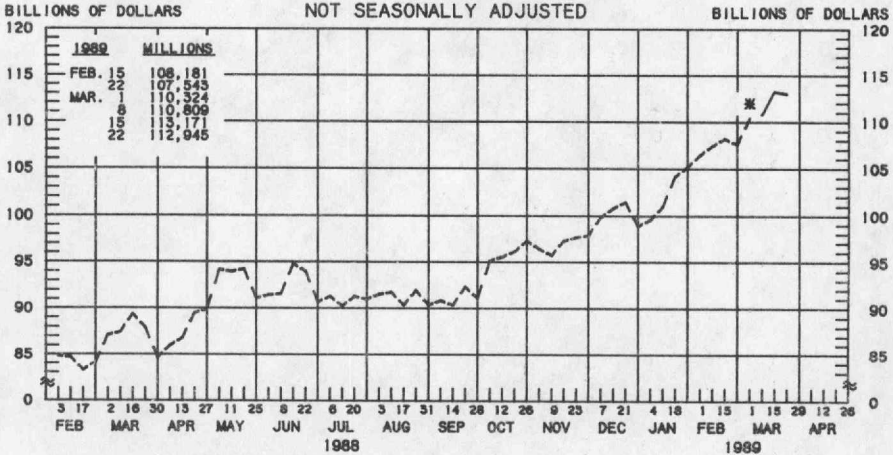

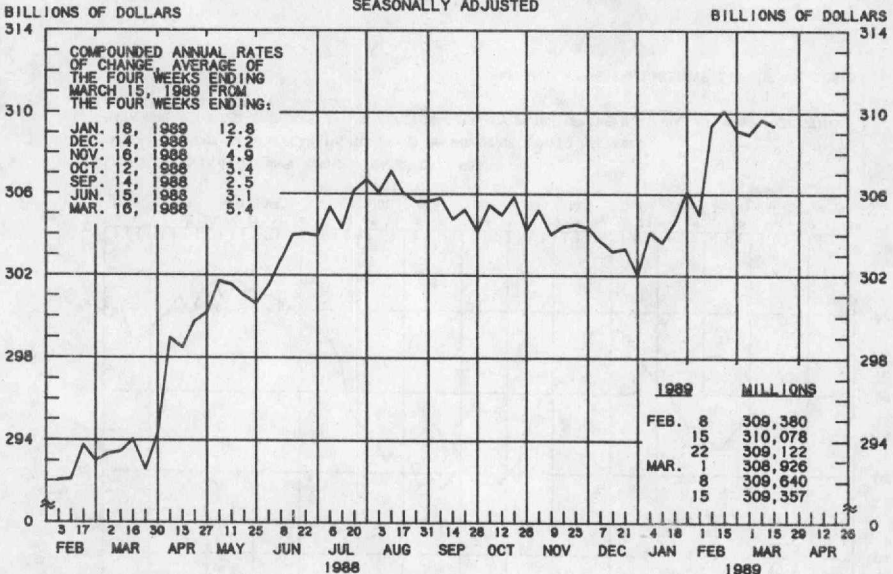
COMMERCIAL PAPER OF NONFINANCIAL COMPANIES

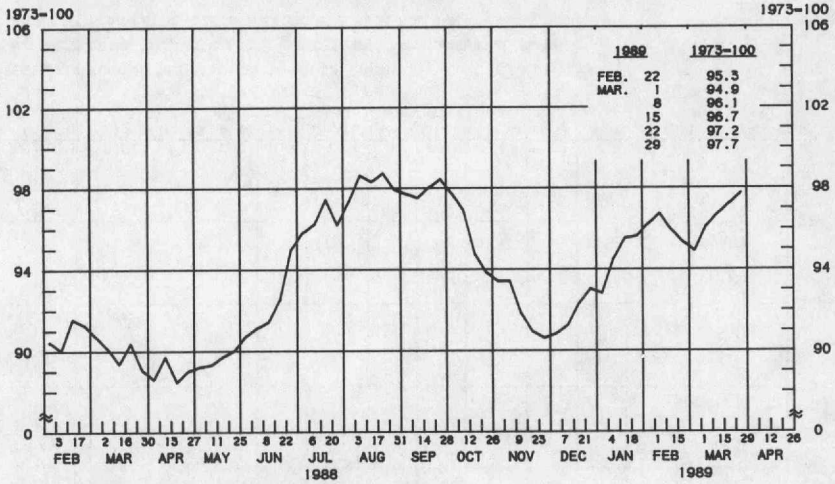
