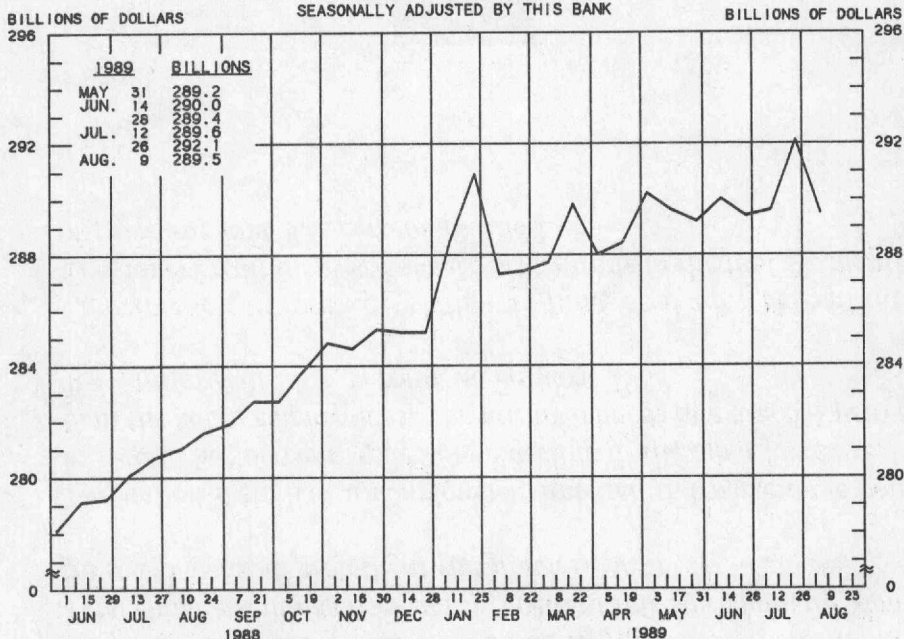

THE WEEK'S HIGHLIGHTS:

- ✓ Payroll employment rose 169,000 in July, a 1.9 percent annual rate of increase. Since January, payroll employment has increased at a 2.4 percent rate, down from a 3.3 percent increase in the previous year.
- ✓ Total civilian employment fell 82,000 in July, a 0.8 percent rate. Total employment has risen at a 1.3 percent rate since January, down from 2.3 percent growth in the previous year.
- ✓ The nation's civilian unemployment rate fell 0.1 percentage point in July to 5.2 percent, reflecting a decline in the labor force greater than the fall in employment. The unemployment rate was 5.4 percent last January and 5.8 percent in January 1988.
- ✓ Consumer credit rose \$2.99 billion in June, or at a 5.3 percent rate. Consumer credit increased at a 13 percent rate in the first six months of this year and 8.5 percent in 1988.

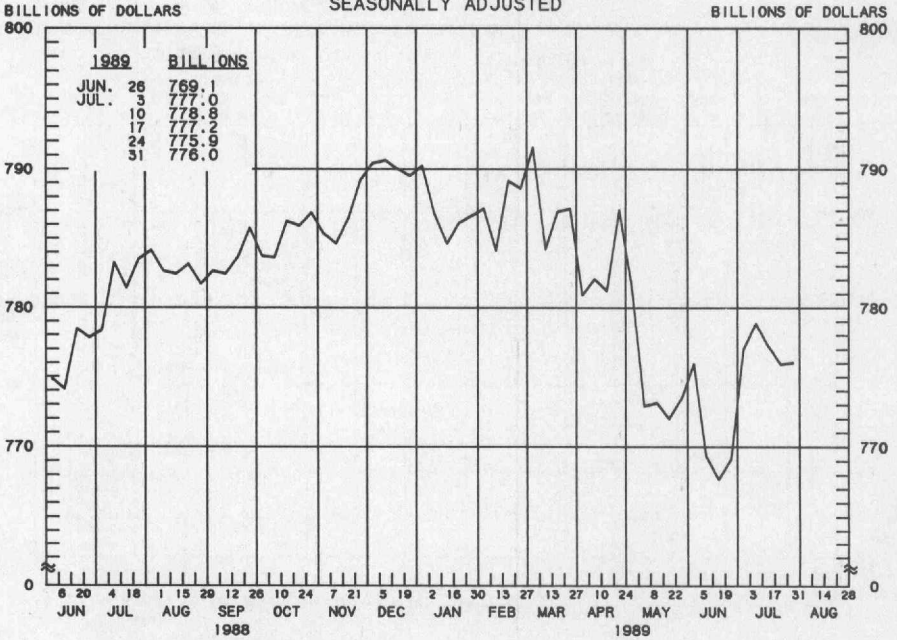

THE MAJOR SOURCE OF THE ADJUSTED MONETARY BASE IS FEDERAL RESERVE CREDIT. DATA ARE COMPUTED BY THIS BANK. A DETAILED DESCRIPTION OF THE ADJUSTED MONETARY BASE IS AVAILABLE FROM THIS BANK.

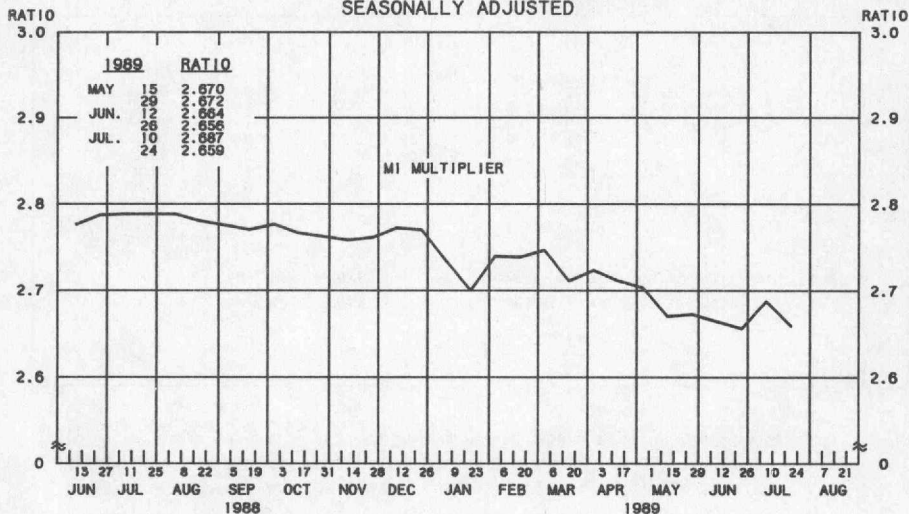

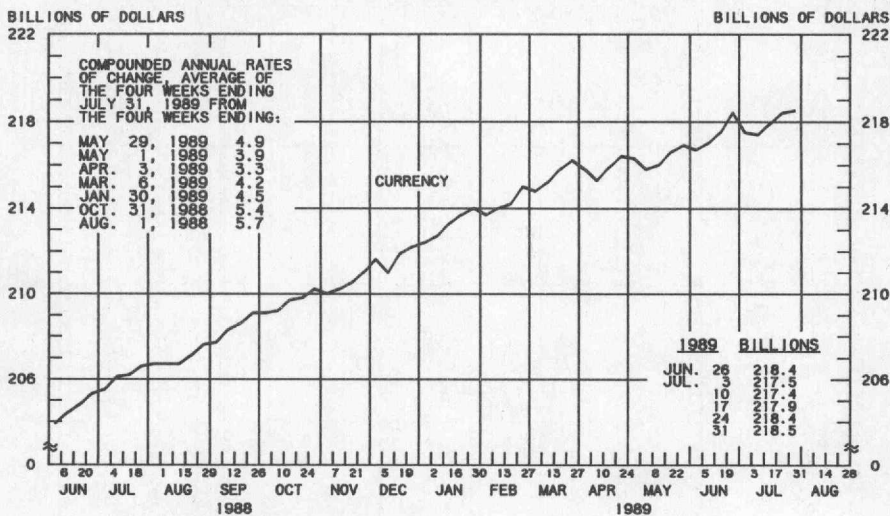

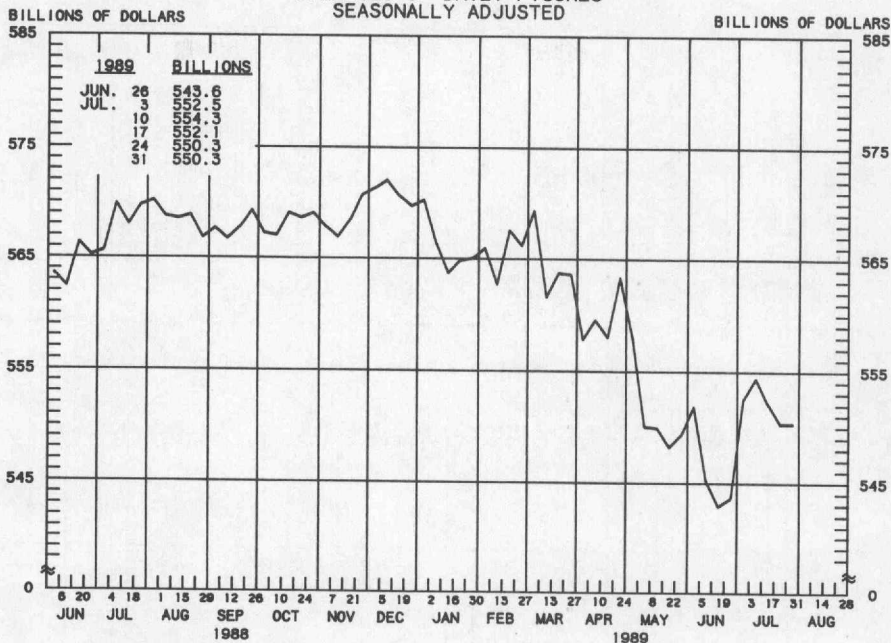

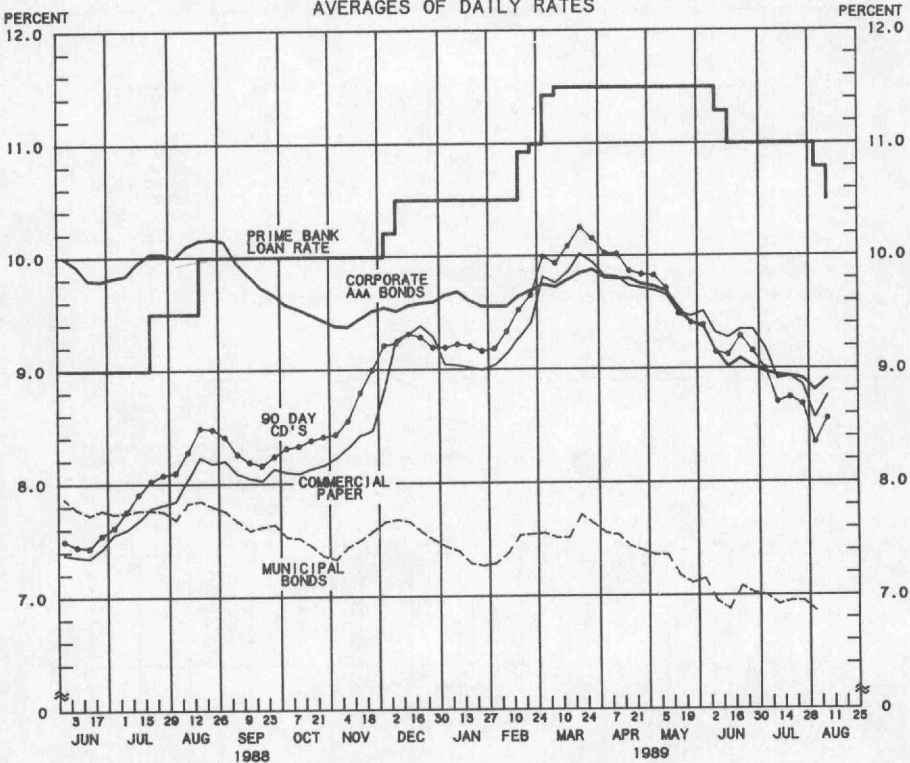

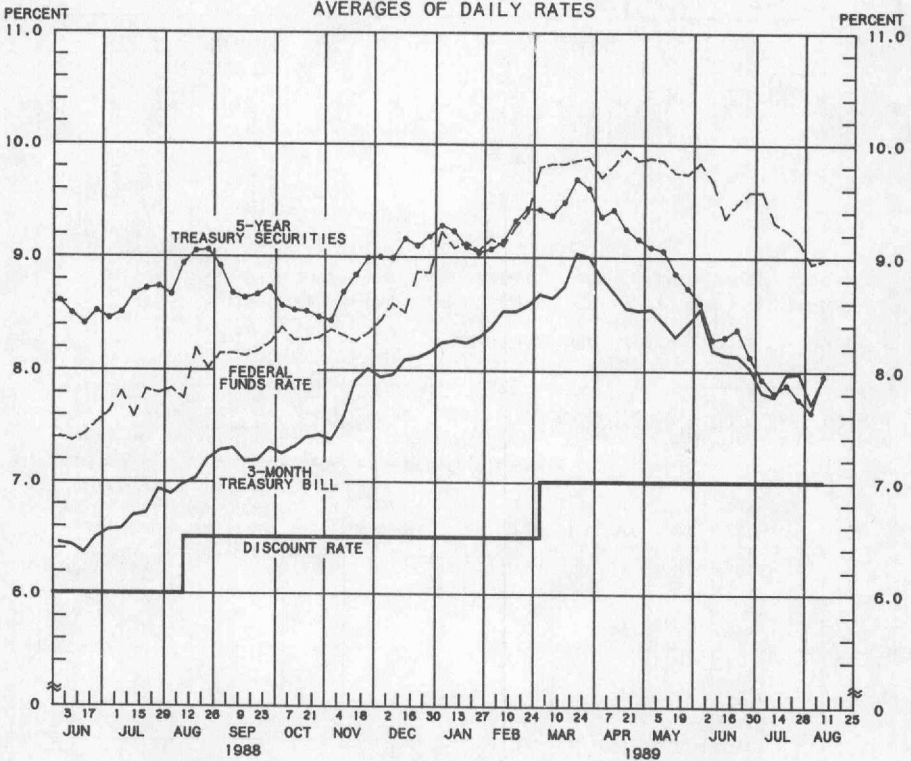

SELECTED INTEREST RATES AVERAGES OF DAILY RATES



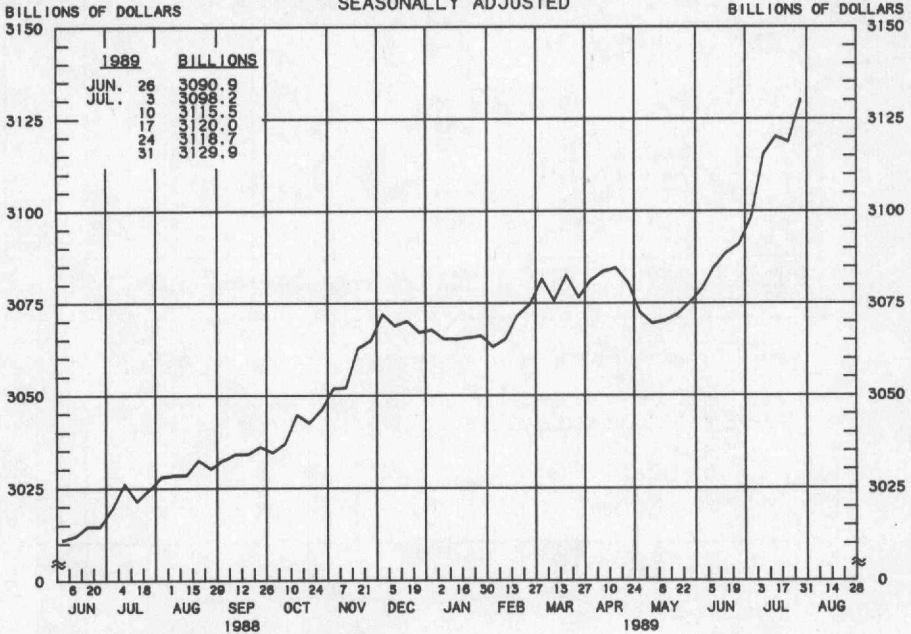

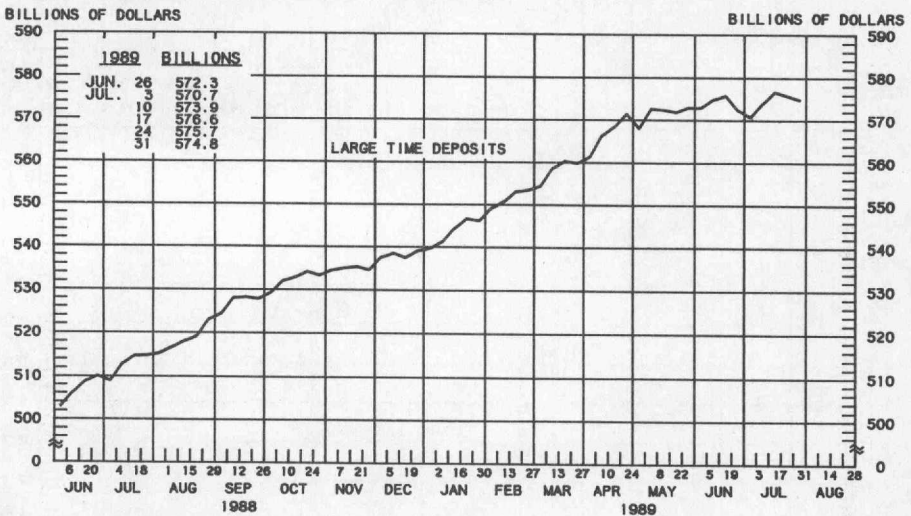

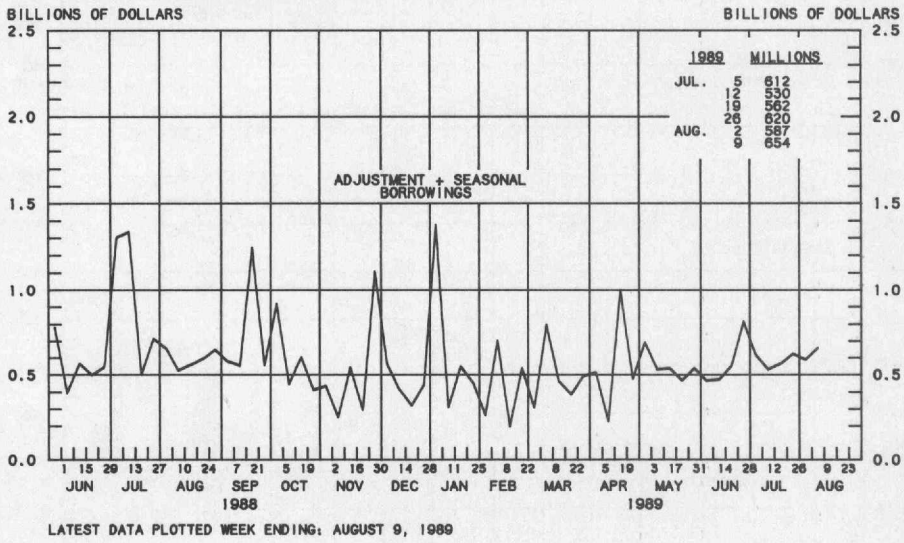
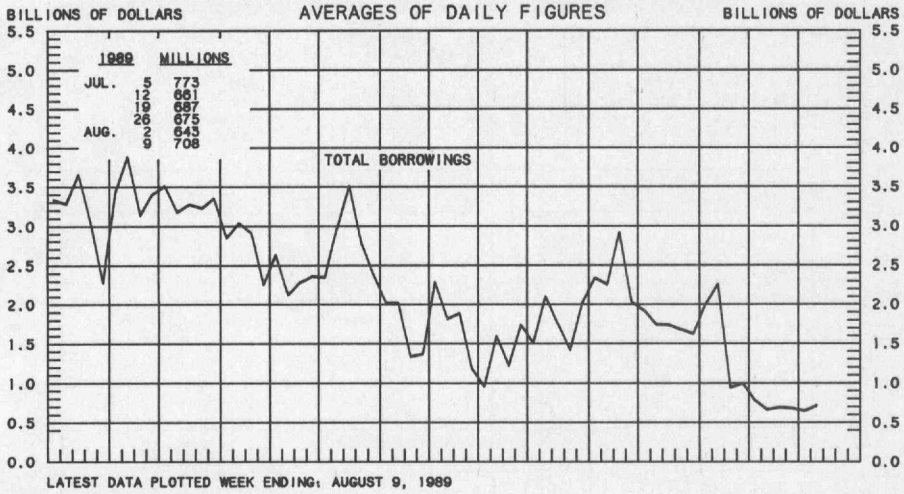

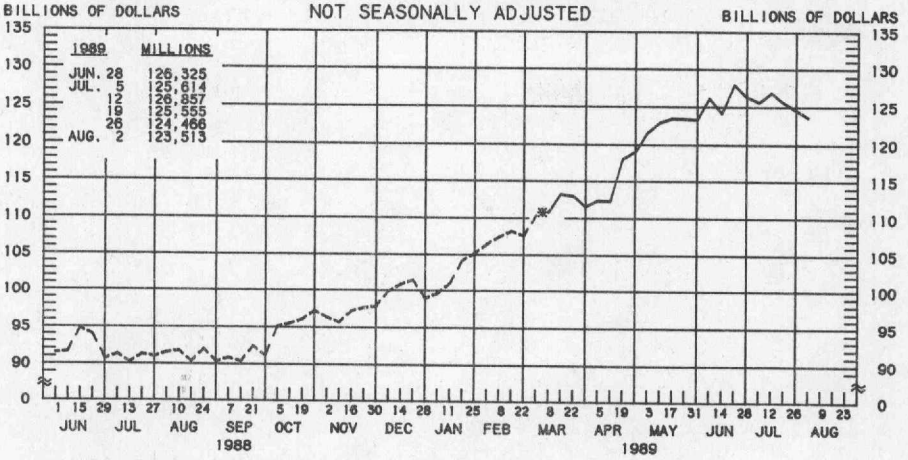

BORROWINGS FROM FEDERAL RESERVE BANKS



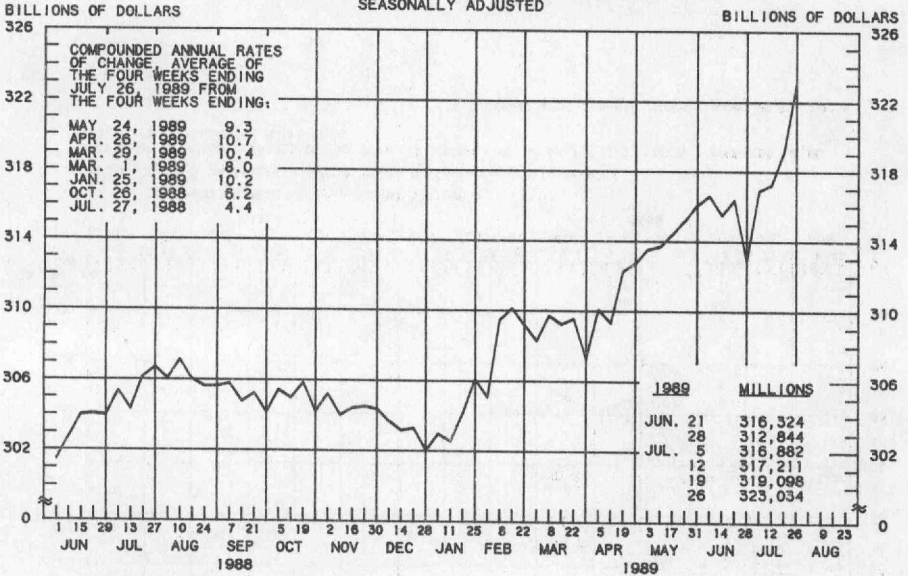

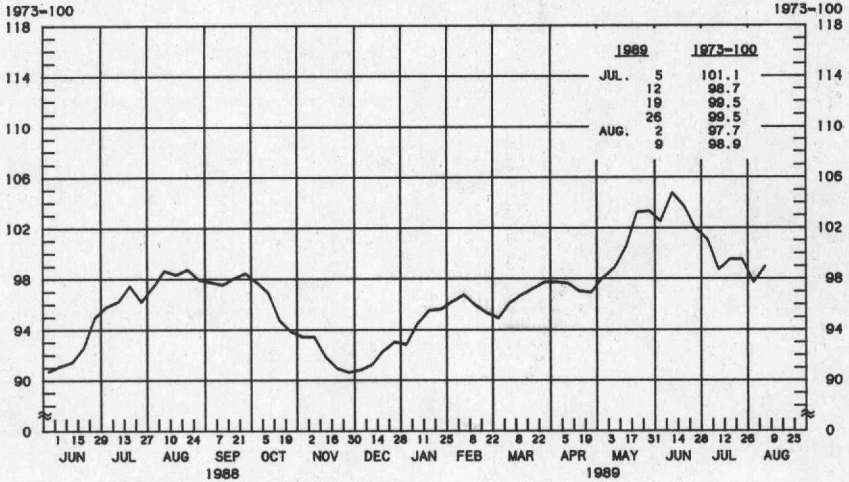
