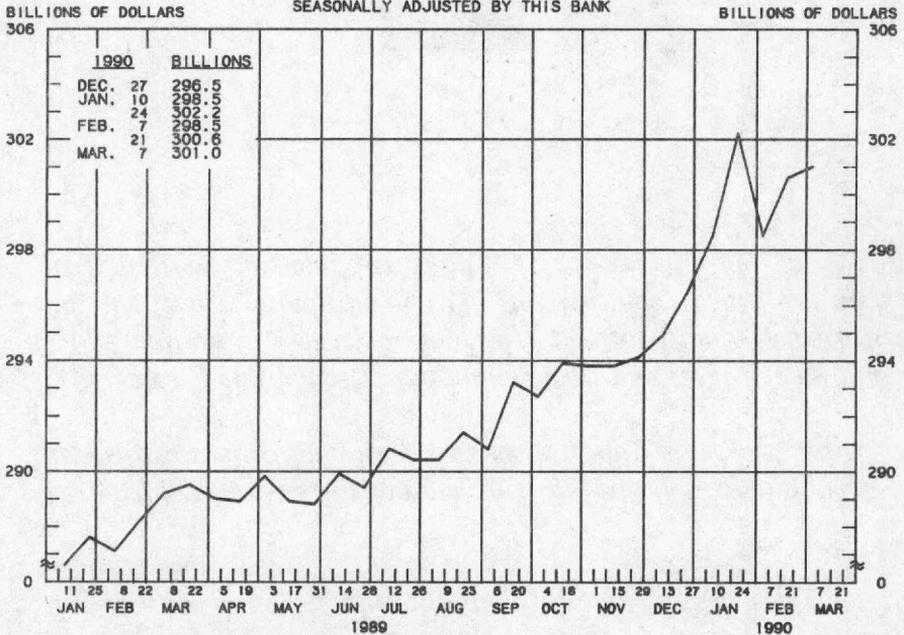
## THE WEEK'S HIGHLIGHTS:

- ✓ *The adjusted monetary base has grown at a 6.8 percent annual rate during the past six months, compared with a 1.7 percent rate of increase during the previous six months.*
- ✓ *The yield on 90-day certificates of deposit averaged 8.28 percent for the week ending March 9, up slightly from 8.13 percent in early January, but down significantly from the 1989 peak of 10.26 percent about a year ago.*
- ✓ *Large time deposits (denominations of \$100,000 or more) at all depository institutions have declined steadily since last July.*
- ✓ *U.S. sales of all (domestic and import) cars and light trucks totaled 1.054 million in February, down 4.7 percent from a year earlier. For the first two months of 1990, total vehicles sold were up 1.3 percent from the same period in 1989.*

LATEST PLOTTED RESERVE MAINTENANCE PERIOD ENDING: MARCH 7, 1990

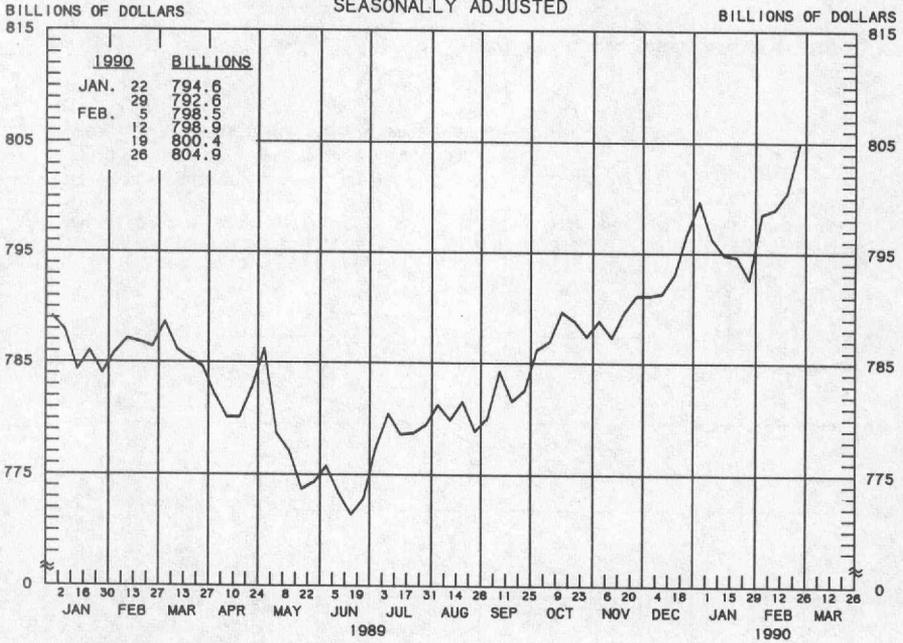
THE ADJUSTED MONETARY BASE IS THE SUM OF RESERVE ACCOUNTS OF FINANCIAL INSTITUTIONS AT FEDERAL RESERVE BANKS, CURRENCY IN CIRCULATION (CURRENCY HELD BY THE PUBLIC AND IN THE VAULTS OF ALL DEPOSITORY INSTITUTIONS) AND AN ADJUSTMENT FOR RESERVE REQUIREMENT RATIO CHANGES. THE MAJOR SOURCE OF THE ADJUSTED MONETARY BASE IS FEDERAL RESERVE CREDIT. DATA ARE COMPUTED BY THIS BANK. A DETAILED DESCRIPTION OF THE ADJUSTED MONETARY BASE IS AVAILABLE FROM THIS BANK.

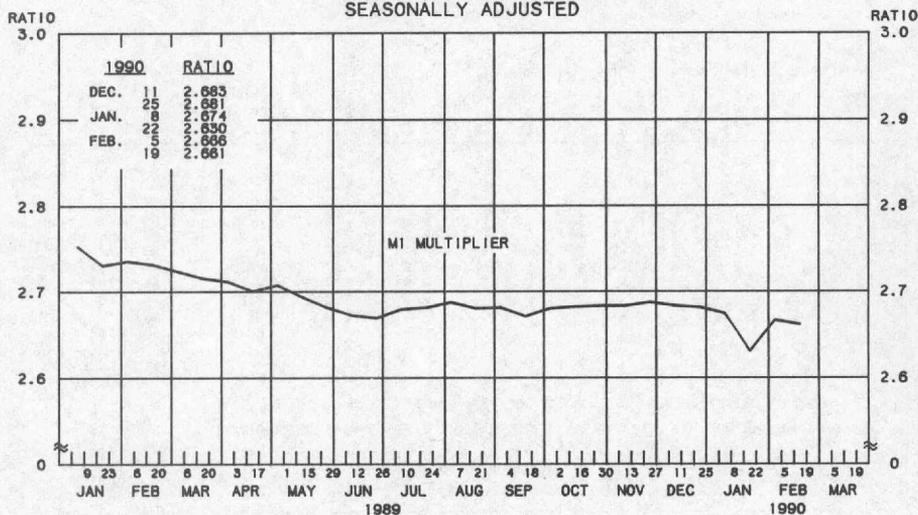

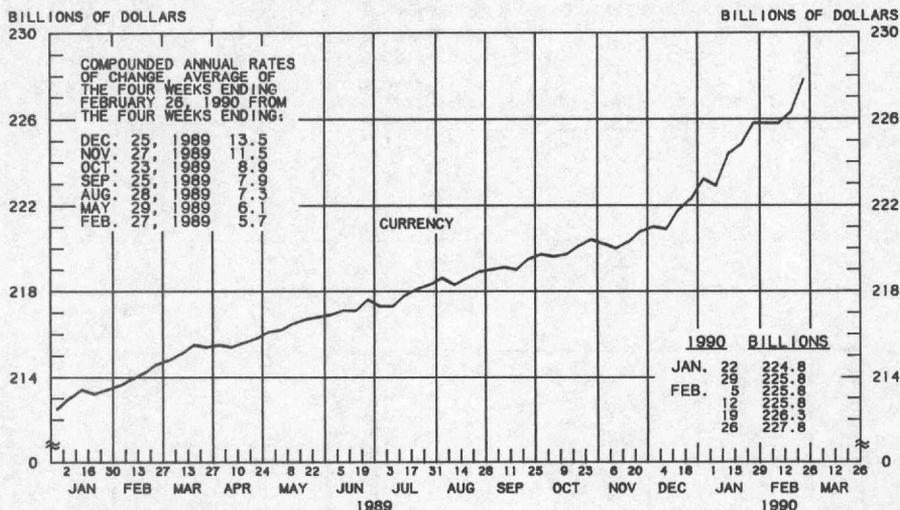

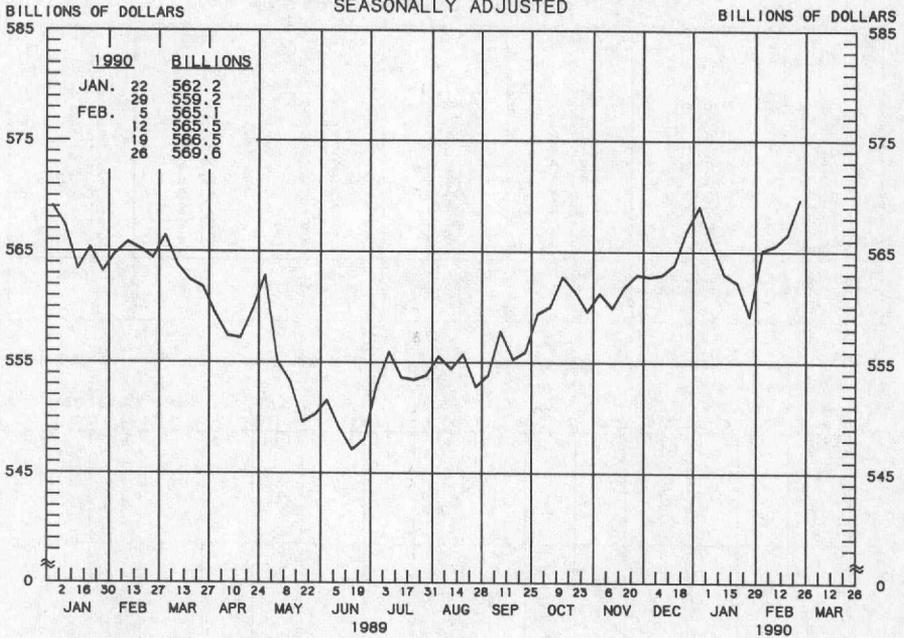

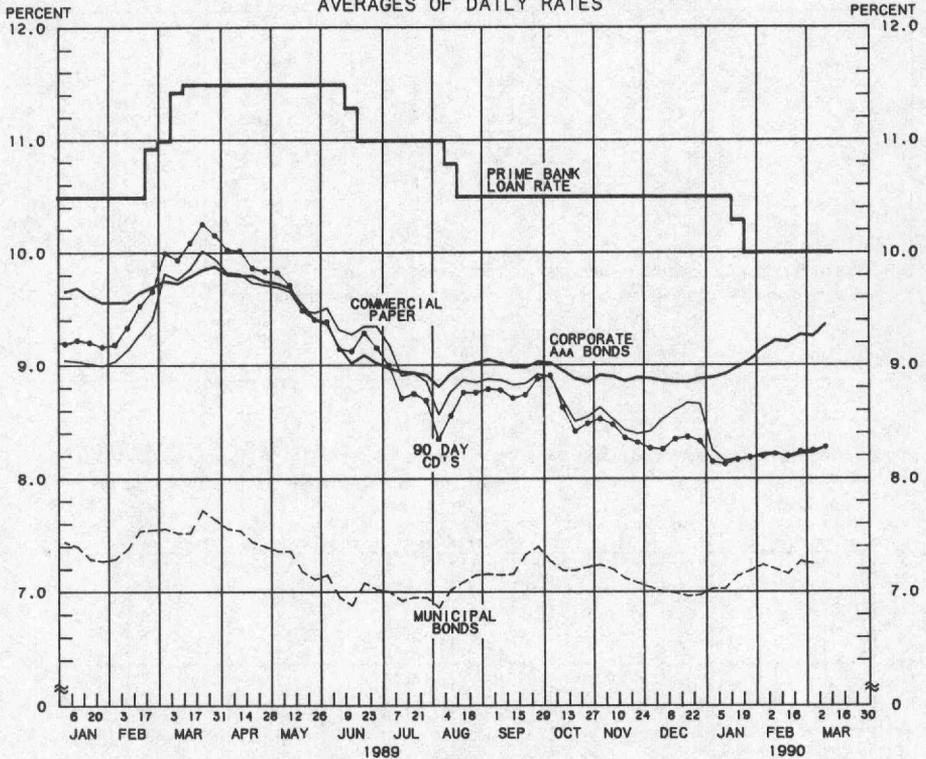

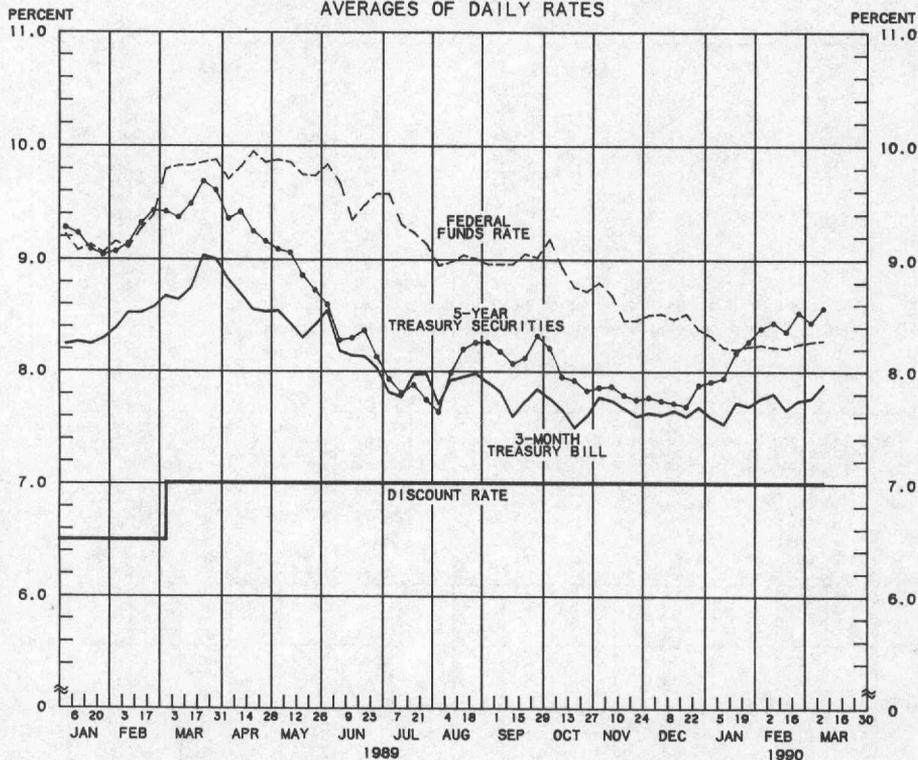

## SELECTED INTEREST RATES AVERAGES OF DAILY RATES



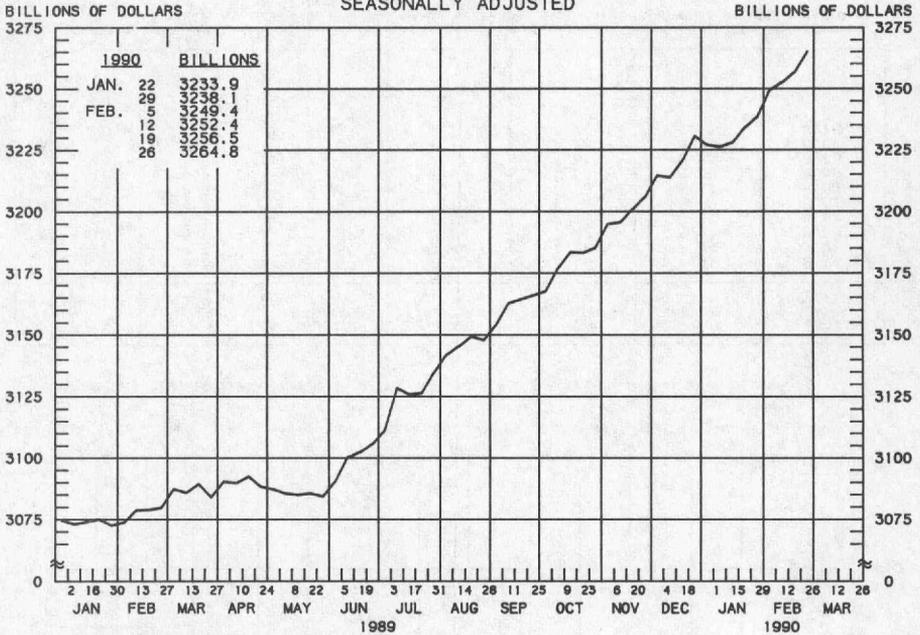

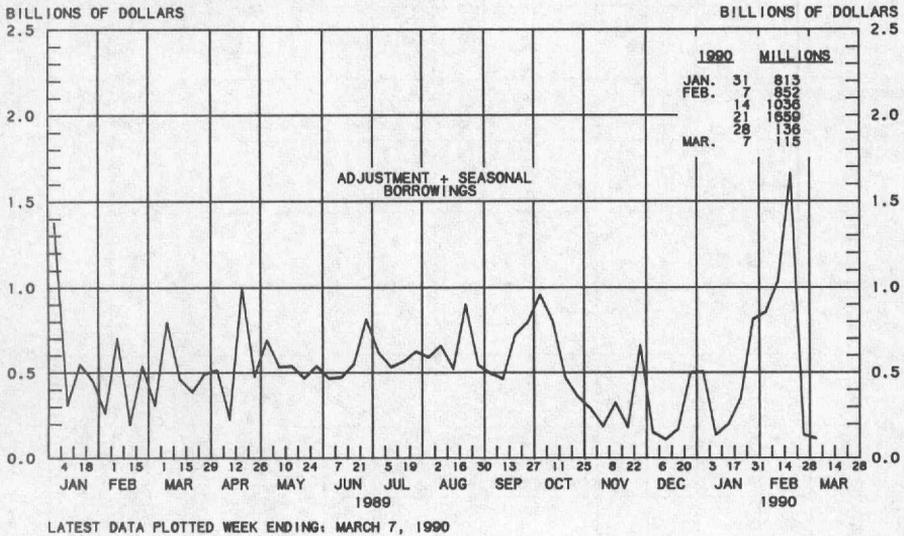
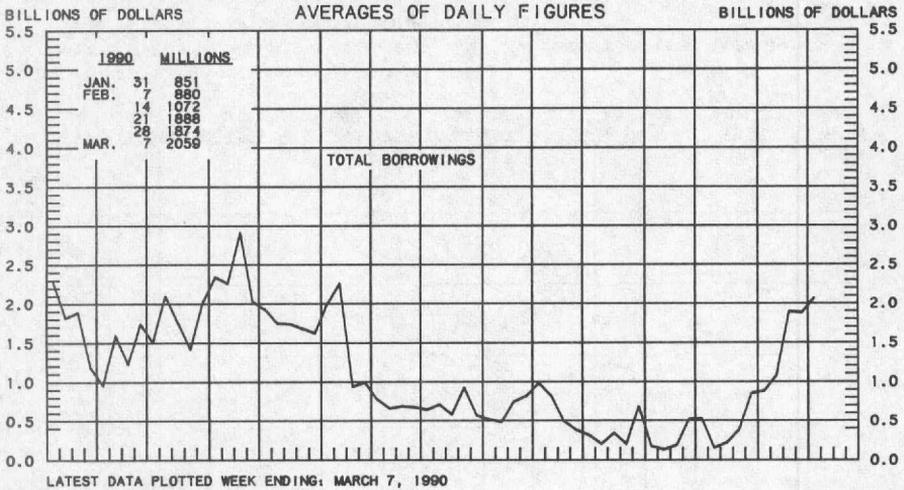

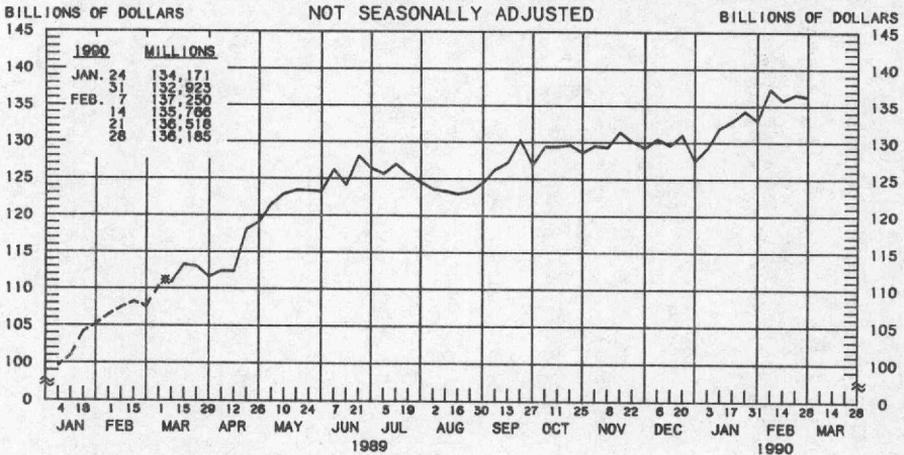

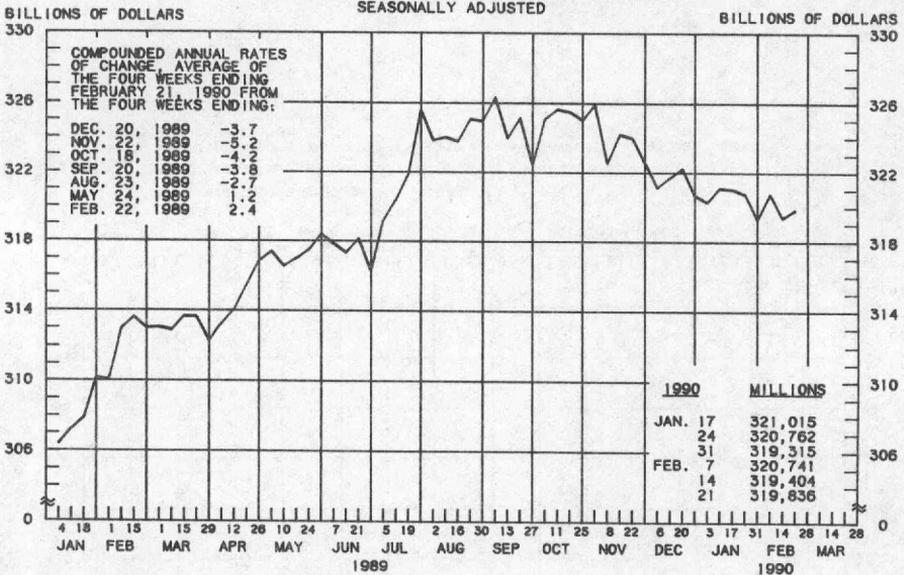
# COMMERCIAL PAPER OF NONFINANCIAL COMPANIES

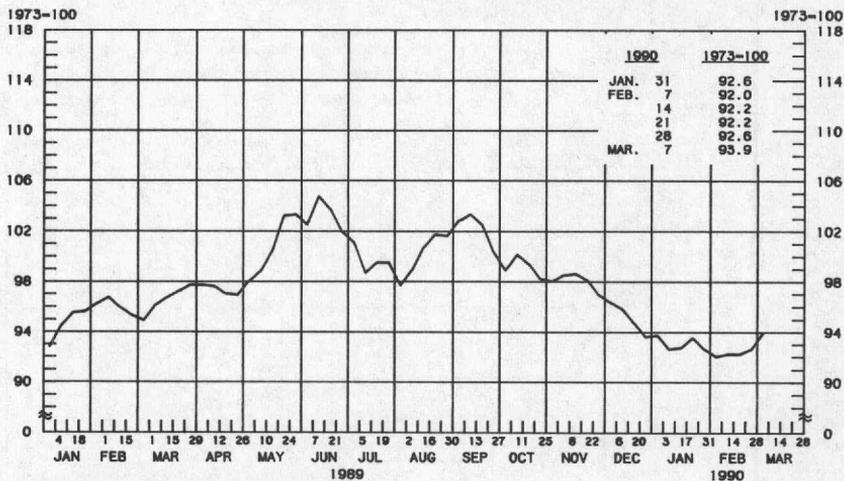
