


THE WEEK'S HIGHLIGHTS:

- Because of a steep decline in auto sales, retail sales fell at a seasonally adjusted rate of 0.9 percent in February, following a 2.8 percent increase in January. February sales were up 5.1 percent from a year ago.
- ✓ The civilian unemployment rate was unchanged from January at 5.3 percent. Total civilian employment rose at an annual rate of 1.8 percent in February, while the labor force rose 2.3 percent. Over the past year, total employment grew 1.1 percent, down from the 2.2 percent growth in the previous year.
- In February, nonfarm payroll employment rose at an annual rate of 4.1 percent, after increasing 3.7 percent in January. Payroll employment was up 2.4 percent from a year earlier.
- The weekly average of the dollar's trade-weighted index has risen 2.4 percent from the week ending February 7, but is 10 percent below its peak in 1989 reached during the week ending June 14.








TOTAL CHECKABLE DEPOSITS AVERAGES OF DAILY FIGURES SEASONALLY ADJUSTED






MONEY STOCK (M2) AVERAGES OF DAILY FIGURES SEASONALLY ADJUSTED








