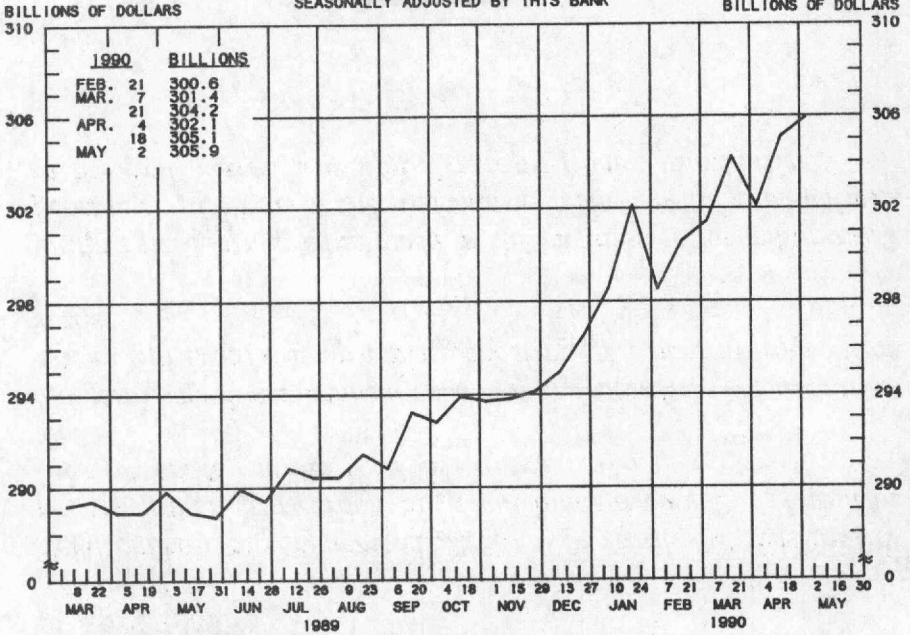

## THE WEEK'S HIGHLIGHTS:

- ✓ *The M1 money stock rose at a 5.1 percent annual rate from the four weeks ending August 28, 1989, to the four weeks ending April 30.*
- ✓ *The civilian unemployment rate increased from 5.2 percent in March to 5.4 percent in April. The unemployment rate was 5.3 percent in April 1989.*
- ✓ *Total civilian employment fell 218,000 in April, but was up 0.9 percent from a year earlier. Such employment grew 2.1 percent in the year ending in April 1989.*
- ✓ *Nonfarm payroll employment expanded at a weak 0.7 percent annual rate in April, but was up a relatively strong 2.2 percent from a year earlier.*
- ✓ *Output per hour (productivity) in the business sector fell at a 0.7 percent annual rate in the first quarter. The level of productivity in the first quarter was up 0.7 percent from a year earlier.*

LATEST PLOTTED RESERVE MAINTENANCE PERIOD ENDING: MAY 2, 1990

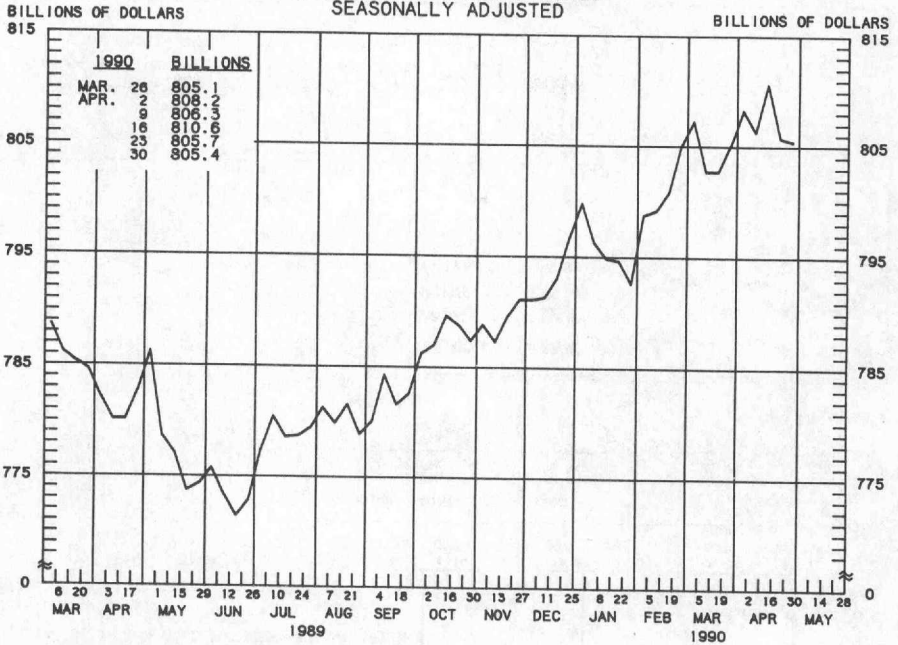
THE ADJUSTED MONETARY BASE IS THE SUM OF RESERVE ACCOUNTS OF FINANCIAL INSTITUTIONS AT FEDERAL RESERVE BANKS, CURRENCY IN CIRCULATION (CURRENCY HELD BY THE PUBLIC AND IN THE VAULTS OF ALL DEPOSITORY INSTITUTIONS) AND AN ADJUSTMENT FOR RESERVE REQUIREMENT RATIO CHANGES. THE MAJOR SOURCE OF THE ADJUSTED MONETARY BASE IS FEDERAL RESERVE CREDIT. DATA ARE COMPUTED BY THIS BANK. A DETAILED DESCRIPTION OF THE ADJUSTED MONETARY BASE IS AVAILABLE FROM THIS BANK.

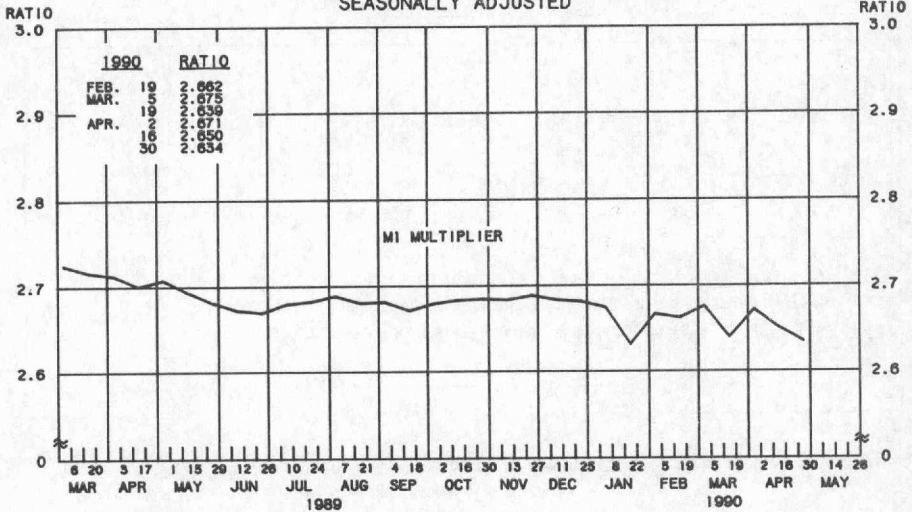

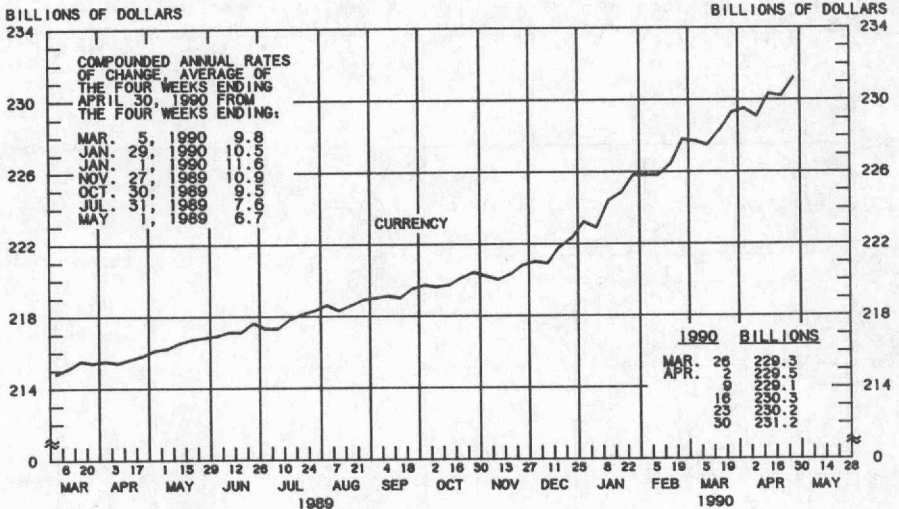

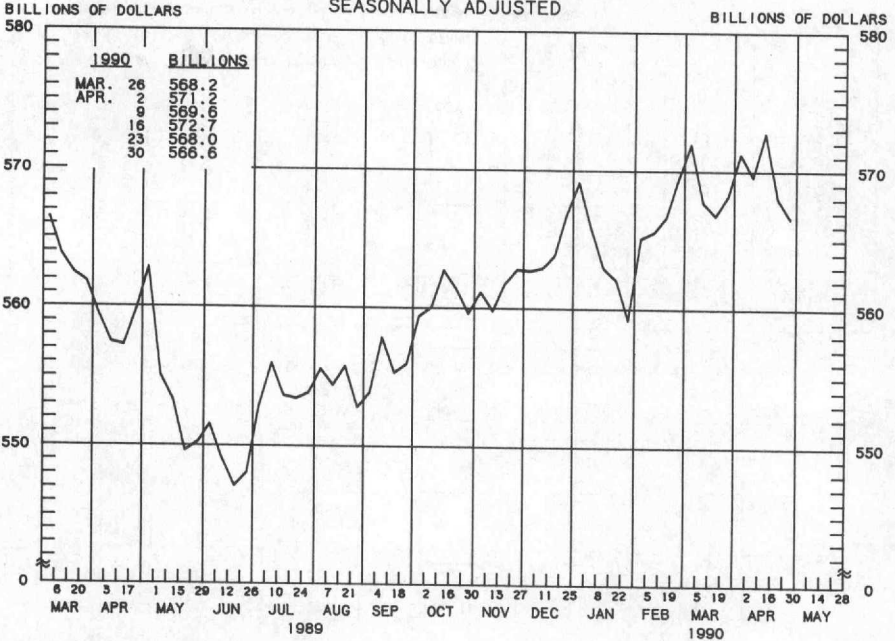

 SEASONALLY ADJUSTED



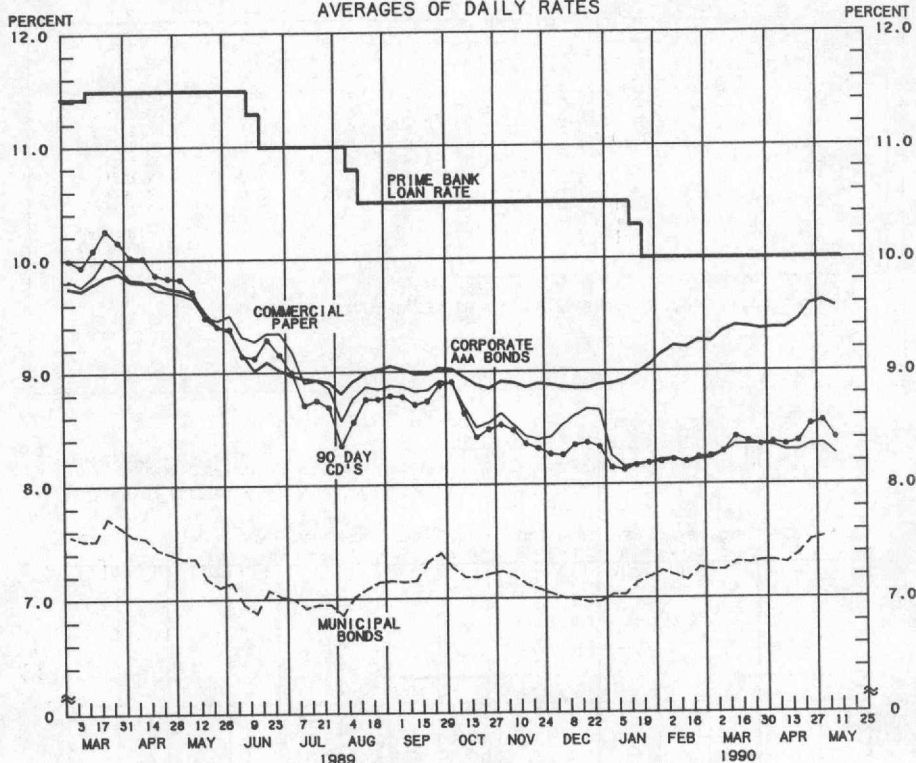

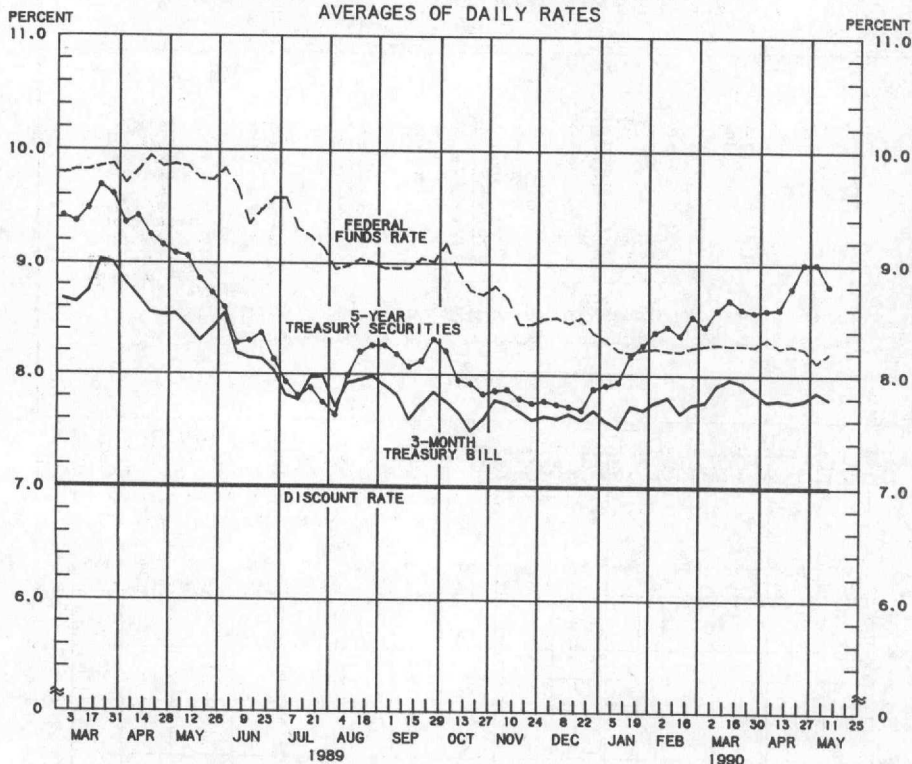

## SELECTED INTEREST RATES AVERAGES OF DAILY RATES



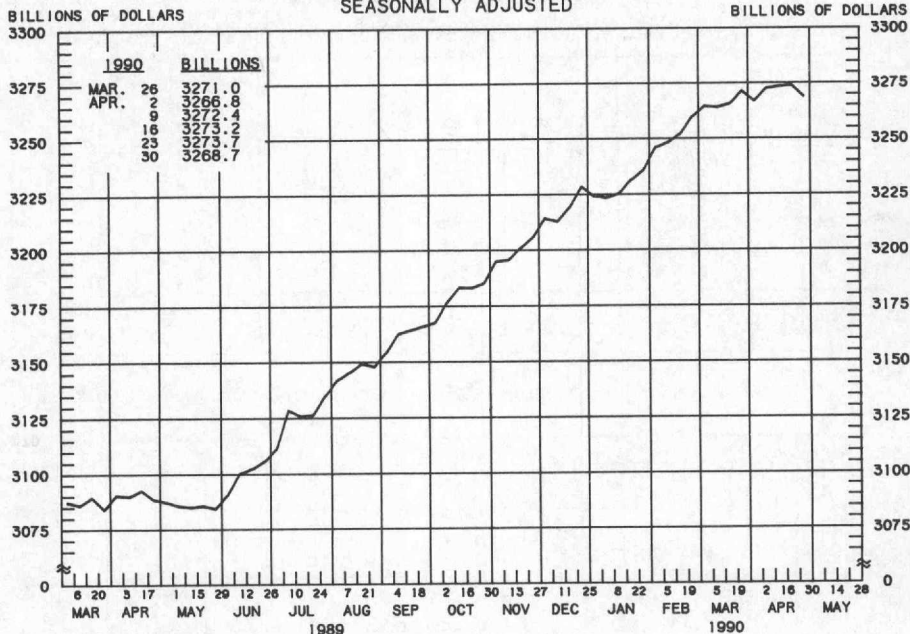

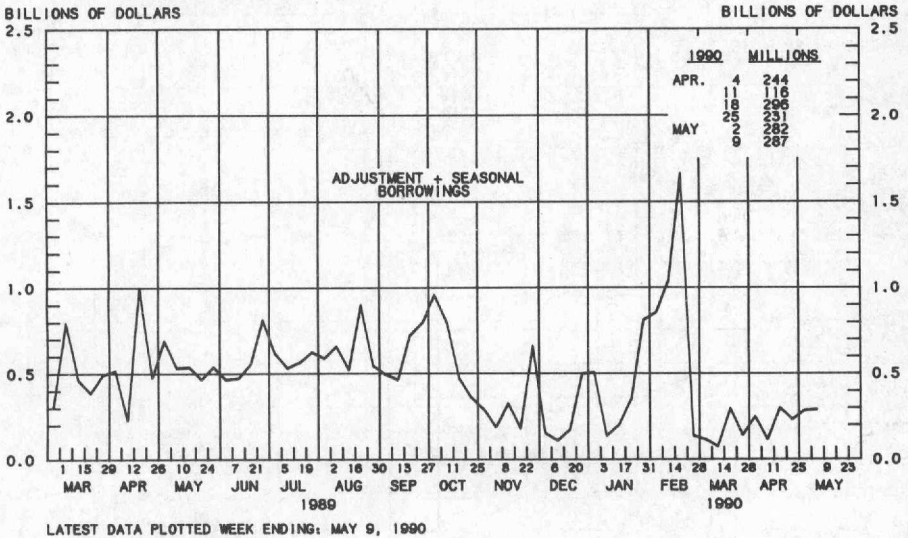

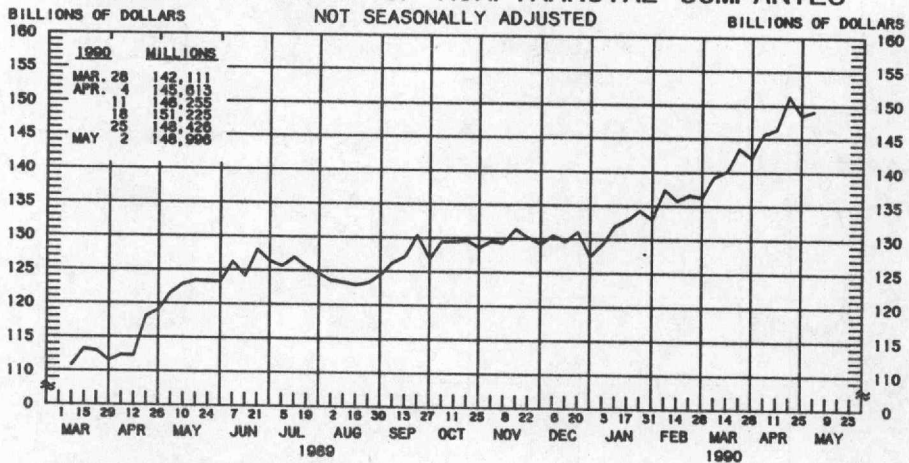

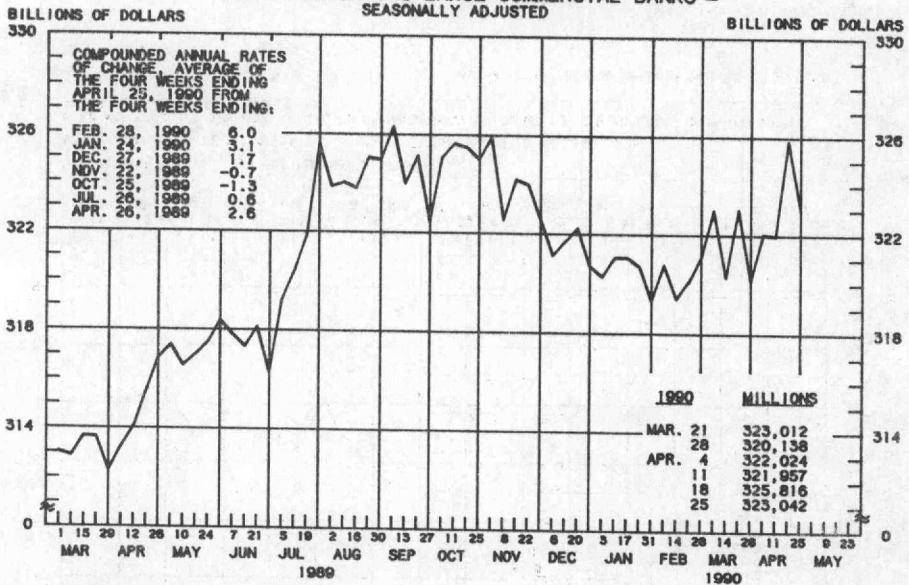

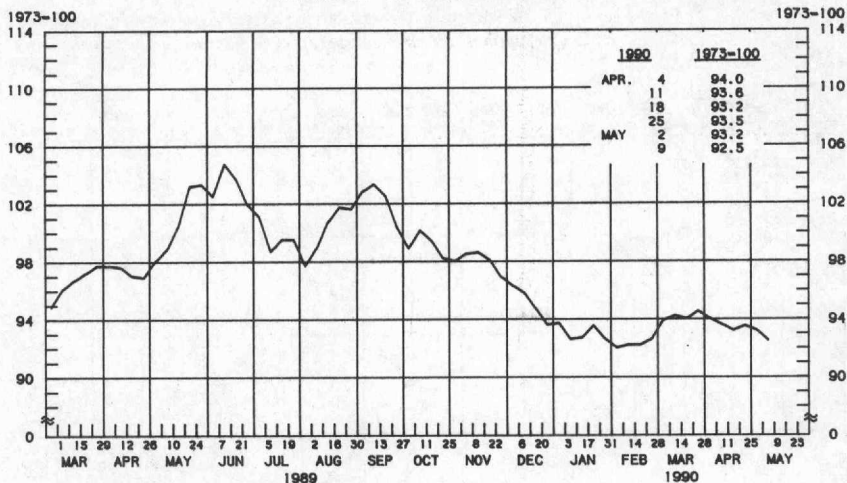
