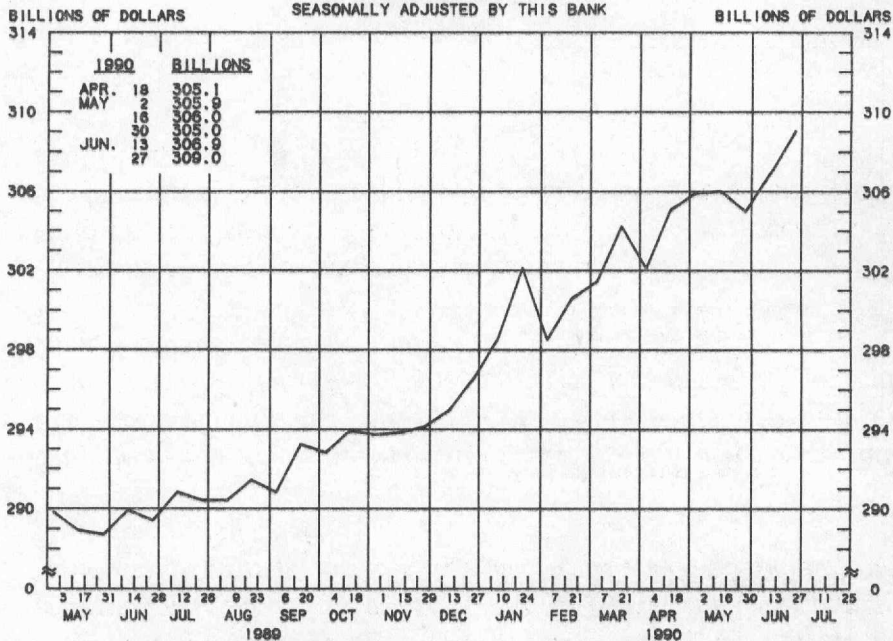
THE WEEK'S HIGHLIGHTS:

- ✓ *The unemployment rate dropped to 5.2 percent in June from 5.3 percent in May. Over the past year, employment has increased 0.7 percent while the labor force has expanded 0.6 percent, resulting in a decline in the unemployment from 5.3 percent to 5.2 percent.*
- ✓ *The value of new construction put in place declined 0.4 percent in May, following a decline of 2.2 percent in April. The value of new construction thus far in 1990 is 3.8 percent above the value from January-to-May 1989.*
- ✓ *The number of new single-family houses rose 0.4 percent in May to a seasonally adjusted annual rate of 532,000 units. The number of units sold in the January-to-May period was down 9.6 percent from the same period in 1989.*
- ✓ *Commercial paper of nonfinancial companies has risen nearly \$25 billion since December of last year. During the same period, there has been essentially no net change in the business loans of commercial banks (page 11).*

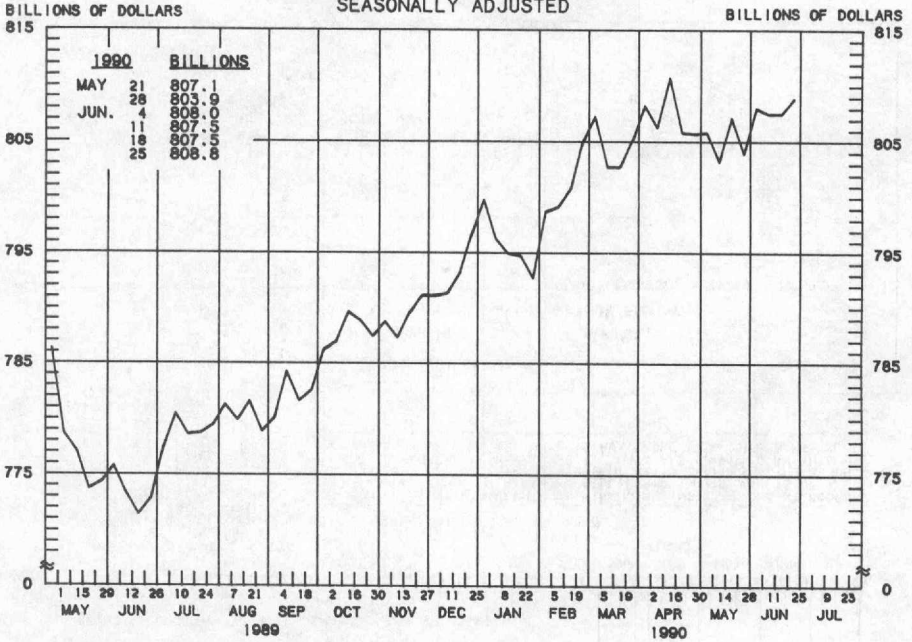
THE ADJUSTED MONETARY BASE IS THE SUM OF RESERVE ACCOUNTS OF FINANCIAL INSTITUTIONS AT FEDERAL RESERVE BANKS, CURRENCY IN CIRCULATION (CURRENCY HELD BY THE PUBLIC AND IN THE VAULTS OF ALL DEPOSITORY INSTITUTIONS) AND AN ADJUSTMENT FOR RESERVE REQUIREMENT RATIO CHANGES. THE MAJOR SOURCE OF THE ADJUSTED MONETARY BASE IS FEDERAL RESERVE CREDIT. DATA ARE COMPUTED BY THIS BANK. A DETAILED DESCRIPTION OF THE ADJUSTED MONETARY BASE IS AVAILABLE FROM THIS BANK.

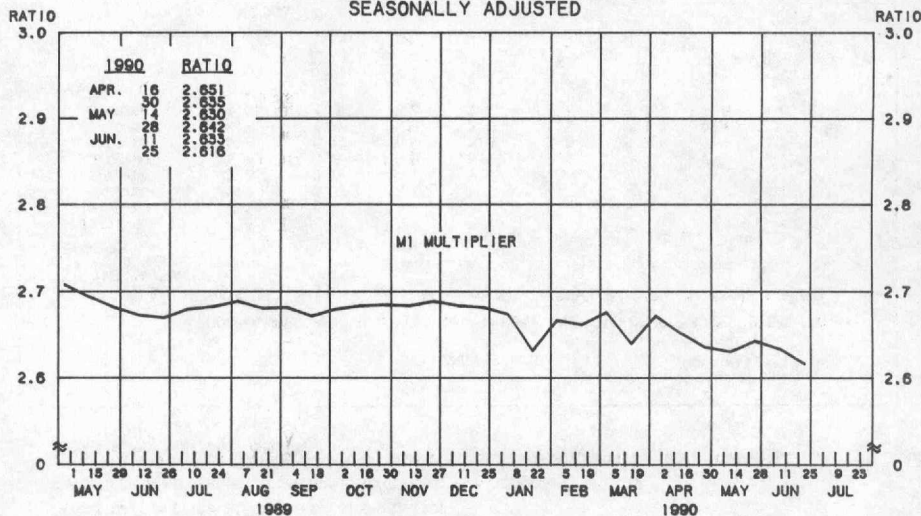

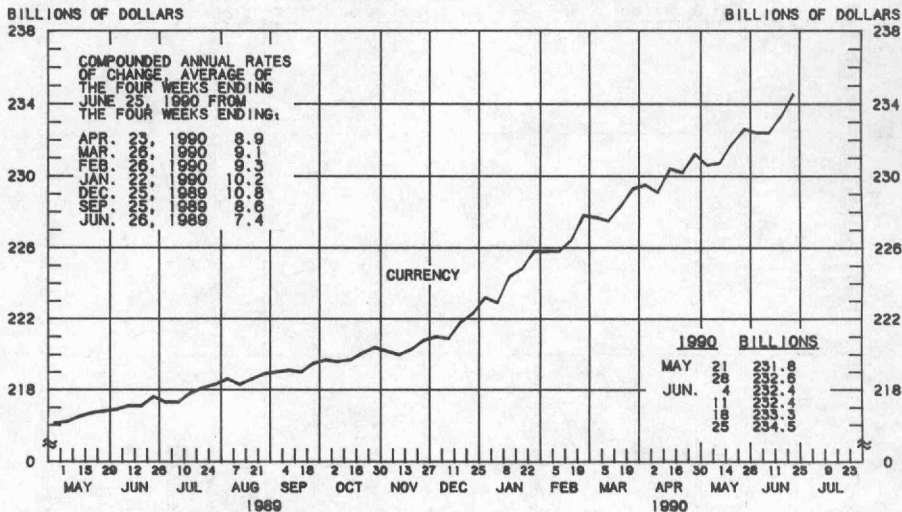

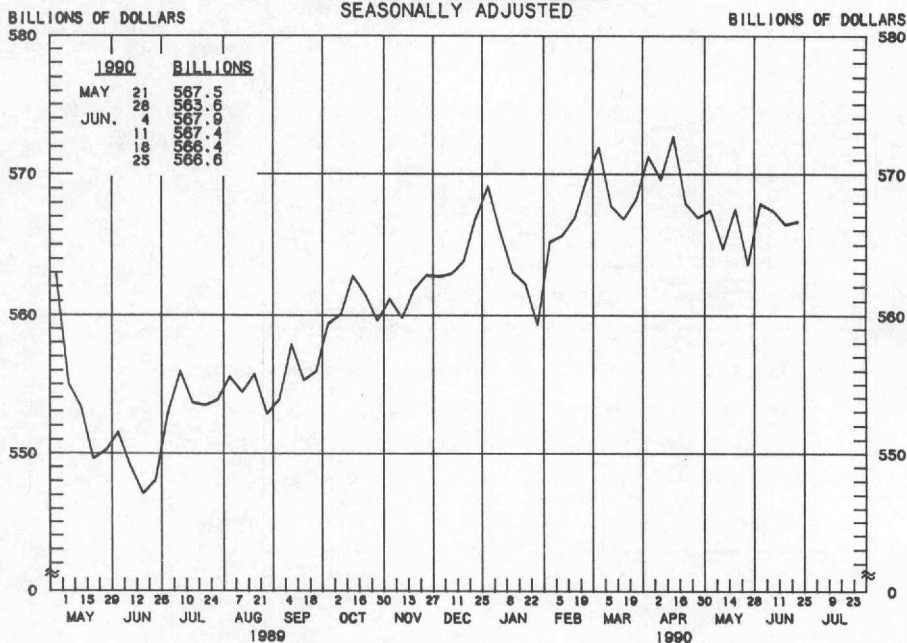

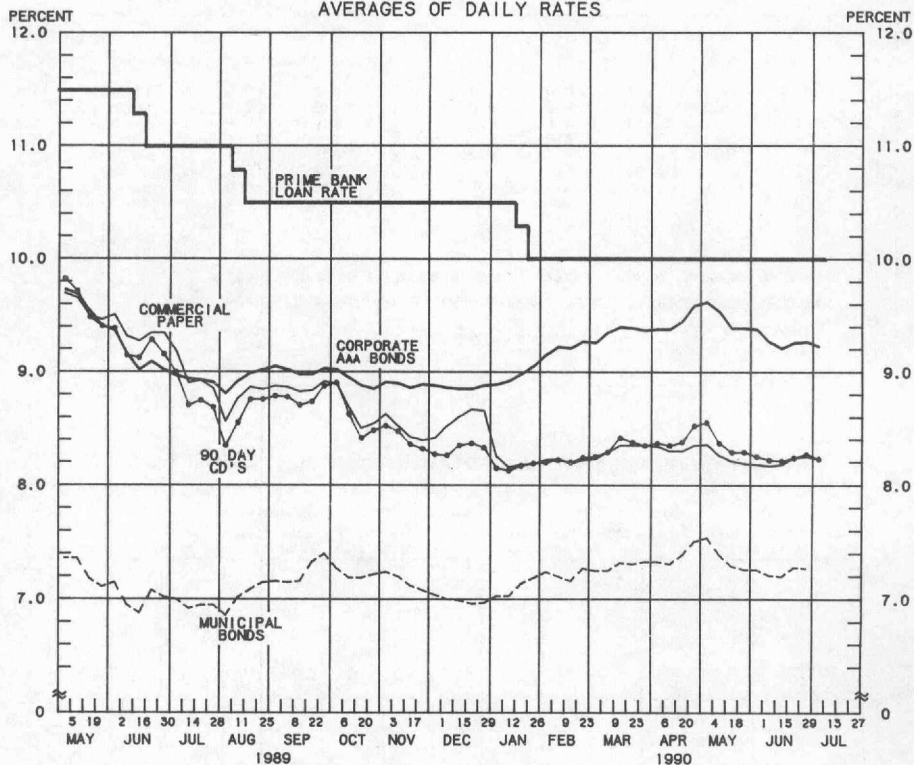

SELECTED INTEREST RATES AVERAGES OF DAILY RATES



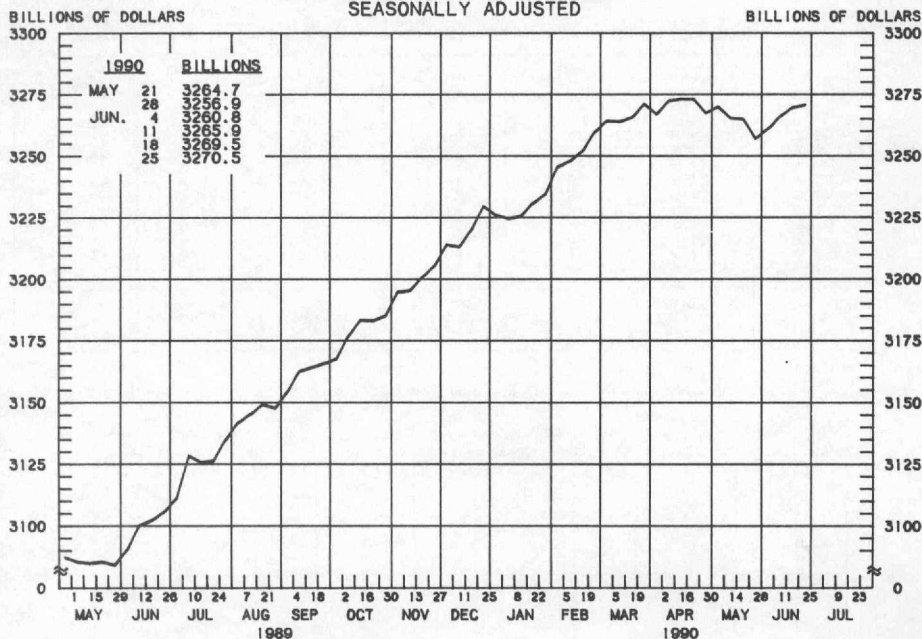

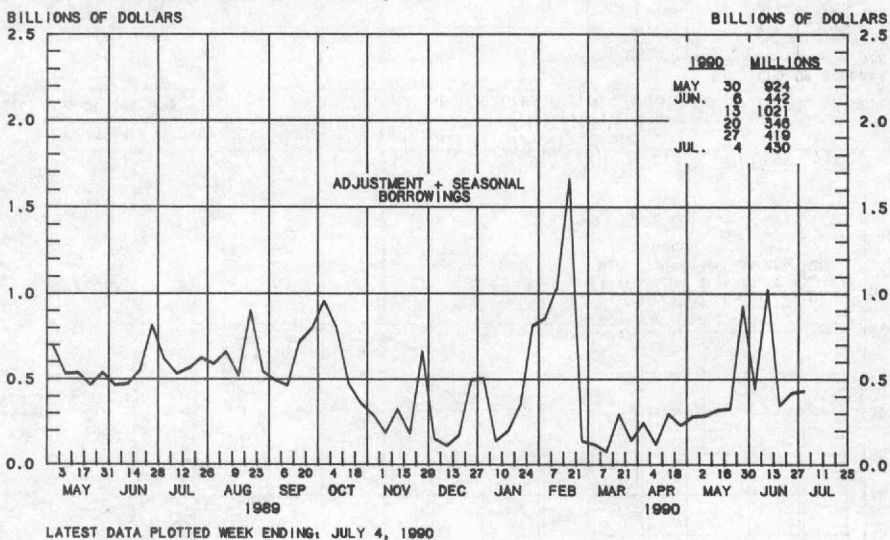
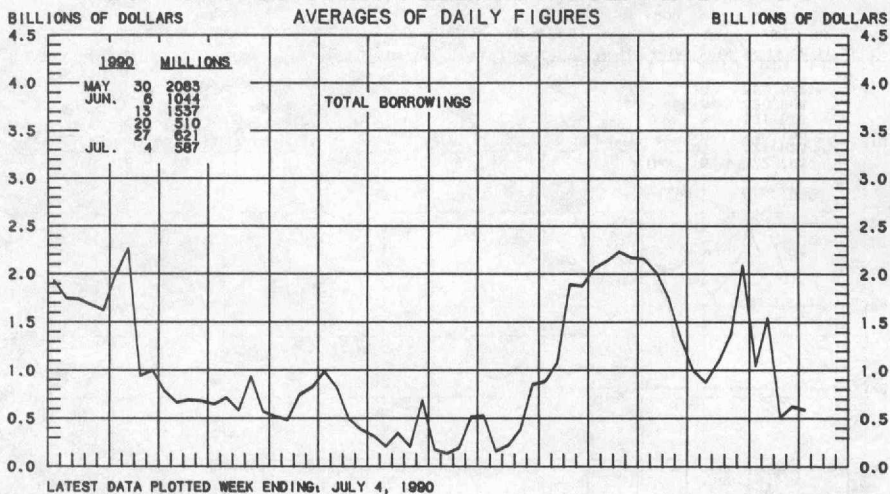

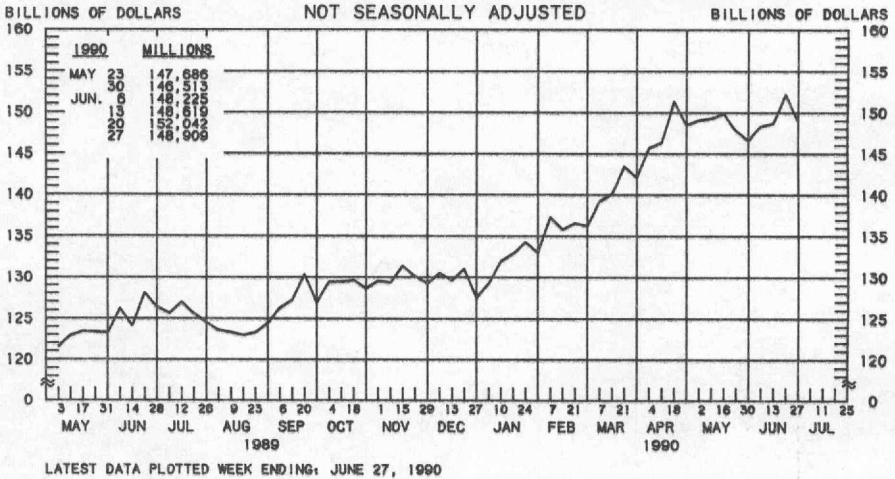

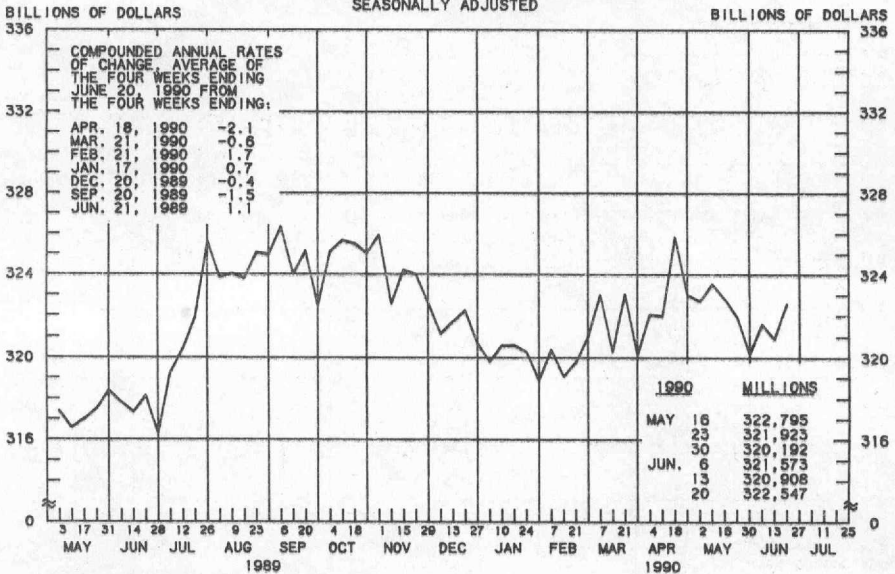

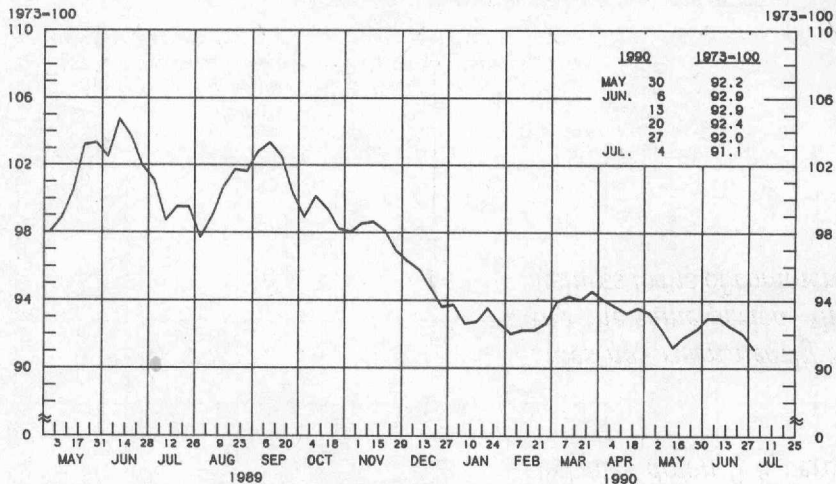
