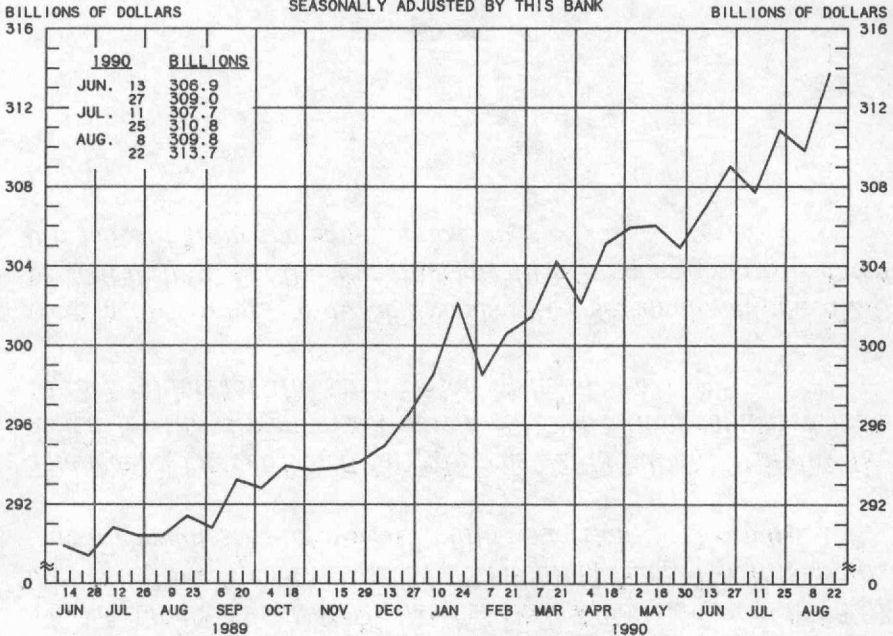

THE WEEK'S HIGHLIGHTS:

- ✓ *There has been a sharp rise in the growth rate of currency and a sharp slowing in the growth rate of total checkable deposits (TCD) since December 1989. This has resulted in a similar rise in the public's holding of currency relative to TCD and a sharp decline in the money multiplier (see page 4).*
- ✓ *The seasonally adjusted merchandise trade deficit narrowed to \$5.07 billion in June from a revised \$7.77 billion in May. The June figure was the smallest since a \$4.17 billion shortfall in December 1983.*
- ✓ *The federal budget deficit for July was \$25.9 billion, bringing the deficit for the current fiscal year to \$189.1 billion compared with \$123.7 billion for the same period in fiscal year 1989.*
- ✓ *New factory orders for durable goods rose a seasonally adjusted 2.9 percent in July. For the year thus far, durable goods orders are down 0.6 percent from the same period in 1989.*

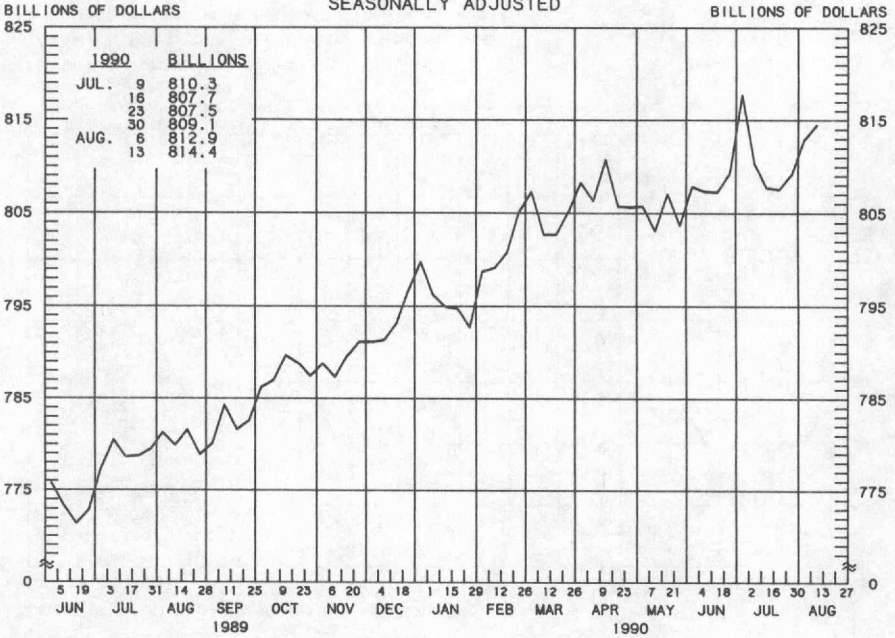
THE ADJUSTED MONETARY BASE IS THE SUM OF RESERVE ACCOUNTS OF FINANCIAL INSTITUTIONS AT FEDERAL RESERVE BANKS, CURRENCY IN CIRCULATION (CURRENCY HELD BY THE PUBLIC AND IN THE VAULTS OF ALL DEPOSITORY INSTITUTIONS) AND AN ADJUSTMENT FOR RESERVE REQUIREMENT RATIO CHANGES. THE MAJOR SOURCE OF THE ADJUSTED MONETARY BASE IS FEDERAL RESERVE CREDIT. DATA ARE COMPUTED BY THIS BANK. A DETAILED DESCRIPTION OF THE ADJUSTED MONETARY BASE IS AVAILABLE FROM THIS BANK.

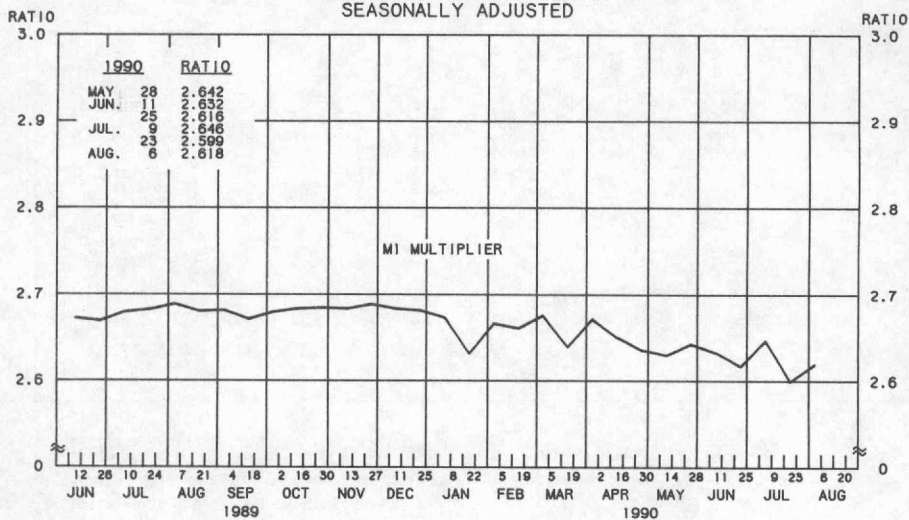

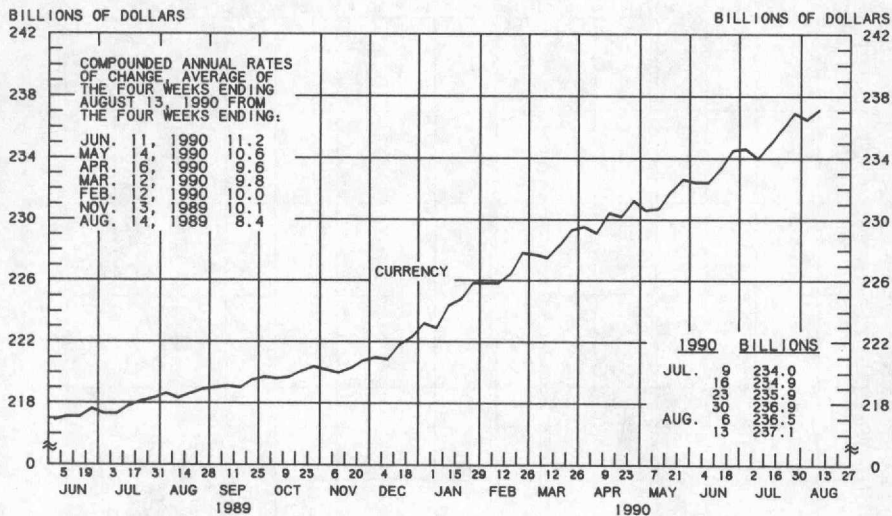

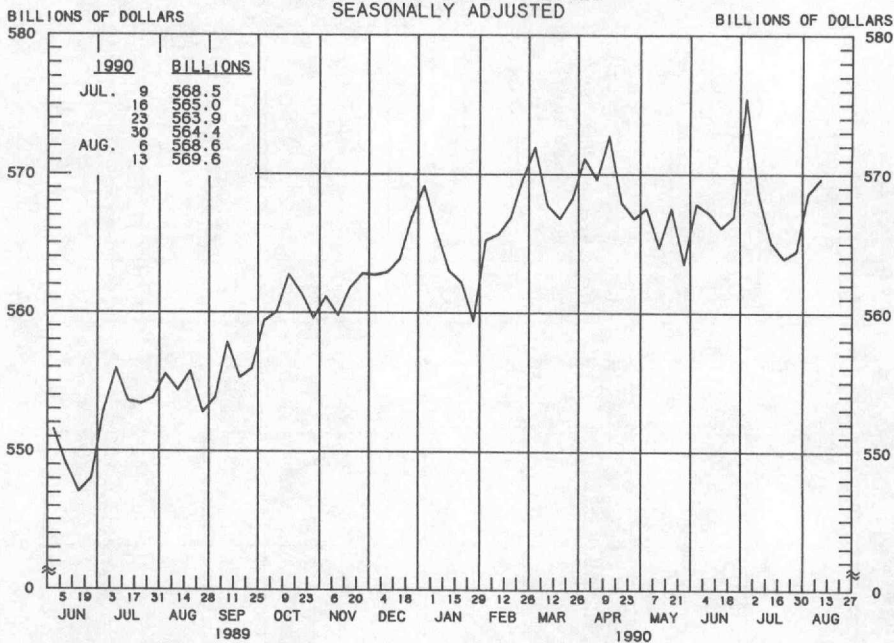

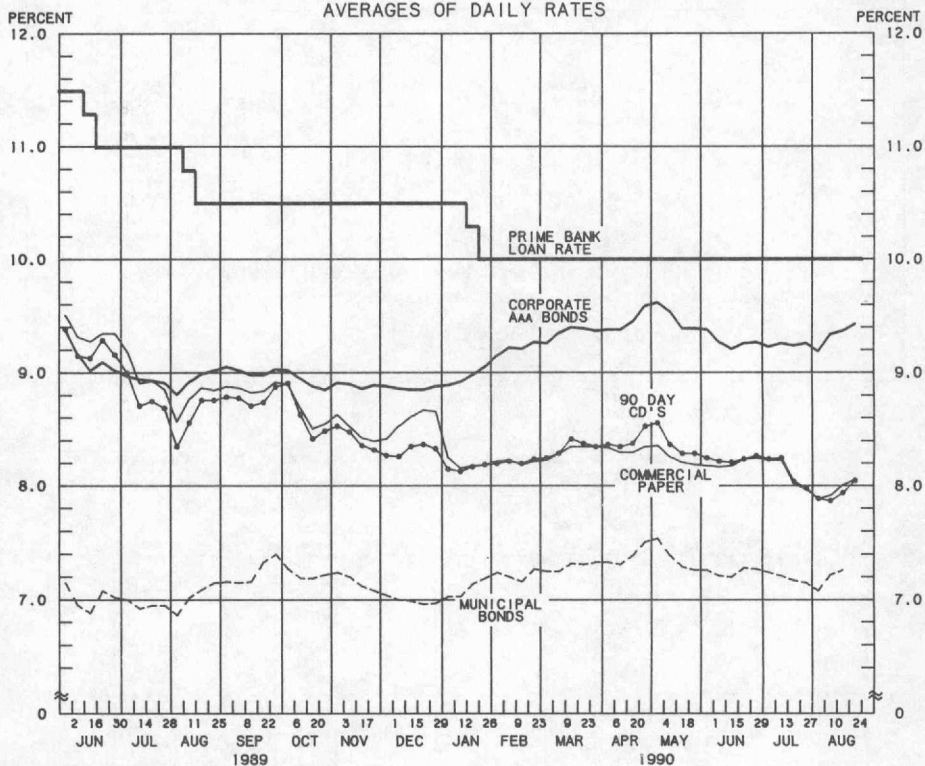

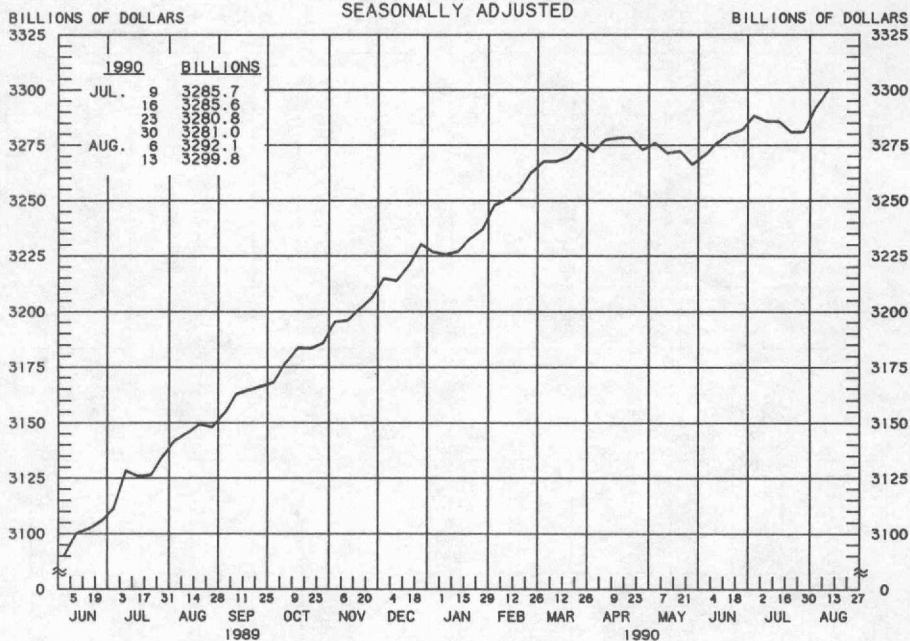

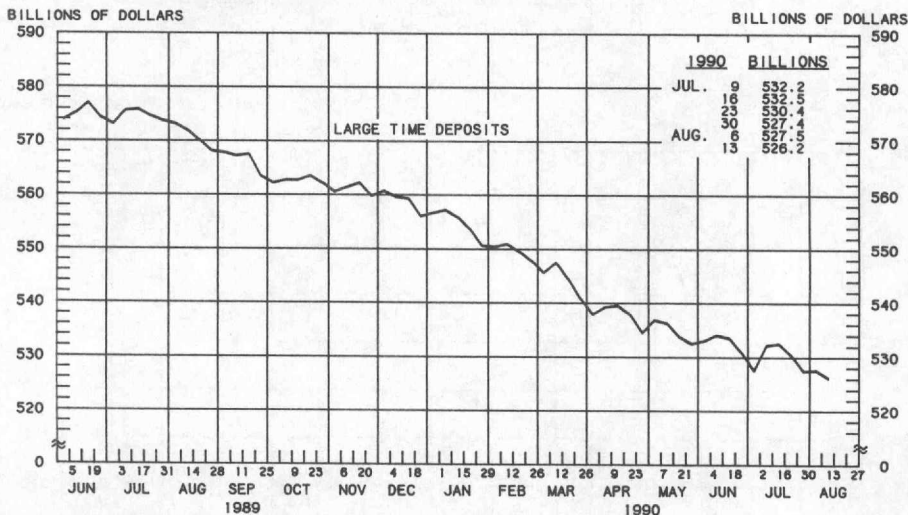

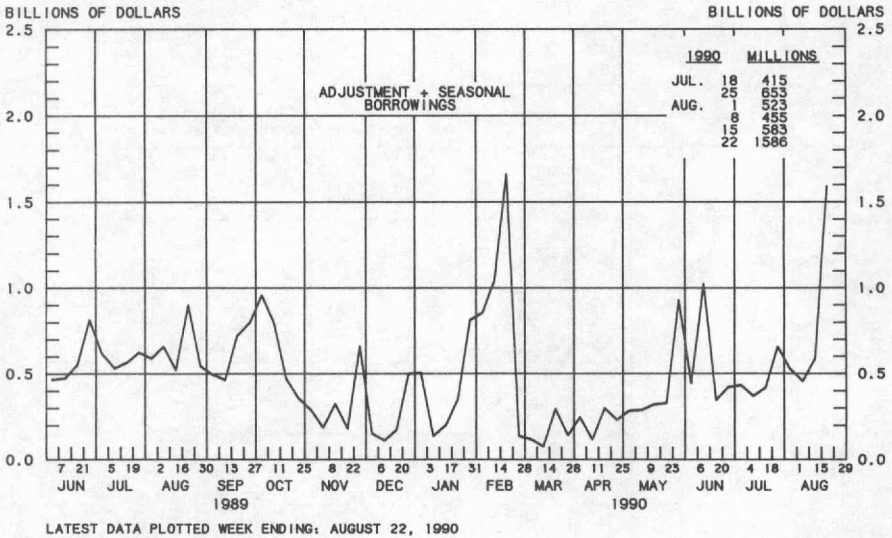
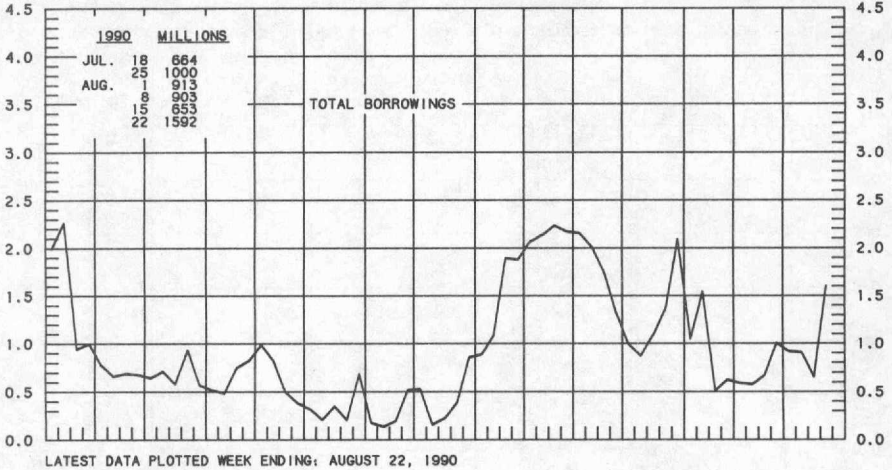

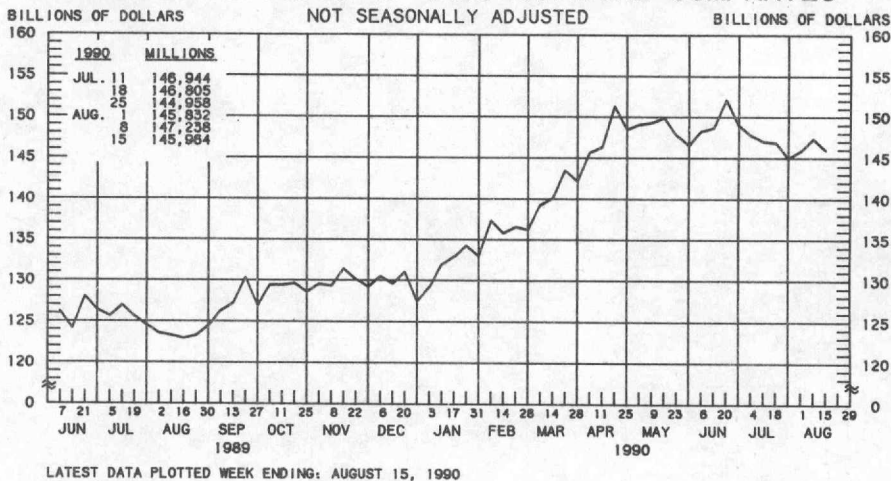
BORROWINGS FROM FEDERAL RESERVE BANKS

BILLIONS OF DOLLARS AVERAGES OF DAILY FIGURES BILLIONS OF DOLLARS



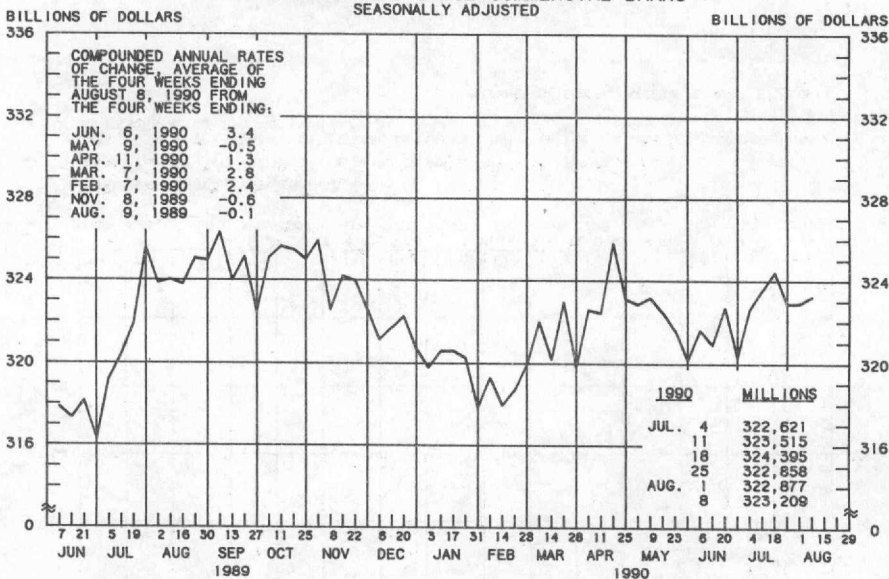

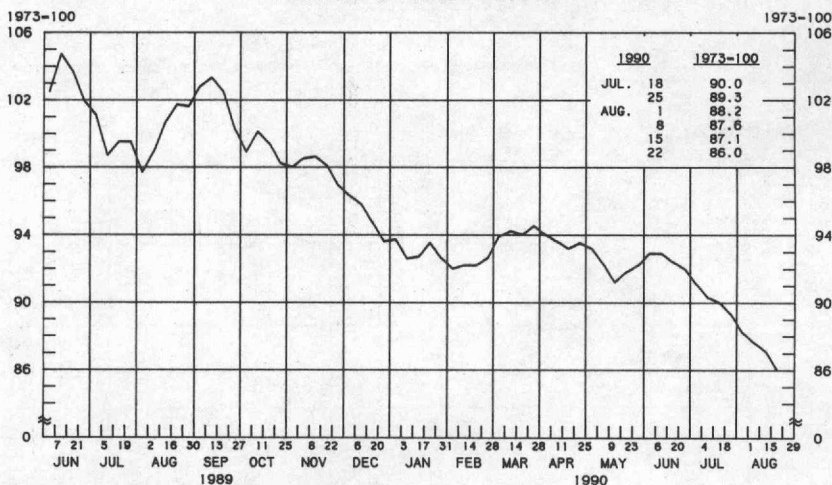
