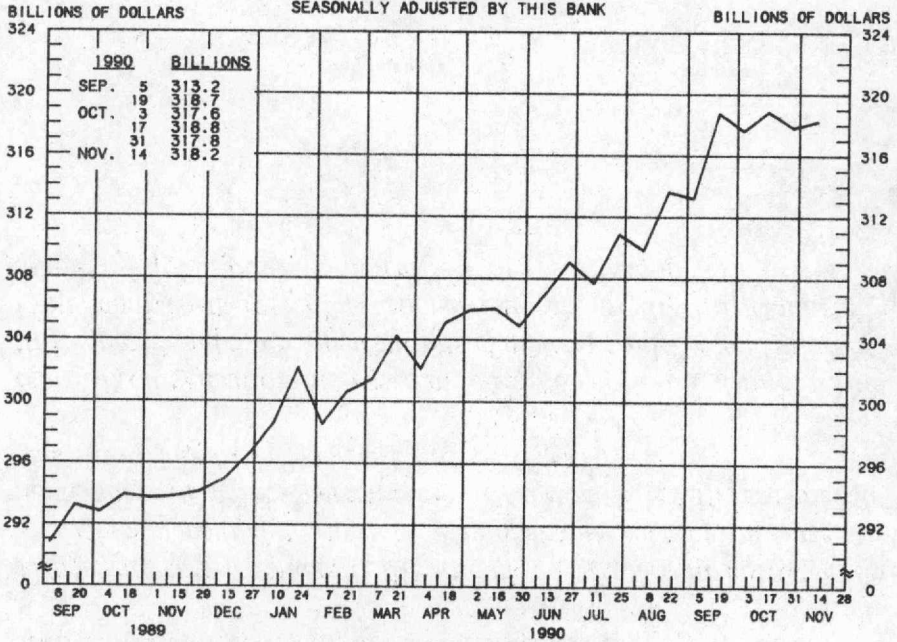

THE WEEK'S HIGHLIGHTS:

- ✓ *Industrial production fell at a 9.3 percent annual rate in October, putting the index below its June level. This follows a 1.1 percent rate of increase in September.*
- ✓ *The capacity utilization rate was 82.6 percent in October, down from 83.5 percent in both August and September.*
- ✓ *The producer price index (PPI) rose at a 13.7 percent annual rate in October, compared with a 20.9 percent rate of increase in September and a 16.4 percent rate in August. The PPI less energy was up at only a 2.9 percent rate in October.*
- ✓ *Hourly compensation increased at a 4.5 percent annual rate in the third quarter, after a 5.1 percent rate of increase in the second quarter. Unit labor costs rose at a 2.6 percent rate in the third quarter, following a 4.7 percent increase in the second quarter.*

THE ADJUSTED MONETARY BASE IS THE SUM OF RESERVE ACCOUNTS OF FINANCIAL INSTITUTIONS AT FEDERAL RESERVE BANKS, CURRENCY IN CIRCULATION (CURRENCY HELD BY THE PUBLIC AND IN THE VAULTS OF ALL DEPOSITORY INSTITUTIONS) AND AN ADJUSTMENT FOR RESERVE REQUIREMENT RATIO CHANGES. THE MAJOR SOURCE OF THE ADJUSTED MONETARY BASE IS FEDERAL RESERVE CREDIT. DATA ARE COMPUTED BY THIS BANK. A DETAILED DESCRIPTION OF THE ADJUSTED MONETARY BASE IS AVAILABLE FROM THIS BANK.

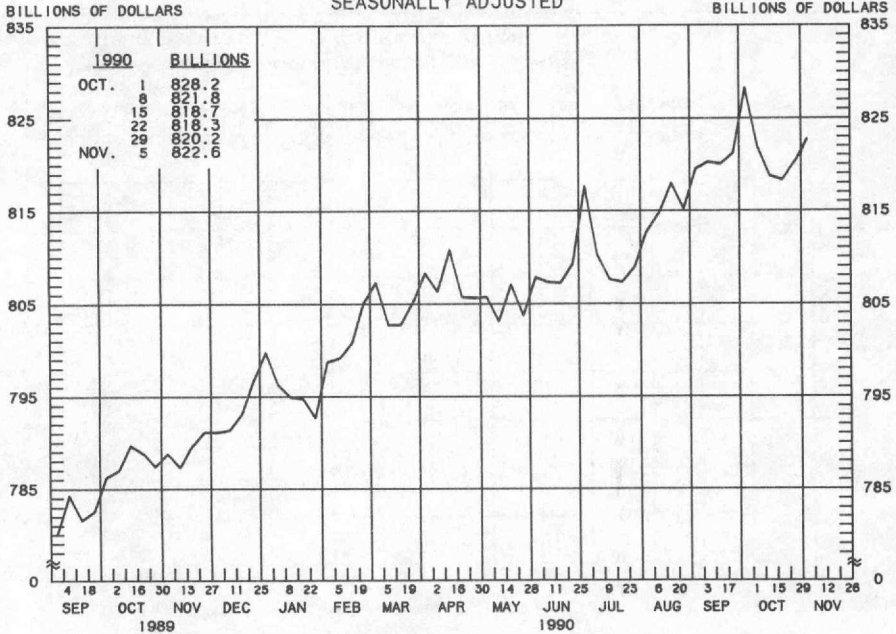

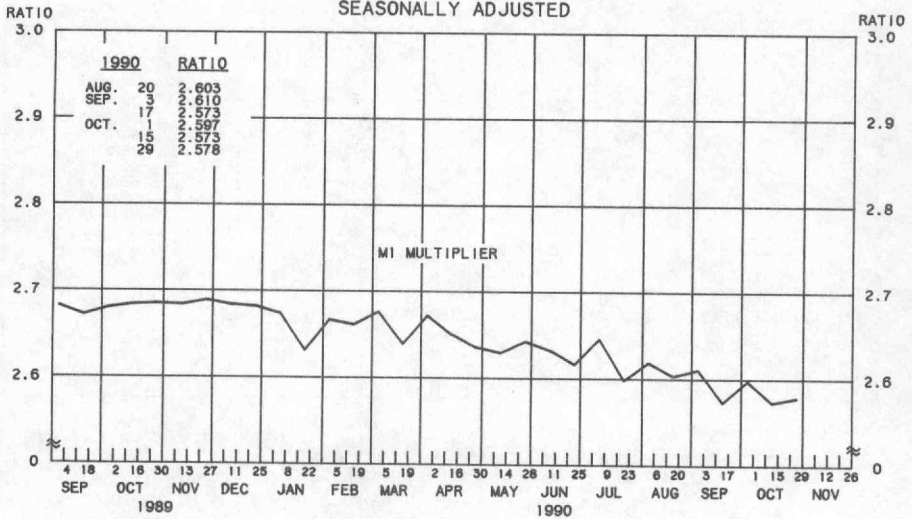

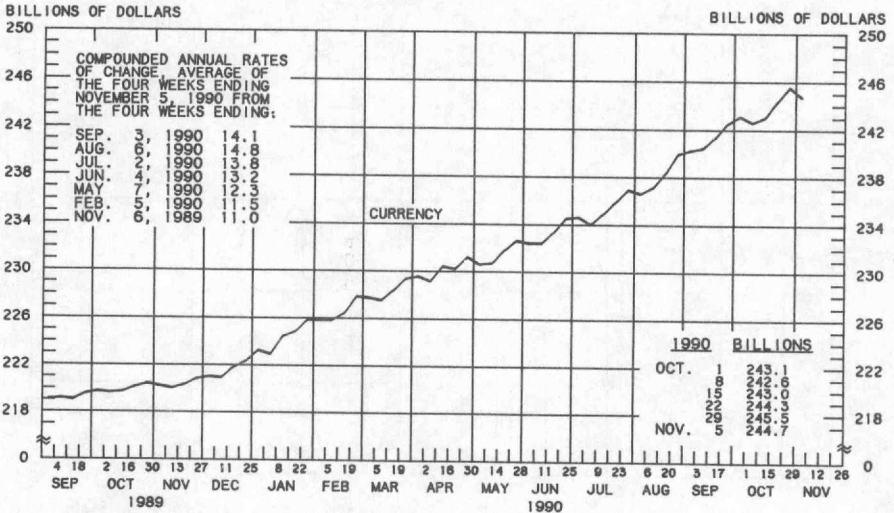

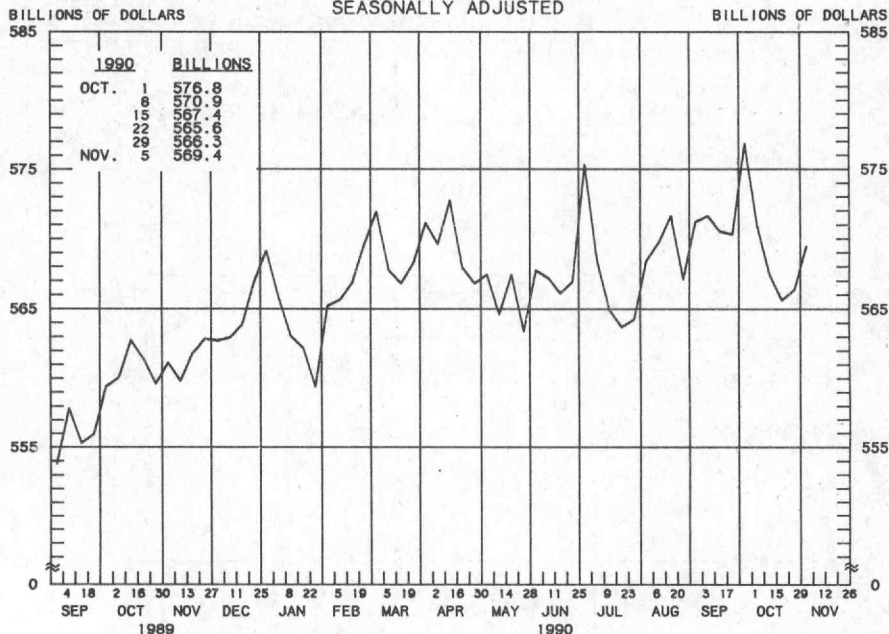

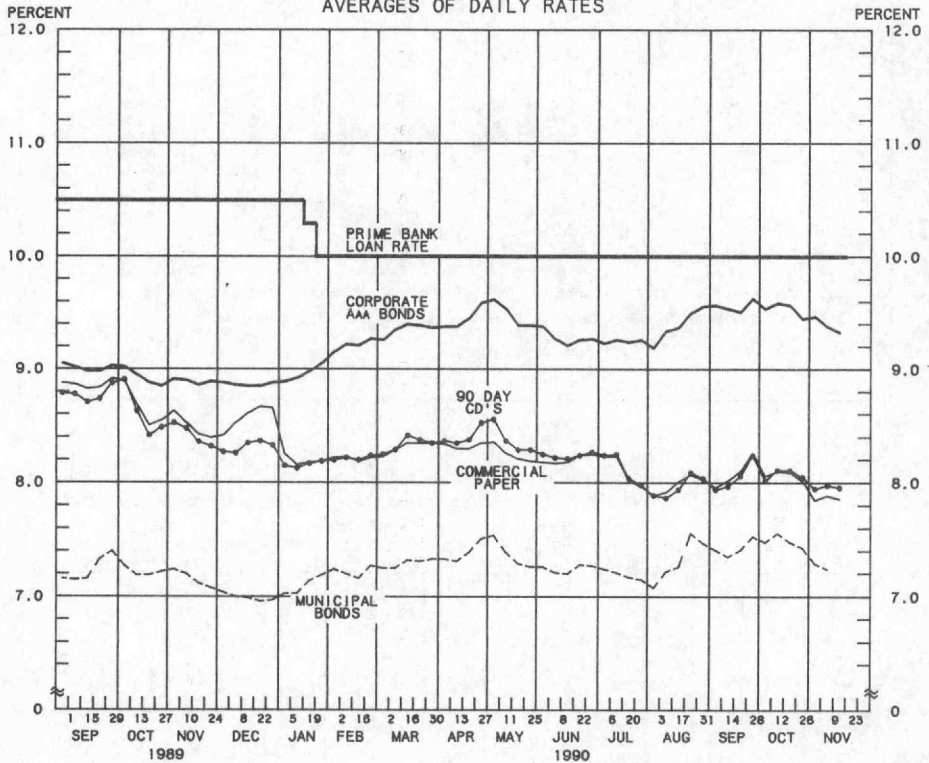

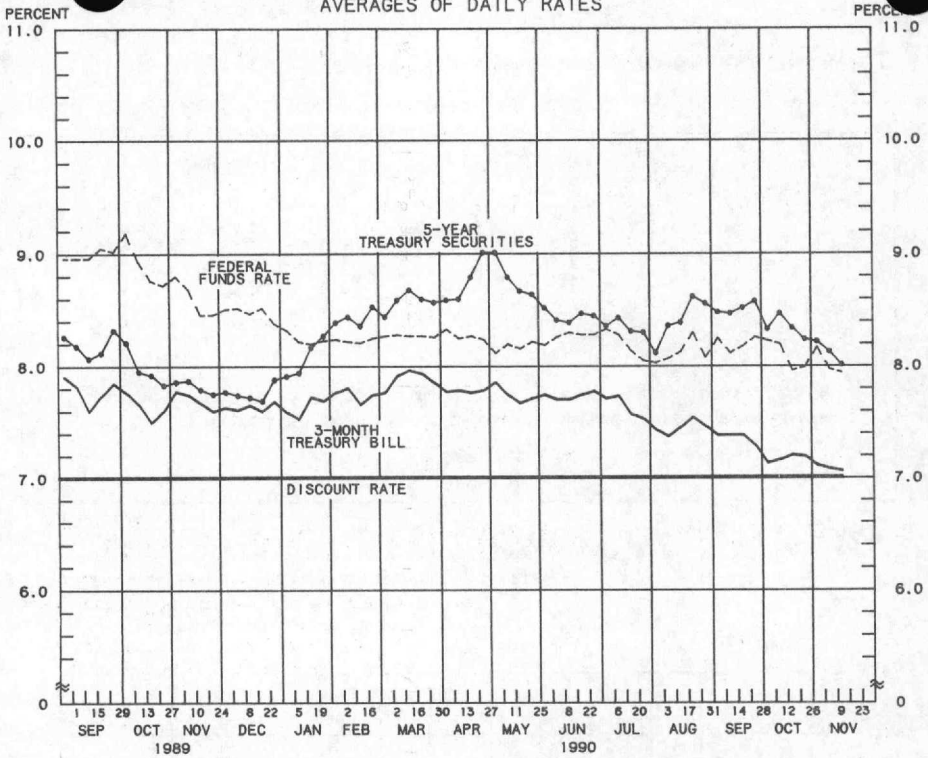

AVERAGES OF DAILY RATES



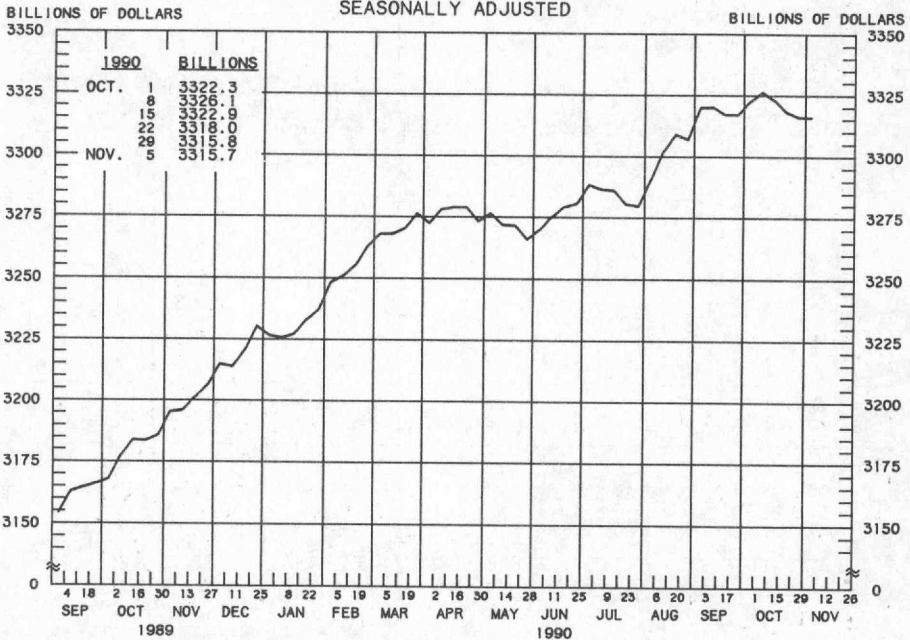

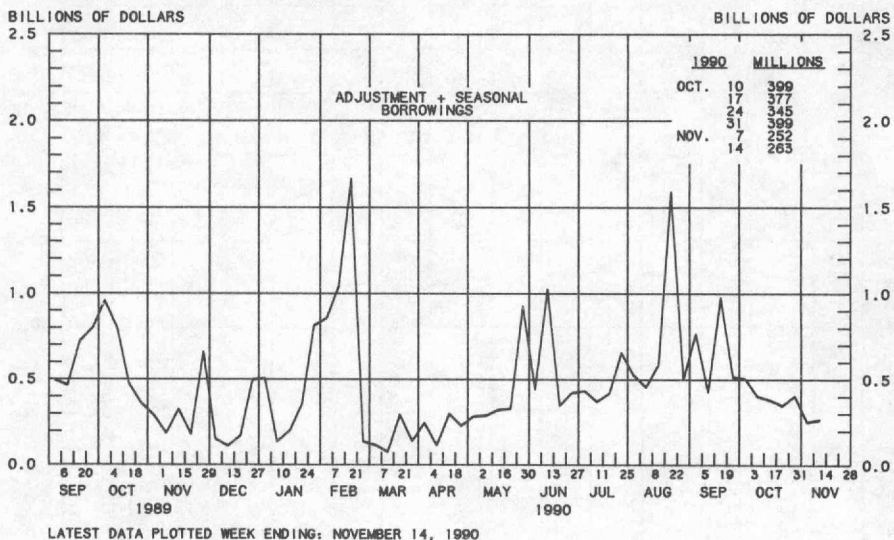
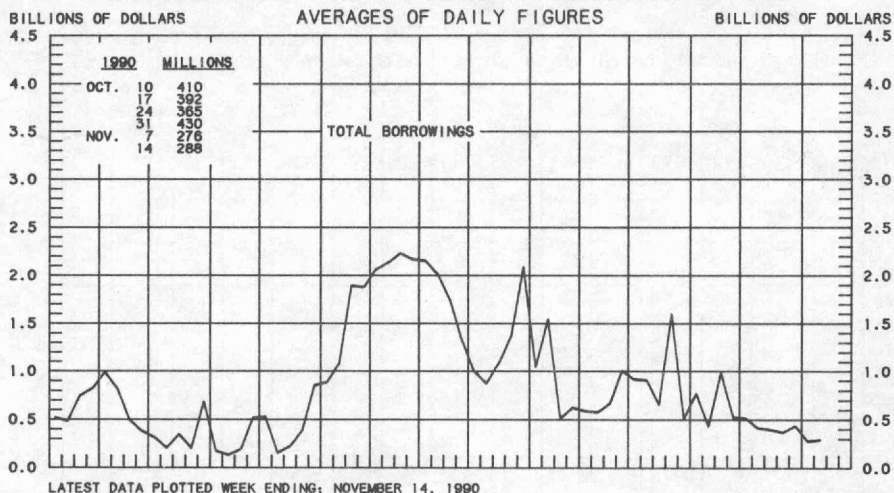

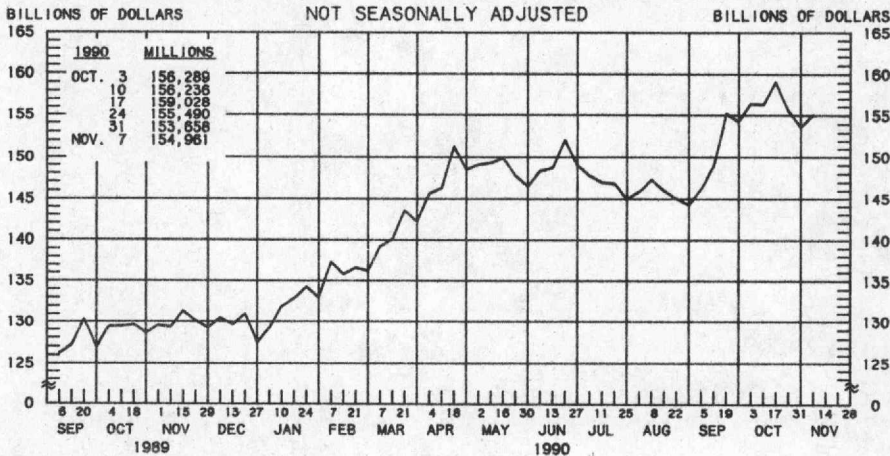

BORROWINGS FROM FEDERAL RESERVE BANKS



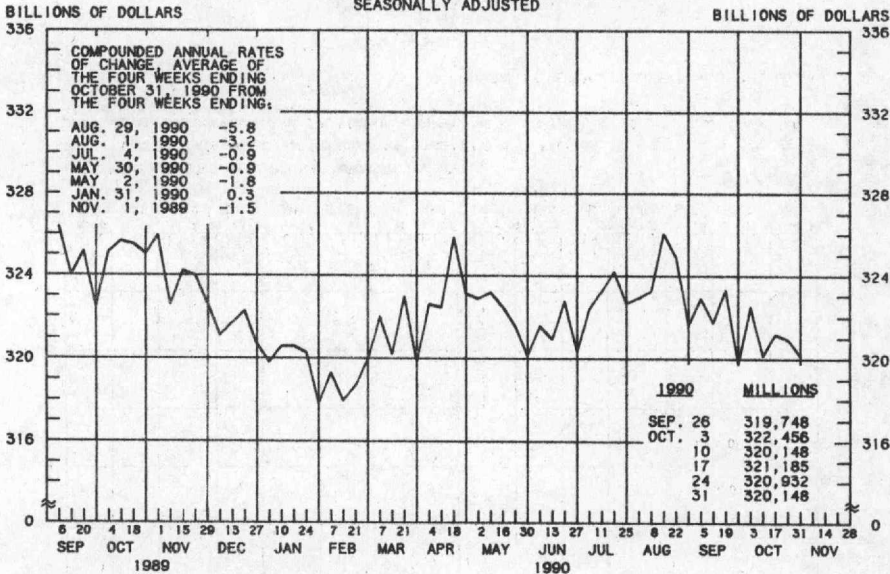

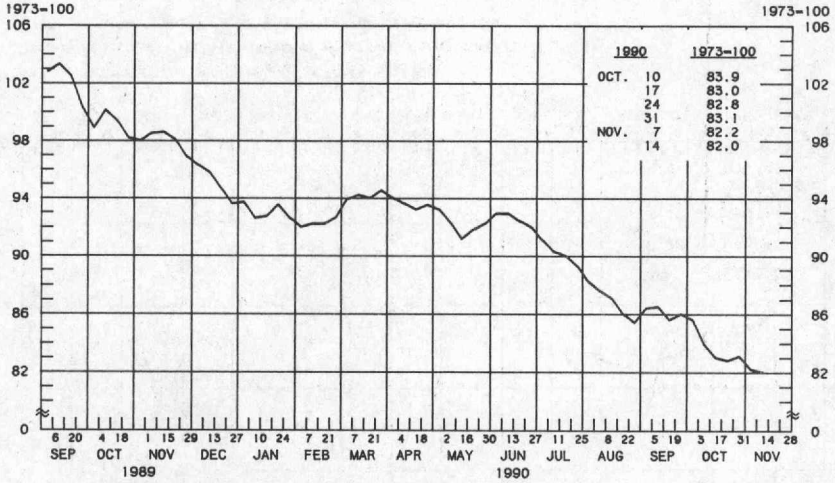
