THE WEEK'S HIGHLIGHTS:


- ✓ *The Federal Reserve Board approved a cut in the discount rate effective December 19 from 7 percent to 6.50 percent. This is the first change in the rate since February 1989.*
- ✓ *Industrial production fell at a 19 percent annual rate in November, following a 10.3 percent rate of decline in October. The capacity utilization rate dropped 1.5 percentage points in November to 80.9 percent, 2.9 percentage points below its July peak.*
- ✓ *The seasonally adjusted consumer price index rose at a 3.7 percent annual rate in November, after rising at an 8.9 percent rate during the previous three months.*
- ✓ *The producer price index rose at a 6.1 percent annual rate in November, following a 16.2 percent rate of increase during the previous three months.*













AVERAGES OF DAILY RATES












BORROWINGS FROM FEDERAL RESERVE BANKS






