
THE WEEK'S HIGHLIGHTS:

- ✓ *The prime rate fell from 10 percent to 9.50 percent, effective January 2, its first change since January 8, 1990.*
- ✓ *The interest rate on long-term securities averaged 8.21 percent for the week ending January 4. Since the week ending October 12, the rate has fallen 86 basis points.*
- ✓ *The civilian unemployment rate rose to 6.1 percent in December from 5.9 percent in November and compares with 5.3 percent in June. Total civilian employment has fallen at a 1.1 percent annual rate since June.*
- ✓ *Nonfarm payroll employment fell by 76,000 jobs in December, following a revised 259,000 decline in November. Such employment has declined for six consecutive months.*
- ✓ *The index of leading indicators decreased 1.2 percent in November, the fifth consecutive monthly decline.*



THE MAJOR SOURCE OF THE ADJUSTED MONETARY BASE IS FEDERAL RESERVE CREDIT. DATA ARE COMPUTED BY THIS BANK. A DETAILED DESCRIPTION OF THE ADJUSTED MONETARY BASE IS AVAILABLE FROM THIS BANK.







SEASONALLY ADJUSTED











BORROWINGS FROM FEDERAL RESERVE BANKS

BILLIONS OF DOLLARS AVERAGES OF DAILY FIGURES BILLIONS OF DOLLARS






